Haines Stampede Rodeo Court Tryout Procedures

The Rodeo Association has the right to amend any or all of the following procedures at any time.

Purpose:

To standardize procedures governing the selection of the Court Member to represent and to reign in hopes that by such standardization, fairness and impartiality will be guaranteed for each candidate, the following rules are adapted:

- 1. Any young woman enrolled and attending High School, will become the age of 15 by the time of tryouts, and who is not, or has not been married, and does not have a child, pregnant or becomes pregnant during their selected year, shall be eligible upon application.
- 2. To announce her candidacy each young woman should submit her name to Annalea Kauth, Court Advisor, prior to tryouts.
- 3. Court tryouts shall be held in the late summer each year and shall be for the purpose of selecting the young woman/women who shall constitute the Haines Stampede Rodeo Court. The Haines Stampede Rodeo Board, Court Committee and/or Court Advisor reserve the right to determine the number of court members for that year.
- 4. No stud horses may be used by a candidate or Haines Stampede Rodeo Court Member.

In order to guarantee a fair and impartial opportunity for each of the candidates, the young woman shall be judged:

A. Upon their riding ability in performing the riding pattern, which shall be given at the time of tryouts, plus a run-in. Each candidate shall be awarded from 1 – 100 points by the judges.

CONTESTANTS ARE EXPECTED TO USE THE SAME HORSE AT TRYOUTS AS THEY ARE TO BE USING DURING THE YEAR SERVING ON COURT.

- B. Upon her speaking ability, knowledge of current events and knowledge of the industry through questions asked by the judges. Each candidate shall be awarded from 1 100 points by the judges.
- C. Upon the basis of her personal appearance and personality. Each candidate shall be awarded points by the judges to be included in their riding and speaking scores.
- D. Based upon the total points awarded, the Rodeo Court Committee and the Haines Stampede Rodeo Association Board's review of the applications (with names redacted), the candidate or candidates with the highest points shall be asked to be on the Haines Stampede Rodeo Court.

There will be 3 judges chosen for the riding, appearance, speaking, and questions portion of the tryouts.

Each candidate <u>may be</u> required to attend riding lessons at the member's expense and Haines Stampede Rodeo Association Board approved teacher until approved by the Court Advisor and Committee.

Agenda:

Tryouts start at 1:00 pm, Saturday, September 28, 2019; family and friends are welcome to attend.

- 1. Group orientation with all contestants and their parents. After introductions, contestants will draw numbers to determine the order for tryouts.
- 2. Horsemanship: Tack will be inspected then you will mount and ride the pattern given at group orientation, and then any impromptu maneuvers on your own horse the judges ask for. Judges may ask questions at this time as well. This will be done in front of the judges and any audience members there to watch. Other contestants will wait out of ear and eye shot.
 - i. We're looking for a confident rider and a well-mannered horse with a professional, polished look.
- 3. Run-in: All contestants will perform a run-in following the current Haines Stampede Rodeo Princess.
- 4. A 3-4 minute speech about yourself, your horse, and why you want to be on the Haines Stampede Rodeo Court. This is to introduce yourself and tell us why you would be the best fit for the Haines Stampede Rodeo Court. This speech will be done in front of the judges, other contestants and any audience members there to watch.
- 5. Personal interviews: You will be asked about current events and the industry. This will be done in front of the judges and any audience members there to watch. Other contestants will wait out of ear and eye shot.
