OUR HORSEY HISTORY

Have you noticed the fun addition to the kiosk at the post office? A horse-themed weathervane.

145 years ago, this area was known as Colton Ranch. General David D. Colton purchased the ranchland from his business partners – the railroad industry titans known as "The Big 4" (Leland Stanford, Charles Crocker, Collis Huntington and Mark Hopkins).

The Coltons (and their heirs) transformed the working ranch into a grand gentleman's country estate that included world class livestock, with prized thoroughbred horses for championship breeding and racing. They expanded the estate house (the grand home named Oakwood today), built a Clubhouse atop the hill with guest rooms, a billiard hall, and two 10-pin bowling alleys (the Carriage Lounge at the heart of Diablo Country Clubhouse today) and added a racetrack framed by eucalyptus trees (you can see eighteen of those trees still standing along the 16th hole today).

CONTRA COSTA COUNTY HISTORIC LANDMARKS ADVISORY COMMITTEE

On May 3, the Board of Supervisors appointed Tony Geisler to serve on the 5 member Board of the Contra Costa County Historic Landmarks Advisory Committee. Tony, along with his wife, Dee, is presently Co-Chair of the Diablo Historic Preservation Committee (DHPC). As stated on the County's Web Site "The purpose of the Contra Costa County Historic Preservation Committee (HLAC) is to advise the Board of Supervisors on matters relating to the identification and preservation of historical resources within the County, including identifying eligible sites and places to be listed in the County's Historic Resources Inventory (HRI)." Diablo was unanimously declared a Historic District within Contra Costa County by the Board of Supervisors in 2002, thus giving us special consideration. As an unincorporated community within Contra Costa County all land use and building matters fall under the jurisdiction of the County.

The County Staff Liaison with the HLAC is Dominique Vogelpohl who also serves as the Planner responsible for all matters relating to Diablo. Dominique is a long-time friend of Diablo and a dedicated supporter of our Historic District. Her contact information is contained on the HLAC Web Site.

Diablo was on the Agenda of the HLAC Board meeting on Thursday, June 2nd with a focus on addressing potential land use changes. Look for updates on that meeting in the next edition of this newsletter.

THE DPOA: NOT YOUR TYPICAL HOMEOWNERS' ASSOCIATION......

Typical homeowners' associations require you to pay high fees for the upkeep of common areas, shared structures, and exteriors. HOA membership also binds you to covenants, conditions and restrictions (CC&R). The DPOA (Diablo Property Owners' Association) has little in common with the HOA's we typically have come to know... and hate.

Formed in 1929, the DPOA is one of the oldest property owners' organizations in California. While the desire to keep common areas - like the entrances to Diablo - beautiful is similar in concept to traditional HOA's, that's where similarity stops. The reason for DPOA's being is fundamentally to facilitate and enhance our unique community. That's it! Community volunteers do this work through social events, communication, beautification, and historic preservation education. The DPOA possesses no CC&Rs, no legal power. Though we often act as a sounding board and work with other organizations to facilitate community affairs such as the Diablo Country Club, Diablo Community Services District (DCSD) and Contra Costa County.

HOA's around the US are quite expensive, often exceeding utility payments. According to the US Census Bureau, the median HOA in the US is \$290 a month. The DPOA asks all residents to make just one ANNUAL contribution of \$150.00. Contributing to the DPOA helps ensure a beautiful welcome for your guests, maintain tight knit community connection, and preserves the stories of our past. Only 70% of Diablo households have contributed this year. If you have not yet contributed, it is not too late. Please visit www.diablopoa.org to make your contribution today.

The Diablo Community Services District or DCSD is a California Special District and is governed by residents elected to a 5-member Board of Directors. The purpose of the DCSD is to provide security services to residents, maintain and improve roads, culverts under roads, and bridges within Diablo, and maintain Kay's Trail.

Get Ready! Wildfire Season is Upon Us!

All Diablo residents are reminded that we are once again in wildfire season. This is a call for all residents to look around your properties, make sure all weed abatement is done with a buffer around your homes, trees are trimmed away from roofs, emergency kits and evacuation plans are made with your families and with your neighbors.

Since our roads are narrow, keeping them clear of vegetation is essential for evacuation as well as day-to-day safety. At this point in the year, all residents should have completed the removal of any vegetation from their property that was encroaching on our roads. Duff, which is debris on the edge of the road, is a double safety hazard in that it gives the appearance that a road is narrower than it actually is, forcings cars to hug the center of the road, and it is dead material that tends to be highly combustible. Check to see If you have duff on your road's edge; if so, please remove it with a broom, rake or leaf blower.

Even though winter brought us two major storms, the seasonal rains ended far too soon and we find ourselves in another severe drought, necessitating that everyone conserve as much water as possible. You can do the most good by limiting your irrigation times to keep your landscaping alive but without waste and runoff. Watering during cooler hours also aids conservation by minimizing evaporation.

Let's all work together for a safe summer here in beautiful Diablo.



Evacuation Preparedness

It's easy to put this into "tomorrow's" to do list. Don't! Formally schedule some time to research the details of what to have ready should an evacuation be ordered. There are numerous websites that offer plans for you to follow to make the process quick and efficient. For example, a Go Bag is considered critical. Don't delay. Do some homework and be ready to leave immediately should it be required.

UPPER ALAMEDA ROAD REPAVING

Enjoying the Smooth Ride?

If you have driven up Alameda Diablo past Caballo Ranchero Dr to Diablo Lakes and Via Diablo lately, you may have noticed the new black asphalt road with bright white lines highlighting the speed bumps. This smooth ride was made possible by our Diablo Community Services District (DCSD), in cooperation with Dryco Construction and ENGEO Engineering, putting your tax dollars to work. This repaving project was one of the district's most challenging projects and we appreciate the patience and cooperation during those five long days of construction. Hopefully the new road surface and smooth ride made the moments of road work fatigue worthwhile.

This project was the final segment of a nine-year program to grind down and rebuild every road maintained by the DCSD. We are excited to have completed the program. Barring any surprises, we will not perform this level of road work for another 15 years. To preserve the integrity of the new road surfaces and prevent water from penetrating the foundation, the roads will only be resurfaced every 5-7 years, but the disruption to residents will be significantly less.
