Emerging Cadillac-Pontiac Lithium District in Québec - Chronology

A new lithium district is emerging in the Abitibi-Témiscamingue region of Western Québec. The region lies within the Neoarchean age Pontiac Subprovince of the Superior Province of the Canadian Shield. The Pontiac lies south of the Abitibi Greenstone Belt and is bounded to the north by the Larder Lake-Cadillac Deformation Zone ("LLCDZ") and by the Grenville Front ("GF") to the south. It is underlain primarily by Pontiac metasediments in the northern part, and various large batholiths and smaller plutons in the southern part. Lithium mineralization within spodumene-bearing pegmatites dykes has been identified at several sites in the Pontiac. These dykes cut both the metasediments and intrusive rocks. The lithium mineralization is very similar to known lithium deposits in the Preissac-Lacorne-Lamotte area located approximately 20km north of the LLCDZ. There has traditionally been very little exploration work done in the Pontiac due to the rich gold and volcanogenic-type base metal deposits found in the prolific Abitibi Greenstone Belt.

Increasing worldwide demand for lithium from the nascent battery sector has focused exploration on areas of historical pegmatite-type lithium deposits. Since 2016 Sayona Mining Ltd. has accelerated exploration and development of the Authier lithium deposit and the recently acquired, past-producing North American lithium deposit in the Preissac-Lacorne-Lamotte area. This advanced activity has resulted in a keen interest the lithium potential of the adjacent, relatively unexplored Pontiac area.


Excellent access to the Pontiac area is provided by a network of logging roads from the town of Cadillac located on provincial highway Route 117. The name "Cadillac-Pontiac" is thus given to this prospective new lithium district. The following is a reverse chronology of lithium exploration in the Cadillac-Pontiac lithium district starting in 2018 with Sayona Mining and continuing with the recent entry of Brunswick Exploration Inc., Vision Lithium Inc. and Winsome Resources Ltd. Bathurst.
