Financial Agreement 2025-2026 (Standard)

Four (4) Tuition Payment Plans are available. The selection of one payment is required.

_____ **Annual Payment Plan.** Full payment of yearly tuition includes a 5% discount and is payable on or before August 30, 2025.

_____ **Semi-Annual Payment Plan.** Payment of tuition is paid **twice** a year. Half of the yearly tuition is payable on or before August 30, 2025. The second half is due on or before January 31, 2026.

_____ **Ten Payment Plan.** Tuition is divided into **10** equal payments to be paid over the period of August 2025 to May 2026. Tuition payments are due by the last day of each stated month.

_____ **Twelve Payment Plan.** Tuition is divided into **12** equal payments to be paid over the period of July 2025 to June 2026. Tuition payments are due by the last day of each stated month.

I/we further accept that:

- All registration fees are to be paid prior to enrollment and are non-refundable;
- I will promptly pay all tuition and fees as outlined on the Financial Agreement Form;
- Upon my child(ren)'s acceptance I am financially obligated to Peace Lutheran School for the payment of tuition. If I withdraw my child(ren) from school, I obligate myself for the full payment of tuition through the end of the month my child(ren) is enrolled at Peace.

I realize that if my account is in arrears at the end of the school year, then I will not be eligible to re-enroll my child(ren) until all fees are paid in full. If the following school year begins and I am still in arrears; I have 30 days to set up a payment plan or risk being reported to a collections agency. Transcript and records will be held until an agreement is reached.
