# Governor has no veto power over Bills, must send back to assembly - Supreme Court

New Delhi : Bills need to be sent back to Legislature 'as soon as possible'; in case the State Assembly reiterates the Bill 'with or without amendments', the Governor has no choice or discretion, and has to give his assent to it, rules Apex Court.

The Supreme Court has laid down the law that a Governor, in case he withholds assent, should send back a Bill forwarded to him by a State Legislature "as soon as possible" with a message to reconsider the proposed law. In case, the State Assembly reiterates the Bill "with or without amendments", the Governor has no choice or discretion, and has to give his assent to it. "The substantive part of

Article 200 empowers the Governor to withhold assent to the Bill. In such an event, the Governor must mandatorily follow the course of action which is indicated in the first proviso of communicating to the State Legislature 'as soon as possible' a message warranting the reconsideration of the Bill... The ultimate decision on whether or not to accept the advice of the Governor as contained in the message belongs to the legislature alone. That the message of the Governor does not bind the legislature is evident from the use of the expression 'if the Bill is passed again ...with or without amendments',' a three-judge Bench headed by Chief Justice of India D.Y. Chandrachud has held.

"The Governor as the unelected Head of State would be in a position to virtually veto the functioning of the legislative domain by a duly elected legislature by simply declaring that assent is withheld without any further recourse. Such a course of action would be contrary to fundamental principles of a constitutional democracy based on a Parliamentary pattern of governance. The Governor is under Article 168 a part of the legislature and is bound by the constitutional regime," the court held. The court held that the Bill should be sent back to the Legislature "as soon as possible" with the mandatory message. It said the expression "as soon as possible" conveyed a "constitutional impera-



tive of expedition". Also read |States in Court against their Governors "Failure to take a call and keeping a Bill duly passed for indeterminate periods is a course of action inconsistent with that expression. Constitutional language is not surplusage," Chief Justice Chandrachud wrote in the 27-page judgment.

Mean while Punjab chief minister Bhagwant

Mann on Friday has written to governor Banwarilal Purohit requesting him to give his assent to the five pending bills passed by the assembly "forthwith" with the latter promptly replying that these were under his "active consideration" and an appropriate decision according to law, and in keeping with the recent Supreme Court judgment, would be taken "expeditiously."

Bhagwant Mann sought to remind the governor about the pending, bills in wake of the Supreme Court holding two special sessions of the assembly valid. Purohit appreciated that the AAP government had finally prorogued the budget session after extending it twice in June and October. Four of the five bills were passed during the two day special session in June. Letter read "It is submit-

ted that five bills were passed by the Punjab Vidhan Sabha which are pending at your end for accord of assent in your earlier communication, you had stated that the validity of the special sitting of the Vidhan Sabha, convened by the speaker in June was in doubt. This was an impediment for clearing the bills. The Issue regarding the sitting on June 19-20 and October 20 has been held to be valid by the Supreme Court in its order pronounced in court on November 10." CM added, "I would request that in keeping with the constitutional obligation and elucidated in the orders (November 10) of the Supreme Court these bills be cleared forth with."

Later in the day, Purohit

replied, "I am happy to note that the practice of adjourning the assembly sine die and recalling it without proroguing came to an end finally . Through it came through the indulgence by the Supreme Court. I am glad that the healthy democratic practices are put on track . In fact, I have been repeatedly advising you follow the same procedure which was agreed upon by you in the Supreme Court." On the status of the bills, the governor added. "The five bills mentioned in your letter are under my active consideration and appropriate decision according to law will be taken expeditiously, in keeping with the Judgment of the Supreme Court.

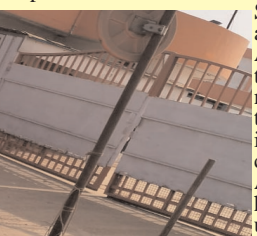
## AKUMS Life Sciences violates water pollution act 1981

## Earn "Green Credits" draft norms engineered by Government

New Delhi: Their will generate green credits (GCs) through specified calculations based on a physical verification process. For example 100 GCs will be distributed to eligible applicants for 10 years for 100 tress. Plantation of minimum 100 tress will be required for qualifying under tress plantation based green credit," said the draft on tree plantation projects, nothing that minimum 100 tress per hectare and maximum 1,000 tress per hectare will be required to be planted. The ministry in its drafts, seeking suggestions or objections from stakeholders, lists state/ district - wise appropriate water conservation / harvesting structure like earthen ponds and poly tanks, and tress/ horticulture species that can be picked up for actions by individuals / cooperatives or urban/rural local bodies. Or promoting environment friend-



ly practices across the country, the environment ministry has come out with two separate draft methodologies for generating such credits through water harvesting and treeplantation projects in different states/ UT, and buying / selling it through a centrally managed dedicated platform. Similarly for generating green credits (GCs) for water harvesting structures based on site location, the minimum size/storage capacity of water conservation/harvesting structures will be 100 cubic meter or 1 lakh litre and maximum size of 10,000 cubic meter. Individuals/entities can get 75 GCs

per 100 cubic meter after completion of specified number of years. The GCP is an innovative marked based mechanism designed to incentivize voluntary environment actions. Its notification, ahead of the upcoming UN climate conference (COP28), assumes significances as it reflects India's approach of addressing environmental al concerns under its Mission LLIFE , which was launched last year as a grassroot mass movement for protection and conservation of environment and other environmental and climate gains.

## UGC grants to be revised

Chandigarh: "PU is special, particularly commendable in the research sector. That's why we have implemented the 7th pay Commission and other UGC- recognized policies. We stand with PU in this, and discussions with the ministry of education are under way. We will do the necessary within our capacity," he said. The faculty's pay scales undergo continuous revision, due to the advent of the 6th and 7th pay commissions the financial liabilities escalate annually. The budgetary estimates a consistent increase from Rs 36,695.68 lakh in 2021-22 a projected 49,585.16 lakh for 2024. EDITORIAL –

Hunger for money drives to insane acts

The US government, no matter which party rules, seems helpless to control them. US capitalism is not unregulated: its pharmaceutical, health and financial sectors are heavily regulated. However, US firms have great power to influence regulations. Companies can spend large amounts of money, legally, to lobby for their interests, and fund think tanks and universities to produce ideas that support their ideology. Capitalism corrupts democracy. Drugs and guns produced and sold by US companies are killing tens of thousands of American citizens. Politics and the Congress are controlled by money power — no-holds barred capitalism. Citizens want to be listened to when policies that will affect their lives and livelihoods are made. This is what farmers and their families camped for on the outskirts of Delhi during the Covid-19 pandemic. It was not too much to ask for. It was their right. Science and technology are powerful instruments which can be used to improve the performance of complex systems — the human body, food systems, environmental systems, financial systems and information systems. Artificial intelligence and synthetic biology are exciting new frontiers of science and technology. Marvellous potential gains to society from their use in health, education, energy, financial and security systems are being described to encourage their faster development and deployment. Great dangers lurk in leaving such powerful instruments in the control of companies in any sector whose mission is to improve profits for their investors — dangers greater than those already manifest from ineffective regulation of for-profit companies using pre-AI

technologies in the health, agriculture, financial, security, media and entertainment sectors. The private sector is not a panacea for various problems. A government has to provide all citizens with healthcare and education regardless of their ability to pay. It must regulate the profit-seeking urges of private businesses. The CEO of the largest media business in the US and the world at that time explained why the media must focus on the demands of its readers and viewers. He said the media as good business must give its customers what they wanted. If they wanted more entertainment, the media must give them good entertainment. If the media did not give its customers what they wanted, it would go out of business. A participant in the Aspen seminar said society could not allow business leaders to get away with the justification that they were giving people what they wanted. “Many people want hard drugs,” she said. “There is a lot of money to be made by supplying hard drugs to these customers. Could a business that supplied hard drugs be defended on the principle that it was giving people what they wanted? Just as sellers of drugs are declared criminals, all business leaders must be held responsible,” she insisted. Karl Marx said religion was the opiate of the masses. Ideologies can be opiates too. The Economist and its ilk have often said that communism was an opiate of the masses, replacing religion. The American version of capitalism is an opiate too. It is heretical in a society ruled by religion to question God; it is heretical to doubt the morality of the ‘invisible

hand’ in free-market capitalism. In the ideological struggle between the US and Soviet Union during the Cold War, then US President Ronald Reagan declared “government is the problem, not the solution” to counter communism and socialism in Europe, where governments took responsibility for public welfare. In the American version of ‘no-holds-barred’ capitalism, the business of business is business. Government regulation of business curbs its animal spirits and innovative ways of making profits. Thus, the ease of doing business, unregulated by the government, replaced the ease of living of citizens as the measure of good government policy. Indian economic policies have not been spared by this global ideological drug. In 2021, the Indian Government allowed the private sector to engage in the production of poppy for opium/heroin, which had been a government monopoly. Six protesting farmers were killed in police firing in Madhya Pradesh’s Mandsaur in 2017. Drugs have ravaged one young generation after another in Punjab. A political war continues about who is responsible. The Economist has an interesting view, albeit in the context of the growing drug problem in the US. Fentanyl is a new synthetic and industrial opioid. It is significantly more potent than heroin, whose raw material comes from poppy grown by farmers in Afghanistan and Southeast Asia, whose fields have been targeted by the US-led ‘war on drugs’ for eradication. “Drugs of fentanyl’s ilk currently kill around 70,000 Americans a year, more than (those who) died in the wars in Vietnam, Iraq and Afghanistan combined.

Medical negligence reported from Pvt hospital doctors

Max Hospital officials, in a statement, said the matter is being investigated. “Clinically, we understand that the patient is doing fine,” the statement noted.

Free 2-wheeler parking to begin from Dec 1

**CHANDIGARH** : “This is a Diwali gift to the residents of the city as well as visitors to market places. We had intended to provide a relief to two-wheeler riders for a long time. Though the tendering process for the same will take time, today being Diwali’s eve, I have decided to announce free parking facility from December 1” said Gupta. Mayor Anup Gupta announced free parking for two-wheelers in all paid-parking sites that fall within the jurisdiction of the civic body from December 1. The General House of the MC had approved the agenda regarding free parking of two-wheelers in all parking sites in July. According to the agenda, all two-wheelers will be exempt from the parking fee. The Mayor said there were 89 parking sites in Chandigarh that were managed by the Municipal Corporation



and all had an equal parking space for two-wheelers as well as four-wheelers. At present, the corporation charges Rs 7 for two-wheeler parking. Parking for electric vehicles is already free. Car parking charges is Rs 14. However, in the last House meeting, it was approved that car parking charges would be Rs 15 for four hours. For parking up to 8 hours, Rs 20 will be charged. After that, Rs 10 will be charged per hour. However, there will be double the charges for cars registered outside the tricity. All rates will be applicable once FASTag-based smart parking system is introduced following tendering process.

Poll preparation for local bodies underway for Jan contest

**CHANDIGARH** : “All the groundwork is complete for the local bodies poll. The model code of conduct will come into force by December 15” revealed highly-placed sources. Elections to at least five Municipal Corporations and 41 municipal councils will be held in the first fortnight of January 2024. The Secretary, Local Government, had issued a notification that elections to five Municipal Corporations, including Amritsar, Patiala, Phagwara, Jalandhar and Ludhiana will be held in the “first fortnight of November”. The term of Amritsar and Patiala MCs had ended on January 22, Jalandhar on January 24 and Ludhiana on March 26. The tenure of Phagwara MC had ended in March 2020. The notification came after the Punjab and Haryana High Court in March had asked the State Election Commission to conduct the poll. The Election Commission had committed that the final publication of electoral rolls would be completed by November 10. Sources said the work related to delimitation of wards in the local bodies was complete. They said



preparations were underway to conduct the panchayat poll in the third week of January. Even block samiti and zila parishad elections are also expected to be conducted on the same day. The CM is learnt to have expressed his intention that all elections should be held within a limited time frame. Earlier, the government had decided that panchayat elections would be conducted in two phases. Even delimitation exercise in panchayats was underway. Moreover, January being less hectic for farmers, it’s the most ideal month to conduct the poll. The state has around 13,240 panchayats, 150 block samitis and 22 zila parishads. These elections would be a litmus test for the Aam Aadmi Party government’s which came to power with a massive mandate in March 2022.

Bhagwant Mann to inaugurate Military Lit Festival on Dec 2

**CHANDIGARH** : With the theme for this year ‘World in turmoil and lessons learnt from history’, besides the event will mark the 75th anniversary of the operations in Jammu and Kashmir in 1947-48 during the first India-Pakistan war, officials associated with the festival said. The seventh edition of the Military Literature Festival will be inaugurated by the Punjab Chief Minister Bhagwant Singh Mann in Chandigarh on December 2 while the valedictory session would be presided over by Governor Banwarilal Purohit on December 3. The sessions scheduled for the first day include ‘Military, strategic and diplomatic lessons to be



learnt by India from the conflict in Ukraine’, ‘The strategy India should follow to deal with a declining Pakistan and a Taliban bent upon expansion’ and ‘How do India and China face off today in terms of weapons technology and self-reliance’. The second day will see discussions on ‘The Israel-Hamas war and its diplomatic and military lessons for India’. Historical topics featuring at the festival include ‘Opening the gateway to Ladakh—The

victory at Zoji La in the autumn of 1948’, ‘The Lahore Durbar and its gift of the North West Frontier, Kashmir, Baltistan and Ladakh to India’ and ‘The legacy of Chinese Emperor Ying Zheng and his methodology of ruling’. Serving defence officers would also participate in some of the sessions particularly those associated with Pakistan and China. Clarion Call, featuring real-life war movies and audio-video presentations have been revived this year. In addition, a session on martial poetry of Punjab, an exhibition of military paintings, face to face with Param Vir Chakra awardees, military stamps display and weapons display are also on the agenda.

Rs 30,000 crore to be recovered from one-time settlement scheme

User charges to streamline garbage waste collection

**PANCHKULA** : The monthly user fee for residential areas would be Rs 50 for units up to 50 sq m area, Rs 100 for sites above 50 sq m and up to 200 sq m, Rs 200 for units of sizes from above 200 sq m and up to 500 sq m, Rs 250 for units of sizes above 500 sq m and up to 1,000 sq m and Rs 350 for units of sizes above 1,000 sq m. The local Municipal Corporation has started collecting user solid waste management (SWM) charges from all residential, commercial and institutional units under its ambit. The charges were discussed and passed by the MC General House in September, and have been implemented from April 2023 after getting approval from the Local Government department. While MC officials claimed that collection of the charges will help streamline garbage waste collection, segregation and management, the fee has not gone down well with residents. The MC will collect charges from street vendors, commercial establishment shops and eateries, guest houses and dharamshalas,



hostels, restaurants, hotels, commercial offices and other units as well. Officials said there are over 1 lakh residential, commercial and other units under the MC ambit. “We have implemented the user charges for all types of units and are providing collection, segregation and management services throughout the city,” said chief sanitary inspector Avinash Singla. He added, “With this, we aim to streamline the city’s solid waste collection and stop the formation of small dump sites in and around residential areas. We are already collecting the waste from doorstep and transporting it to a single collection unit in the city. From there, it is being transported to Ambala for processing.” Officials said the step would help do away with small

garbage dumps created by irregular waste collectors outside residential areas. MC Commissioner Sachin Gupta said the corporation had issued a schedule of all sanitation workers. “The identity of workers has also been mentioned on the MC website. Residents can complain to the MC on 9696120120 in case garbage vehicle does not turn up in their area for door-to-door collection.” Officials said the SWM fee would be collected along with property tax charges. “The charges have been implemented from the ongoing fiscal year. Some people have received bills for the previous fiscal year as well. All charges pertaining to the previous year will be revoked”, the Commissioner said. SK Nayar, president, Citizen Welfare Association, Panchkula, said two years ago, the corporation had stated that it would not charge garbage collection fee. “Residents are quite surprised to note that the MC is now sending the charges at random. We are against such random collection of charges.”

Voters of Kalka, Panchkula to file objections till December 9 : ECI

**PANCHKULA** : Voters can get the entries recorded in the voters’ list corrected and name transferred from one polling station to another under the Assembly constituency during this time, for which eligible persons must enter the new name in the voter list, said Deputy Commissioner and District Election Officer Sushil Sarwan. As per the instructions of the Election Commission of India (ECI), claims and objections regarding the voters’ list will be taken up by December 9. Persons who will be aged 18 or more on January 1, 2024, can get their names registered in the electoral rolls ahead the upcoming elections. Form number 7 will have to be filled to remove the name of an ineligible voter while form number 8 will have to be submitted for corrections, changing location (outside the Assembly constituency) and remove duplicate cards. Sarwan said, photocopies



of necessary documents such as proof of age, residence, ration card, etc would have to be attached with each claim. All these forms would be available free of cost at polling stations and respective offices. He said as per the instructions of the ECI, the booth-level officers would be present at all polling stations to address claims and objections in regards the revision of the electoral rolls during the special campaign on November 25 and 26. He urged all the voters of both Assembly constituencies in the district — Kalka and Panchkula — to check their names in the voters’ list on the official website of the Chief Electoral

**Officer** : www.ceoharyana.nic.in. Voters can also check their details at the district election office, Panchkula, during any working day. “If the name of a voter has been removed from the list for any reason and the voter is present at his place, he/she can get his name included in the electoral rolls by filling form number 6 by December 9,” said the district election officer. He added that voters can also fill these forms online through the National Voters’ Service Portal (NVSP) app or the Voter Helpline App (VHA) issued by the Election Commission of India.

MP MLA courts summons Rahul Gandhi in defamation case over remarks on Amit Shah

Sultanpur (UP) : The defamation case was filed by BJP leader Vijay Mishra in 2018 against the Congress leader for allegedly making "objectionable" comments against Shah at a press conference in Bengaluru. An MP-MLA court has summoned Congress leader Rahul Gandhi in a 2018 defamation case over alleged "objectionable" comments he made against Union minister Amit Shah, the petitioner's counsel said. During a hearing on the



case on Monday, MP/MLA court judge Yogesh Yadav summoned Gandhi on December 16, advocate Santosh Pandey said. The complainant had referred to Gandhi's comment that the BJP which claims to believe in honest and clean politics has a party president who is an "accused" in a murder

case. Shah was the BJP president when Gandhi made the remark. About four years before Gandhi's remark, a special CBI court in Mumbai had discharged Shah in a 2005 fake encounter case when Shah was a minister of state for home in Gujarat.

40K senior citizens eulogised for going old-age pension

KARNAL/CHD : Over 40,000 eligible senior citizens, above the age of 60 years, have voluntarily refused the pension, resulting in an annual savings of approximately Rs 100 crore. Chief Minister Manohar Lal Khattar expressed gratitude to (for the opportunity to interact with) senior citizens, who were eligible to receive pension under the Old Age Samman Allowance Scheme but had chosen to forgo it. Mr Khattar announced that the state government had decided to increase the old age pension to Rs 3,000 from January 1, 2024. Senior citizens with an annual income below Rs 3 lakh currently receive Rs 2,750 per month. He said this during an interaction with senior citizens receiving old age allowance through audio conferencing as part of the 'CM Ki Vishesh Charcha' programme. The CM said the surplus funds would be directed towards service homes under the Senior Citizen Seva Ashram scheme in 22 districts.



Khattar also spoke about the 'Prahari' scheme that has been introduced to ensure the well-being of senior citizens aged above 80 years. Data based on family identity cards issued in the state revealed that there are around 3,30,000 such individuals, of whom 3,600 live alone. Under this scheme, retired government employees will personally visit these senior citizens to assess their well-being. If any elderly person requires medical assistance, property protection or any other support, the department concerned will be notified to provide prompt assistance. Retired government employees can call on 112 to join the scheme, said the CM.

Gurugram holistically aims zero emission by 2050

GURUGRAM : As Gurugram features among the top polluted cities in the country, the Gurugram Metropolitan Development Authority (GMDA) has drawn a holistic plan to reduce emissions in the city. The authority has drafted a 'net zero 2050' document, contouring the goals for urban policy-making to make Gurugram a zero emission city. Net-zero refers to the point at which a specific area or city is able to remove from the atmosphere all green



house gases (GHGs) it is emitting. Effectively, it ensures that no additional carbon or other GHGs are being added into the atmosphere. The document elaborates on the way forward to implement sustainable development strategies like construction of green

buildings, setting up of centralised cooling plants in housing societies, adoption of cleaner technologies and increasing the share of electric vehicles over the next 25 years. The plan deals in four major arenas — energy, waste, transport and greenery.

Amended Forest Act from Dec 1 deplored by environmentalists

CHANDIGARH : Environmentalists have expressed concern over potential forest exploitation by private companies as the amendments consolidate more power in the hands of the Central government. From December 1, amendments to the Forest (Conservation and Augmentation) Act, 1980, encompass permission for infrastructure development within 100 km of the International Border (IB). With this, construction along the roads, railway tracks and eco-tourism projects like



safaris and zoos in the forest areas can be developed. Punjab shares 550-km IB with Pakistan, spread across Pathankot, Gurdaspur, Amritsar, Tarn Taran, Ferozepur and Fazilka districts. Senior Forest Department functionary said the amendments might escalate the pace of forest degradation and ecology.

The official said, "The exemptions are not only for defence projects, but for public utility services as specified by the Centre." "Safaris and eco-parks in the forest areas will put a huge pressure on the ecosystem," said environmentalists, adding that eco-tourism projects require massive infrastructure development.

Bajwa deprecates 2 days session period too lesser

CHANDIGARH : After the Cabinet meeting, Finance Minister Harpal Cheema during press meet said the Cabinet gave its nod to create and fill 9 posts of technical cadre through direct recruitment in Maharaja Bhupinder Singh Sports University, Patiala. The Cabinet, led by the Chief Minister, Bhagwant Mann, approved the fifth session of the Vidhan Sabha to be held on November 28 and 29. This session has been approved after Governor Banwarilal Purohit had prorogued the Budget session last week. The winter session will start with obituary references on November 28 and the business for the two-day Assembly session will be decided by the business advisory committee shortly, said an official press release. The university was set up with an aim to upscaling the standard of sports through the focus on education, training and courses in the field of sports, adding that these posts would help in streamlining the work of the



university and facilitate students in getting their routine work done. Among other decisions, the Council of Ministers has also given its go-ahead to close the Punjab State Social Welfare Board (PSSWB) and merge its staff, including PSSWB Headquarters employees, pensioners and five ICDS blocks, into the Department of Social Security, Women and Child Development. The Cabinet also gave its consent to send a case of a life convict for the premature release, while rejecting four other cases. After the nod of the Cabinet under Article 163 of the Constitution, the special remission/premature release case will be submitted to the Governor for consideration.

Feb 29 enhanced date for voter enrolment period

AMRITSAR : A fresh notification was issued by the Gurdwara Election Commission with a revised schedule in this regard. The last date for receipt of claims and objections will be April 11, 2024. The final publication of the voters' list will be May 3, 2024. The voters' enrolment process for the Shiromani Gurdwara Parbandhak Committee (SGPC) general poll has been pushed to February 29, 2024. Earlier, the voters' registration was between October 21 and November 15. Many Sikh organisations, including the SGPC, had approached Justice SS Saron (retd), Commissioner, Gurdwara Election Commission, Sikh



apprising him about the problems being faced by members in registering their votes. In the 2011 elections, a total of 52.69 lakh voters were registered in Punjab, followed by 3.37 lakh in Haryana, 23,011 in Himachal and 11,932 in Chandigarh. As Haryana may be out of the picture this time as it has already constituted a separate ad-hoc Haryana Sikh Gurdwara

Management Committee, the voters from Himachal and Chandigarh would participate in the SGPC poll. With the introduction of common mobility card, the transport department of the UT administration aims to integrate automatic fare collection system having EMV enabled electronic ticketing machines through partner bank/financial institution. Further, the existing system integrator will upgrade the AFCS application to meet the requirement of NCMC open loop card and the partner bank/financial

institution will be responsible for instant issuance of mobility cards.

"Once the project is introduced, people will have to carry only one card and the same could be used everywhere. This move will encourage people to opt for the city bus service to travel. Since it will be used for multiple purposes, including shopping, people won't have to carry multiple cards with them. Once the project gets the nod, the issue of payment gateway, banks etc will be decided accordingly," sources said.
