## Cooperative societies members await operationalisation of notification, yet extend gratitudes to Bhagwant Mann

Chandigarh : The Gazette (Extra) notification of Punjab Govt , Cooperation department dated 21Nov 2025 facilitating registries afresh with the revenue department ,share holders of cooperative housing societies are awaiting compliance till the date.The process has not yet been

operationalised as the revenue department too has not received any government direction for the implementation of the registration deeds , said Lovedeep Singh, the incumbent tehsildar of Zirakpur block. The original share holders or the members to whom property was directly allot-

ted by the housing society, as per the Gazette notification, would be exempt from the payment of stamp duty though the prescribed registration fee shall be payable to the revenue department, reads the notification. Several share-holders conveyed their heartfelt obligations to the cooperation

department since they intended to have independent government document as and when they felt to sell the property to any other prospective house

builder. All transfers of membership, possession or ownership subsequent to the original allotment shall be subject to stamp duty and registra-

tion fee as per the rates prescribed by the department of revenue. All transfers of property allotted by a cooperative society shall be effected only through a duly executed conveyance deed between the transferor and the transferee. Where the existing holder of property intends

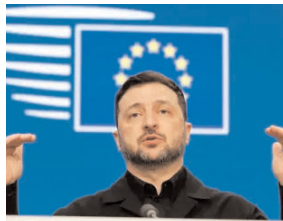
to transfer it to purchaser, he shall first execute and register the conveyance deed in his own name and only thereafter may the sale or transfer deed be executed in favour of the purchaser. No cooperative society shall here after execute or register an instrument of transfer directly in favour

of any purchaser or transferee and same in the case of the original allotment. A society however may recover an administrative fee, not exceeding Rs 10,000/( or such amount, as may be specified by the Registrar) solely for the record verification and confirmation of the membership.

### Russia strikes "Kyiv" Ukraine's capital during Trump-Zelenskyy meeting

Kyiv : Russia has carried out drone and missile strikes on Ukraine's capital Kyiv on the eve of a key meeting between the United States and Ukrainian leaders, killing at least one person and leaving a third of the city without heat, according to local authorities. Russian ballistic missiles and drones rocked Kyiv from the early hours of Saturday morning, where an air alert was in place for nearly 10 hours. The attacks killed a 47-year-old woman and wounded at least 22 others, according to



Kyiv's mayor and regional governor. Among those wounded were two children, said the head of Kyiv's City military administration, Tymur Tkachenko. Ukraine's President Volodymyr Zelenskyy said the attack was "still ongoing" as of 10:45am (08:45 GMT), with some 500

drones and 40 missiles launched targeting "energy facilities and civilian infrastructure". The air raid alert for the capital ended at 11:20am local time (09:20 GMT). In addition to the casualties, Ukraine's Foreign Minister Andrii Sybiba said there was no heat in one-third of the capital, where temperatures hovered around freezing (0 degrees Celsius). Russian forces are "trying to cut off all Ukrainians from our critical resources just to freeze us", Kyiv-based journalist Kristina Zelenyuk told Al Jazeera.

### Drunken on duty, cops dismissed from service, no relief from High Court

Chandigarh : The Punjab and Haryana High Court has dismissed a revision petition filed by two cops of the Chandigarh Police, who were convicted in a 20-year-old case registered under the Excise Act. The police had registered a FIR under Section 68 of the Excise Act on January 30, 2003, after both were caught in a drunken state on duty. The case was registered on a complaint filed by DSP Om Parkash. He had reported that the PGI police post received a wireless message that the cops posted with a PCR vehicle had consumed liquor and they were under the influence of liquor on duty.



During checking, the DSP found that Head Constable Rajinder Singh and Constable Harvart Singh were under the influence of liquor. A glass used in drinking and a bottle containing 180 ml of liquor were recovered from the vehicle. Finding a prima facie case, charges were framed against the accused, to which they pleaded not guilty and claimed a trial.

### Staffing crunch germinates longer wait for aggrieved patients

Chandigarh : Aggravating more trouble for the patients due to staffing crunch, massive strike by the Himachal Pradesh doctors has paralysed the healthcare services in Chandigarh. About PGI OPD intake of patients traffic stems from Himachal Pradesh, revealed an official of the Post Graduate Institute. The senior consultants in govt medical college and hospital away on break schedules are busy with their domestic obligations , left with no extra medical specialists . At present, only emergencies are being handled by doctors of Himachal medical



services. The influx of patients are taken over by the Government Multispecialty hospital sector 16 as no winter break is observed by this hospital. At GMCH 32 , the faculty leave is staggered from Dec 15 to Jan 31 with the second half begins from Jan 1 to Jan 18.

### Pkula mayor fails to clear 1.7 tonnes legacy garbage despite several promises

Panchkula : About 1.7 lakh metric tonnes of garbage remaining unlifted there only , despite wide assurances by Mayor Kulbhushan Goyal given to residents.

Fresh tender of Rs 11.50 Cr was awarded to the same old agency which cleared 3.72 lakh metric tonnes in 3 years in the earlier phase, said an official of the Municipal Corporation.

This , Dec 25 , is the second dead line, after the earlier dead line of August 31 was too jumped by the contractor, whom again the tender has been



advanced despite several complaints of the residents of the Jhurwala village located near to Ghaggar river. The proximity of the Ghaggar river and continual delay could exacerbate the scourge of piled garbage with the potential high risks of human health, bemoaned hundreds of villagers from Juriwala.

### Election Commission appoints 5 electoral officers for special revision of voters

Chandigarh : In view of undertaking fresh revision of voters, the election commission has appointed 5 electoral registration officers for the Chandigarh parliamentary constituency.

The names of the designated officers would include Sub Divisional Magistrate (Central), Sub Magistrate(East), Sub Divisional Magistrate (South), Director Transport, Director Social welfare, UT,



Chandigarh. The appointment would remain effective until the special intensive revision of 2025-26 electorates is over. The mandatory revision was unavoidable, will continue for comprehensive revision work before the next parliamentary election gets due in 2029.

### Poultry to face closure, violating environmental norms-- NGT

Chandigarh : In contravention of the Central Pollution Control Board ' Environmental guidelines like proper stack height of diesel generator sets , absence of water meters, valid consent to operate , the poultry operator might face closure order. The National Green Tribunal dismissed



the appeal filed by an entrepreneur of poultry farms whose power connection was snapped against the failure to maintain the environmental norms under section 33 A of Water (pre-

vention & control of pollution) act 1974, and section 31A of Air (prevention and control of Pollution) Act 1981.The NGT ordered to close the defaulted poultry farm as it was located in the closer vicinity of a govt school at only 80 meters where school children used to study at their tender age.

CIC reprimands ASR civic body for missing record

As the appellant sought details including the ownership of the property, sanctioned building plans, parking provisions, violations from the approved plan, if any, and the action taken thereupon in the property concerned. During the proceedings, the respondent public information officer submitted that in the absence of a general registration number, town planning wing of the at Amritsar municipal corporation was unable to trace records of the prominent commercial complex, Ganpati Tower, situated on Lawrence Road. However, it was admitted that information related to the property tax department was retrieved and supplied to the appellant. The Punjab Chief Information Commissioner issued detailed directions, flagging serious concerns over record management, enforcement of the building bylaws, and accountability under the Right to Information Act, 2005. The bench was headed by Chief Information Commissioner Inderpal Singh,

examined the appeal filed by a resident seeking information related to a multi-storeyed commercial complex in Amritsar. The respondent further claimed that no construction activity of any nature took place in recent years, including the period preceding the filing of the appeal. It was also submitted that no on-site survey was conducted as no complaint requiring such action was received by the department. The respondent asserted that any action regarding the compounding of violations, if any, could not be undertaken since an RTI application cannot be treated as a complaint under the RTI Act, 2005. The department remained silent on the issue that the property in question is a large commercial complex, comprising more than 75 shops spread over five floors. The complex is located in a posh area of the city and, according to the appellant, lacks adequate parking facilities for commuters. The appellant sought information on these aspects. The commission recorded that it was

not satisfied with the plea taken by the municipal corporation's town planning wing that information relating to the sanctioned map could not be retrieved from official records. It also noted that the Department of Local Government has its own Chief Vigilance Officer and deals with a large number of complaint cases across the state. Keeping these aspects in 8 view, the commissioner cising powers under Section 25(5) of the RTI Act, 2005, directed that a copy of the order be sent to the principal secretary to the Govt of Punjab, dept of local government, for enquiry. The commission sought a specific report to be submitted on or before the next date of hearing on January 14, 2026, on several issues, including whether the respondent's stand that the GR number must be obtained from the owner is justified even when complete details and address of the building have been disclosed; whether any action has been taken by the department so far to retrieve building plan details on its own.

**CHANDIGARH :** PK Pushkarana and others, had joined the Chandigarh Administration and were later transferred to the Municipal Corporation Chandigarh after its constitution in 1994. The petitioner and others retired between 2014 and 2015 and were paid 90 per cent provisional pension in 2015, with the remaining pension released in 2018. The Punjab and Haryana High Court has directed the Municipal Corporation Chandigarh to pay 7.5 per cent interest on delayed pension payments to retired employees. The interest will commence two months after the date of retirement. The court also ruled that 60% of the interest will be borne by the Chandigarh



Administration and 40% by the Municipal Corporation. Justice Jagmohan Bansal noted that the delay in payment was due to communication issues between the Chandigarh Administration and the Municipal Corporation, and the petitioners could not be deprived of their rightful dues. The court directed the respondents to pay interest on the delayed amount, with the Municipal Corporation to verify the figure and make the payment within three months, failing which the interest rate would increase to 9 per cent.

Rs 10L family health insurance cover from next month by Pb

**Chandigarh :** The new family insurance scheme, which is expected to be rolled out for 65 lakh families by the state government early next year, will provide health cover which will be significantly higher from the number of families that are presently covered under the state health insurance scheme. The Punjab government will soon provide health insurance cover of Rs 10 lakh each family of the state under Mukh Mantri Sehat Bima Yojana. When the state government had announced the scheme in July this year, around 45 lakh beneficiary families were covered under the government health insurance schemes,



including around 29 lakh families that were enrolled under Mukh Mantri Sarbat Sehat Bima Yojana, which was capped at Rs5 lakh per annum. “The scheme will be rolled out during the current fiscal with an estimated expenditure of Rs 600 crore, wherein an insurance agency and state's private hospitals will be roped on in to provide healthcare facility to around 65 lakh families residing in the state” said Punjab health minister Harpal Singh Cheema.

3rd most polluted Pkl city emerges in North

**PANCHKULA :** “North India continues to experience unhealthy air quality with AQI remaining in poor category. Unfavourable winter meteorology, lower boundary layer and fog limit pollutant dispersion are increasing exposure risks, especially for vulnerable groups.”, commented Dr Ravindra Khaiwal, Professor of Environmental Health at the Department of Community Medicine and School of Public Health, said in a public health advisory: Panchkula recorded the third-highest air pollution level in North India this evening, prompting concerns not only over deteriorating air quality but also the reliability of pollution-monitoring system amid unusually sharp fluctuations in official readings. Only Delhi and Ghaziabad reported worse air quality, with AQI levels of 373 and 353, respectively, at 8:05 pm on Sunday. Panchkula ranked above Baddi (328), Jind (329), Gurugram (321) and Rohtak (318), reflecting the widespread impact of winter pollution across the region. Official data over the past four



days reveals extreme variation in Panchkula's air quality. On December 18, the AQI was 346 (very poor), before dropping sharply to 145 (moderate) on December 19 — an improvement of over 200 points within a single day. This was followed by a sudden spike to 361 (very poor) on December 20, before easing slightly to 340 on December 21 evening. Such abrupt swings contrast with trends in neighbouring Chandigarh, where changes were more consistent. Chandigarh recorded an AQI level of 266 (poor) on December 18, 254 (poor) on December 19, 302 (very poor) on December 20 and then improved to 216 (poor) on December 21. Environmental observers noted that while both cities were affected by winter pollution, Panchkula's volatility stood out.

Monthly pass for parking across Chandigarh scheduled to come up

**CHANDIGARH :** Soon, the implementation process of a single pass system for all paid sites under its jurisdiction will be initiated. The local body has launched a significant step towards easing parking access for residents by initiating A high-level meeting chaired by MC Commissioner Amit Kumar was held to discuss the Phase-I rollout and integration framework of the new system. Under the proposed structure, monthly passes will be issued at Rs 500 for four-wheelers and Rs 250 for two-wheelers, offering citywide access to all MC-



managed paid parking locations. Officials from the MC, the Department of Information Technology, Chandigarh, and representatives of various banks attended the presentation-cum-pre-consultation meeting. The MC Commissioner directed that a committee be constituted to scrutinise technical and financial proposals and finalise the banking partner for implementation of the system.

Unrented shops of CITCO generate financial loss to corporation : Audit

**CANDIGARH :** The audit inspection report points out Rs 37.87-lakh loss due to infructuous decision of running a bakery shop instead of renting it out. The corporation is running a cafeteria at Sukhna Lake comprising a restaurant, fast food counter and pub. It has rented out shops and the area for amusement and other tourist interest activities. An inspection report of the Director General of Audit (Central) has pointed out a number of shortcomings in the functioning of the Chandigarh Industrial Tourism Development Corporation (CITCO), which led to losses to the corporation. The 2023-24 inspection report highlights the revenue loss of Rs 53.56 lakh due to non-leasing out of shops and other establishments of the corporation. “The CITCO is operating seven petrol stations at



various locations. It also has three hotels, namely Mountview, Shivalikview and Parkview, besides Chef Lakeview food court at the Sukhna Lake. These hotels, petrol pumps and food court have shops/cabins, from which the corporation earns rent. Out of the five shops at Hotel Shivalikview, three have been lying vacant for more than three years,” states the report. During the audit, it found that five shops/cabins/stores had remained vacant for months. At Hotel Shivalikview, shops No. 3

remained vacant from April 7, 2022, till March 2025, shops No. 4 from September 1, 2021, till March 2025, and shop number 5 from March 31, 2020, to March 2025. The last per month rent received from these shops was Rs 26,9100, Rs 34,929 and Rs 38,480, respectively. With monthly rent of Rs 86,031, a booth at Chef Lakeview had remained vacant from December 24, 2024, till March 2025, and a convenience store at a petrol pump with a monthly rent of Rs 26,500 was vacant from April 19, 2024, till March 2025. “Due to non-leasing out of shops/cabins/stores, the corporation suffered loss of lease rent of Rs 53.56 lakh. The corporation should make efforts to lease out these shops and start process before the end of lease period, so that lease rent may be maximised” says the report.

Hry govt extends farmers' loan waiver scheme till March 2026

**PANCHKULA :** During a meeting of the all district-level Chief Executive Officers and Managers held at the Haryana State Cooperative Agriculture and Land Development Bank (Land Mortgage Bank) headquarters information was shared by the bank's Chairman, Amar Pal Rana. The Haryana Government has extended the One-Time Loan Waiver Scheme (OTS Scheme 2022) for overdue borrower-members of the Bank until March 31, 2026. Mr Rana informed that under this scheme, overdue interest on the loan accounts of deceased borrowers of the District Primary Cooperative Agriculture and Rural Development Banks would be waived in full. If legal heir/heirs of a deceased borrower deposit the entire principal outstanding amount, they would receive 100 per cent waiver of overdue interest, along with waiver of penal interest and



other charges, he said. The bank currently has 17,229 deceased and widow borrower accounts, with dues amounting to Rs 190.70 crore in principal, Rs 246.77 crore in interest and Rs 41.68 crore in penal interest, totalling Rs 479.14 crore. “In addition, under the OTS Scheme 2022, all other overdue borrowers will be eligible for 50 per cent waiver of interest, while penal interest and additional charges will also be waived. The scheme will apply to all categories of loans issued by the bank,” Rana said. “As per the scheme, any borrower who, for whatever reason, could not repay his/her loan and was

declared a defaulter by the bank on March 31, 2022, may avail benefits of this settlement,” he said. It is noteworthy that the 19 District Primary Cooperative Agriculture and Rural Development Banks together have 61,767 borrowers, with total outstanding dues of Rs 1,857.92 crore (Rs 723.55 crore principal, Rs 1,002.91 crore interest and Rs 131.47 crore penal interest). The government extended the OTS Scheme once again to facilitate repayment by these borrowers. Rana said, “The scheme has been extended for a limited period. The beneficiaries should avail its benefits on a ‘first come, first served’ basis. For availing the scheme and obtaining further information, borrowers may contact any of the 19 District Primary Cooperative Agriculture and Rural Development Banks or the 70 branches established at the tehsil

Canine bite victim to receive Rs 1-lakh relief, court directs owners

**CHANDIGARH :** Dr Bhumika Gupta, a resident of Sector 49-B, Chandigarh, had filed a suit for recovery of Rs 30,000 with interest rate of 18% per annum on account of medical and incidental expenses for treating the injuries caused by a dog owned by Divya Setia and Manpal Setia, who lived in her society. She also sought damages and compensation of Rs 2,00,000 for the reputational, economical, mental and social loss caused to her. A local court has directed the owners of a dog to pay a compensation of Rs 1 lakh to a woman who was bitten by the canine. The court also directed the owners to pay Rs 30,000 on account of medical and incidental expenses. Gupta said on January 18, 2020, she went to the terrace of her building to collect clothes hung up for drying and found Divya and her five unchained pet dogs there. One of the dogs suddenly attacked her, making her fall



down. Thereafter, the dog bit her on the forehead and scratched the flesh thereof. An extensive section of skin was completely torn off the underlying tissue. As she shouted for help, other residents of the society came out. She was taken to the hospital for medical aid. The police were informed about the incident. Both defendants admitted their mistake and requested not to take any legal action while assuring that they would bear the expenditure on her treatment. She agreed and no FIR was registered. Later, the plaintiff underwent medical treatment, which cost her around Rs 30,000. The injuries permanently

disfigured her face. She had to remain at home for around a week, which also caused loss to plaintiff's professional and social life. When asked to fulfil the commitments, including reimbursement of the medical expenses and compensation, the defendants did not give any satisfactory reply. The defendants, however, denied the allegations and claimed that they had kept only two pet dogs as per the permissible limit and the canines were duly licensed and registered with the MC. After hearing the arguments, the court ordered that the defendants to pay Rs 30,000 on account of medical and incidental expenses along with simple interest at the rate of 9% per annum. Further, the plaintiff was also entitled to damages and compensation of Rs 1 lakh to be paid by the defendants for causing reputational, economical, mental and social loss to her, the court ordered.

Submit suggestions for formulation of excise policy 2026-27 - UT Excise deptt

**CHANDIGARH :** Facing allegations of cartelisation, the UT Excise and Taxation Department has invited suggestions from stakeholders and general public for the formulation of the Excise Policy 2026-27. The suggestions or feedback could be submitted latest by December 30. Seeking consumer-friendly policy, Darshan Singh Kler, president, Chandigarh Wine Contractors' Association, suggested that the upcoming Excise Policy 2026-27 should be formulated while considering the transparency and to prevent “cartelisation” of the liquor trade in the city. “The policy should focus on the retailers and the consumers of the city while preventing the increase in rates of various kinds of liquor like the previous years,” he

further added. Advocate Sachit Jaiswal, who deals in excise and taxation cases, suggested that any officer against whom complaints were pending should not be the part in formulating the upcoming Excise Policy. “The administration should take steps against monopolisation of the liquor trade in the city,” he said, further adding that a single individual from a family/enterprise/business firm or as an individual should only be allowed to run not more than five liquor vends.

“To strengthen revenue protection, promoting transparency, safeguarding public health, ensuring fairness, and improving enforcement,” Ajay Jagga, member, Administrator's Advisory Council, suggested that prohibition of employment of men under the age of 25 years and women. Further suggestions included that no person licensed to sell liquor should employ with or without remuneration any man under the age of 25 years or any women in any part of such premises where liquor or intoxicating drugs are consumed by the public. Besides, the number of liquor drinking places/restaurants must be freed (or reduced) in the areas like Sector 10, 11, 15, 26, 32, 36 etc, where educational institutions are high in numbers.

Pakistan surrounded by horrific victimisation of minorities, India rejects Pak's remarks : MEA

NEW DELHI : “Pakistan’s own treatment of minorities of various faiths was a “well-established fact” that could not be obscured by what he described as finger-pointing” said Randhir Jaiswal Ministry of External Affairs. India strongly rejected on Monday remarks by Pakistan’s ministry of foreign affairs on incidents involving minorities in India, saying comments from a country whose abysmal record on this front speaks for itself. Pakistan’s horrific

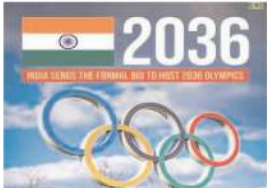


and systemic victimisation of minorities is a well-established fact. No amount of finger pointing will obfuscate it.” Jaiswal said. The MEA response came after Pakistan’s foreign office spokesperson Tahir Andrabi, in a statement issued in Islamabad on Monday, expressed concern over what he termed the “persecution

of minorities in India”. In his remarks, Andrabi referred to incidents of vandalism during Christmas and alleged “state-sponsored campaigns” targeting Muslims, including the demolition of homes and instances of lynching. He also called upon the international community to take note of what he described as violations of the rights of vulnerable communities in India. India has consistently dismissed such statements from Pakistan, maintaining that they are aimed at diverting attention from Islamabad’s own domestic record and misuse of minority rights narratives at international forums.

BJP’s commitment to make Thiruvananthapuram 2036 Olympics venue generate political uproar

Thiruvananthapuram : BJP Kerala unit urge it would request the Centre to include the city as one of the venues for the 2036 Games. In its manifesto for the Thiruvananthapuram Corporation election. BJP’s local body election manifesto promise to develop the state capital into a co-host city for the 2036 Olympics triggered a political row, with leaders of both LDF and UDF on Monday calling it a fake claim. The International Olympic Committee is yet to announce the host for the 2036 edition of the world’s biggest sporting event. However, there have been reports that India is bidding for the Games with Ahmedabad as its proposed main host city. Kerala Education Minister V Sivankutty accused BJP of deceiving the people of Thiruvananthapuram. “When the Union Government has bid for the



Olympics in Gujarat, how can BJP here claim that Thiruvananthapuram will be a venue?” He further said as part of the bidding process, BJP is planning for the 2030 Commonwealth Games in Ahmedabad, he claimed. He asked whether BJP state president Rajeev Chandrasekhar considered the people of Thiruvananthapuram “fools”. “The proposal submitted to the Olympic body has no mention of Thiruvananthapuram. This is a trick because BJP has nothing to say about development,” he said. Senior Congress leader K Muralaeeharan also hit out at BJP on its election manifesto,

saying that, fearing defeat, the party had begun making “fake promises”. “They know they would not even become the main opposition party this time. Hence, such claims,” he said. State Revenue Minister K Rajan echoed a similar view, stating that the host for the 2036 Olympics had yet to be announced, but BJP claimed the event would be held in Thiruvananthapuram. Reacting to the criticism, Chandrasekhar said that other political parties would realise the proposal later. “They do not understand how it will happen. We will teach them after we get the opportunity to govern,” he said. BJP is currently the main opposition in the CPI(M)-governed Thiruvananthapuram Corporation. The local body election in the state will be held in two phases on December 9 and 11.

Kangana to appear on January 5 as the court case deferred

BATHINDA : “Kangana did not appear in court on Monday, and her proxy counsel had filed an application seeking her exemption for the day, citing the ongoing winter session of the Lok Sabha, which was granted,” said Advocate Raghubir Singh Behniwal. A special MP-MLA court on Monday adjourned the hearing in the defamation case against BJP’s Mandi MP and Bollywood actor Kangana Ranaut to January 5 after the prosecution witnesses and the accused failed to appear. The case was listed for the cross-examination of the prosecution witnesses—complainant Mahinder Kaur, an elderly farmer from Bahadurgarh Jandian village here, and her relative Gurpreet Singh. Arguments on Kangana’s plea for permanent exemption from personal appearance in the court were also scheduled to be heard. “Mahinder Kaur could not



appear due to her old age and the cold weather. The court has directed that all witnesses be presented by furnishing their names to the court as well as to the accused’s counsel before the next hearing. The court has also directed Kangana to appear at the next hearing,” he added. The case pertains to a 2020 tweet by Kangana during the farmers’ protest, in which she shared a photograph of Mahinder Kaur, mistakenly identifying her as Shaheen Bagh protester Bilkis Bano and alleging that such women were “available for Rs 100” to participate in protests. Mahinder Kaur filed a defamation complaint against her in January 2021.

Longer work visas opened for Indian students; 5,000 professionals to benefit in New Zealand

NEW DELHI : Under the concluded trade pact, New Zealand has liberalised mobility provisions enabling Indian students to access longer post-study work visas and allowing 5,000 Indian professionals, including yoga instructors and chefs, to work in the Oceania country. “The students going to New Zealand for study will now be eligible for a two-year work visa if they take degree course, three-year work visa if they take bachelors degree with honors or are graduate in STEM disciplines and a four-year work visa if they do postgraduate studies in New Zealand,” Commerce and Industry Minister Piyush Goyal told reporters here. The two countries on Monday announced closure of the FTA negotiations. It is expected to be signed and implemented in about 7-8 months from now. The Union Cabinet approved the pact last week. The pact also needs approval from the New Zealand parliament. As per the pact, New Zealand has, for the first time, signed an annexure on student mobility and post-study work visas with any country, offering no numerical caps and locking in



20 hours a week of work rights for Indian students. He also said that almost 5,000 of India professionals such as yoga instructors, chefs, Ayush professionals, IT, education teachers, nurses, caregivers, will get professional visas for serving the New Zealand economy. At present, an estimated 12,000 Indian students are enrolled in various courses in New Zealand. The pact provides for a Skilled Employment Pathways through a new Temporary Employment Entry Visa pathway for Indian professionals in skilled occupations, with a quota of 5,000 visas at any given time and a stay of up to three years. It is in addition to the existing visa pathways; “therefore, professionals and skilled workers can continue to apply to go to New Zealand under the existing visa regime (e.g. Accredited Employer Work Visa, Skilled Migrant Category Resident Visa, etc),” the Commerce Ministry said.

India-Australia Economic Cooperation provides Zero-duty access to Oz market from Jan: Goyal

NEW DELHI : “Reminiscing three years of the trade pact, the agreement had emerged as a key pillar of India’s economic engagement in the Indo-Pacific region, delivering tangible export gains, deeper market access and stronger supply-chain resilience” said Commerce and Industry Minister Piyush Goyal. Indian exporters will gain zero-duty access across all Australian tariff lines from January 1, 2026, a major milestone under the India-Australia Economic Cooperation and Trade Agreement (Ind-Aus ECTA), Goyal said on Monday. The removal of tariffs is expected to open fresh opportunities for labour-intensive sectors such as textiles, leather and handicrafts, while also



benefiting manufacturing and agriculture. The minister said the agreement had supported Indian exporters, MSMEs, farmers and workers across sectors. According to official data, India’s exports to Australia grew 8 per cent in FY 2024-25, contributing to an improvement in the overall trade balance. Key export growth was recorded in manufacturing, chemicals, textiles, plastics, pharmaceuticals, petroleum products, and gems and

jewellery. Agricultural exports also saw robust expansion, particularly in fruits and vegetables, marine products and spices. Coffee exports registered exceptional growth during the period. Gems and jewellery shipments alone rose 16 per cent between April and November 2025. Goyal also highlighted the signing of a mutual recognition arrangement (MRA) on organic products, which is expected to simplify certification processes and reduce compliance costs for exporters. As negotiations on a broader Comprehensive Economic Cooperation Agreement (CECA) continue, the minister said the Ind-Aus ECTA remained central to India’s trade strategy in the Indo-Pacific region.

Cong mulls tickets on new faces as party battled internal rift throughout years

CHANDIGARH : Amongst 70 new faces as candidates for the 2027 Assembly polls would be picked up said. Punjab Congress president Amrinder Singh Raja Warring. He has sent a strong message to the old guard, saying the party would decide afresh considering the merits. The Congress, which is the state’s main Opposition party, grappled with factionalism throughout the year. Will submit this to the party high command that would conduct its own surveys to ascertain new faces,” he told. “There are many new faces among recently appointed district presidents. My take on the issue is in line with Rahul Gandhi’s process of bringing new faces,” added Warring. Asked why the party failed to identify the leaders who could lead the Congress in run-up to the

next elections, Warring said to be a leader, one had to be disciplined, hardworking and loyal. “AAP found a leader in CM Bhagwant Mann in 14 years,” he quipped. On too many CM aspirants and problem of leaders vying for one-upmanship, Warring clarified that he was not in the race. “The party has already given me a lot,” he added. On why senior leaders were “fighting their personal battles” to retain their positions, he said, “It is a problem with some leaders across the country. Like Capt Amarinder Singh, they think they are popular and great leaders. On the Congress CM face ahead of the polls, Warring said the party had decided not to project a leader for the post as happened in Karnataka, Himachal Pradesh, Chhattisgarh and Telangana.

## China triggers fire drills around Taiwan, Japan resists, would embroil in conflict

Beijing : By deploying navy, air, rocket troops , China has launched live-fire drills in war games around Taiwan, its military said were aimed at testing combat readiness and delivering a "stern warning" against "separatist" and "external interference" forces.

The exercises on Monday prompted Taiwan to scramble soldiers and hardware to rehearse repelling an attack.

It came amid anger in Beijing over an \$11.1bn weapons sale to Taiwan by the United States, as well as a statement by Japanese Prime Minister Sanae Takaichi, who suggested that



the Japanese military could get involved if China were to attack the self-governed island.

Beijing considers Taiwan as part of its territory and has pledged to take control of the island by force if necessary.

In a statement, the Chinese military's Eastern Theater Command said it had concentrated forces to the north and southwest of the Taiwan Strait and carried out

live firing and simulated strikes on land and maritime targets.

The drills, dubbed Just Mission 2025, would continue on Tuesday and include exercises to blockade the island's main ports and encircle it.

Shi Yi, a spokesperson for the Eastern Theater Command, said in a post on Chinese social media platform Weibo that the activities will focus "on training for maritime and aerial combat readiness patrols, gaining ?integrated control, sealing off key ports and areas and conducting m u l t i - d i m e n s i o n a l deterrence".

## Centre opposes PIL in Delhi High Court to slash GST on air purifiers

New Delhi : 'Pandora's Box' situation might ensue if the Court were to order the GST Council to slash goods and services tax (GST) without following the applicable process involved before such decisions can be taken. Add. Solicit General on Fiday informed Delhi High court in [Kapil Madan vs Union of India & Ors] case. A Division Bench of Justices Vikas Mahajan and Vinod Kumar was hearing a plea on air purifier case seeking directions to categorise under the kind of 'medical device' and



reduce the GST on them from 18 to 5 percent. The High Court had, on December 24, asked the GST Council to convene an urgent meeting to consider this proposal. The Central government today said that the matter is being examined at the highest level, but sought more time to give a measured response.

Additional Solicitor General (ASG) N Venkataraman, representing the Centre, added that if the GST Council mechanism is bypassed in this case, it could open a Pandora's Box whereby more GST exemptions may be sought without following the proper procedure. "This will open a Pandora's Box. Parliamentary committee has recommended something to us. It will be considered. There is a process. We are not saying anything. We are not saying whether it will be done or not. Constitution issue is involved," the ASG said.

## PPCB to submit district wise verifiable water pollution data to NGT

Chandigarh : Across the state, district wise verifiable water pollution data would be required for submission to National Green Tribunal, revealed the sources. The submission of information would help assess the ground realities and the effectiveness of remedial measures. The NGT bench comprised Justice Prakash Shrivastav and expert member Dr Senthil Vel in a suo motu case. A total of 1511 sources of water pollution were identified, and a total of 45.79% were closed or removed, left



with 819 pollution sources where action was needed as yet, apprised the PPCB. The various categories of pollution generating units included industrial units, dairy waste outlets, municipal discharges, village waste water outlets and individual sources.

## Polish jets intercept Russian reconnaissance plane spotted near airspace

Warsa : Posh air force intercepted a "Russian reconnaissance aircraft" flying near the border of its airspace just hours after tracking suspected smuggling balloons coming from the direction of neighbouring Belarus. "This morning, over the international waters of the Baltic Sea, Polish fighter jets intercepted, visually identified, and escorted a Russian reconnaissance aircraft flying near the border of Polish airspace from their area of responsibility," the Operational Command of the Polish Armed Forces said in a post on X on Thursday. Polish forces also tracked unknown "objects" flying in the direction of Poland from Belarus during the previous night, prompting Warsaw to temporarily close civilian airspace in the northeast of the country. "After detailed analysis, it was determined that these were most likely smuggling



balloons, moving in the direction and at the speed of the wind. Their flight was continuously monitored by our radar systems," said the Operational Command. The post did not disclose any further details about the number or size of the balloons. Polish Defence Minister Wladyslaw Kosiniak-Kamysz said on X that the incidents did not pose an immediate threat to Poland's security, and he thanked the "nearly 20,000 of our soldiers who, during the Holidays, watch over our safety". "All provocations over the Baltic Sea and near the border with Belarus were under the full control of the Polish Army," he said.

## Digvijaya Singh Cong leader back tracks from praising RSS, BJP

New Delhi : Senior leader Digvijaya Singh's praise for the RSS and the BJP has exposed cracks within the Congress in a fresh crisis that has gripped the grand old party and raised questions over unity and discontentment among the senior leadership. Singh had triggered controversy over an online post in which he said that the BJP-RSS allow grassroots workers to grow within the organisation to top posts like chief minister and prime minister, sharing a photo of Prime Minister Narendra Modi sitting on the floor near BJP veteran LK Advani. But in quick succession, he back tracked saying he had been staunch critic of the RSS-BJP, the damage was already done. His post brought to attention another



remark by Singh from a week ago, in which he had publicly called for the need for reforms and decentralisation of power within the Congress, tagging Leader of the Opposition Rahul Gandhi. His posts sparked a debate over whether a section of Congress leaders believed that the RSS's discipline was its strength that offered a learning opportunity. In a firefighting mode, Congress cleared its stand: it doesn't believe in the RSS ideology. Singh also clarified that there was nothing to learn

from "Gandhi's killers," referring to Nathuram Godse. "I have been in the Congress and fought the communal forces in the Assembly or Parliament. I oppose their (RSS and BJP) ideology. I have been completely opposed to their ideology," he said, but asserted that every organisation needs strengthening. Singh's earlier remark, however, had already divided the Congress, with a majority of the leaders siding with him. But Pawan Khera, a member of the highest decision-making body of the Congress, chose to differ. "I don't agree to what he said. Godse's supporters cannot be Gandhi's supporters," said Khera, who is in charge of the party's media and publicity.
