Congress a fighting force for 2024 polls?

Congress has effectively future disputes between articulated its political narrative through images and metaphors depicting a 'loving' India, not an articulation through words. Congress had struggled to come up with any coherent counter-narrative to BJP's nationalism for the last eight years. Partly, this was for the historical reason that Congress's nationalism had been the same combination of developmental and unitary nationalism that was now owned by BJP. And partly, because evocations of secularism and pluralism always seem emotionally bloodless in front of the assertive flag-waving nationalism of BJP.

So the yatra provided that rare occasion when Congress also effectively articulated its own political narrative.

It did so through the clever use of populist spectacles: images and metaphors depicting a 'loving' India, not an articulation through words.

This aesthetic format suited Rahul Gandhi as it allowed him to steer clear of contentious debates (on Hinduism vs Hindutva, for instance).

It also generated a huge amount of PR material that could be funnelled through social media channels.

Yet, as opinion polls keep pointing Out, BJP's Hindutva is still clearly at pole position as the ideological dominant imaginary. The attacks on socio-economic inequality, conjured up some media buzz but it needs to be followed through into a political platform, along with tangible solutions, if it is going to be a potent political narrative for 2024. The delay in structural reforms within the party being a major cost However, the renewed activity of some of the frontal organisations of Congress, as well as numerous dormant workers, should count as a positive. The weakest component of the yatra relates to alliances. Only three parties, who were not erstwhile partners, joined the yatra: Farooq Abdullah's NC, Mehbooba Mufti's PDP and Kamal Haasan's Makkal Needhi Maiam (MNM). The yatra had been taking place in a political context marked by heightened polarisation between BJP and non-BJP political forces, with a coercive state apparatus becoming a major bone of

In such a scenario, for the yatra to not get forthright support from even some traditional Congress allies must count as a negative. It also reflects that Rahul Gandhi might have become a stronger political personality through the course of the yatra, but he (or his team) still needs the softer alliance-managing skills of the Sonia/Ahmed Patel duo in order to construct a grand opposition alliance.

MOHALI: The total number

of primary schools in Punjab was 12,826. There were 227 regular posts of safai sevaks in the primary schools of the state, according to the RTI reply. Of these, only 22 posts were filled by the government, said Kuljit Singh Bedi, MC Deputy Mayor.

According to information obtained through an RTI application, there are only 22 safai sewaks at 3,943 primary schools in the state.

The information also reveals that 295 safai sewaks are serving in these schools on a temporary basis. "There are a large number of bathrooms



built in primary mostly through the grant of the Central Government, but there is no permanent arrangement for cleanliness," said during a press

conference in Mohali. Bedi said in Mohali district, of the 216 primary schools, only seven safai sewaks were

Vision syrup fails in retest

Commissioner News Service CHANDIGARH: The Drug Control Officer, Ambala, had

moved an application under Section 25 (4) of the Drugs and Cosmetics Act, 1940, for retesting of the third sealed sample of the seized drug. After the application was filed, the statement of M/s Digital Vision was recorded and the sample sent to the Central Drugs

Laboratory, Kolkata, for retesting on July 21, 2020. An Ambala court has revealed that the third sample of the syrup manufactured by Digital Vision, which is suspected to be behind the death of 12 children in J&K's Udhampur in 2020, also failed the quality test on retesting.

Earlier samples of the syrup also failed the retest and were "found to be not conforming to the manufacturer specifications".
"The report, dated March 26, 2021, has been received. The sample was retested and has been found to be substandard. A copy of the report has already been sent by the Central Drugs Laboratory to the State Drugs Controller, Haryana, and to the Drug Controller General, New Delhi," said the order of Chief Judicial Magistrate (CJM) Saurabh Gupta, dated January

Under Section 25 (4) of the Drugs and Cosmetics Act, 1940, the test report in writing is signed by or under the authority of the Director of the Central Drugs Laboratory, and "such a shall be conclusive



evidence of the facts stated therein"

According to sources, the sample of the Cold Best-PC has adulterated in the retest. The report of the samples will

be attached with the Food and Administration Department's complaint against Digital Vision for a trial. After the Udhampur deaths in January 2020, it was found that Cold Best-PC Syrup was allegedly contaminated with diethylene glycol, a toxic substance. The syrup, used for cold and fever children. subsequently banned.

The probe has revealed that Digital Vision had supplied its entire stock of 5,575 bottles of the syrup to Ambala Cantonment-based distributor Shiva Medical Hall. The latter supplied 1,620 bottles to PP Laboratories, Palwal; 324 to Shiva Medical Agencies, Ambala Cantonment; 162 each to Padha Medical Hall, Panipat, and Anil Medical Store, Raipur Rani; 50 to Om Medicose, Babain; and 30 bottles each to Medical Nursing Home, Kalka.

The protesters asked BBC to stop broadcasting the documentary "India: The Modi Question" in the UK. They held placards carrying slogans like "Boycott BBC", "British Bias Corporation" and "BBC: you don't deserve public money". They waved the Indian flag and were heard shouting slogansoutside the Oxford Circus BBC HQ-like "Bharat Mata Ki Jai" and "Shame on



Protester Malti Sharma, 40, who runs a construction company, said the BBC documentary had "spread lies about the Indian PM based on false propaganda". She said the BBC had cut interviews it conducted and 'just showed what suited their agenda".

'They have done this to spread a false narrative in India to provoke violence Hindus between and Muslims. Who are they to question our Supreme

Court? I am boycotting BBC. Why are they showing this now? There are so many powers working behind the scene to stop PM Modi in 2024 but I think he a will still win," she said.

Protester Sunil Verma asked why BBC has never shown anything about Hindu girls being abducted in Pakistan and omitted Kashmir from its maps of India in the past. According to the protesters, the documentary doesn't tell the entire story, including the genesis of the riots.

Sprint queen breaks down against encroachment at her athletics school

In New Delhi, addressing a press conference she said those at the Usha School of Athletics had been facing such harassment and security issues for some time and it has intensified after she became the Rajya Sabha member. Usha had been nominated to the Upper House by the BJP in July 2022.

The "sprint queen" appealed to the Left government in Kerala and Chief Minister Vijayan intervene into the issue and take immediate steps to stop



the alleged encroachment and trespassing into the campus and ensure the safety of women athletes

"Of the 25 women athletes in the Usha schools, 11 were from north India. It is our responsibility to ensure their safety. I submitted a written complaint to the Chief Minister in this regard," she said.

GMADA, MC to remove encroachments in Mohali sectors: Minister

MOHALI: Aman Arora, Minister of Housing, urban developments issued the directions for serving 15 days notice to residents encroaching upon the government land outside their houses and if they do not rectify on their own, then carry on the demolition and ask the violators to incur the cost of the demolition.

The MC had detected encroachments government land, like boundary walls being demolished to get access to government land along the road. Some residents were also found constructing stair cases outside the boundary walls.

The civic body failed to provide actual report of the encroaches so, a fresh survey was conducted after which 4,500 such

Extending the main gate on MC land outside the driveways to use it for vehicle parking also falls under encroachments.

However, GMADA and MC became active to remove encroachments from roadsides, corridors and other public places following a contempt notice from the Punjab & Haryana high court.

CHANDIGARH: "We

have given in-principle approval to have PNG Piped Natural Gas) in all government housing sector. In private houses, people have the option to avail the connection, but such a network is not available in government housing,' said the Adviser.

More than 13,000 government houses maintained by the engineering department in both northern and southern sectors would be connected with the supply. The PNG is considered safer and cheaper by 20% of the liquified petroleum gas

FIR in corruption against IAS Ashok Khemka

Clarifying the scope of Supreme Court verdict given in 2013 in the Lalita Kumari versus the State of Uttar Pradesh case regarding the registration of FIRs, the chief secretary's office clarified that the Lalita Kumari case specifically mentions a preliminary inquiry before the registration of FIR in corruption cases. In the previous clarification given to the chief secretary's office, the DGP's office in its reply dated November 18, 2022 had said the case against Khemka was registered in compliance with the Lalita Kumari judgment.

Kaushal Mr Sanjeev Kaushal Haryana chief Secretary has made it clear to DGP PK Agrawal that in case of corruption charges against pubservants, it is mandatory for police to take prosecution sanction under Section 17-A of the Prevention of Corruption Act, 1988, before any inquiry or investigation. "The apex court judgment says in the case, titled Yashwant Sinha and Others versus CBI, held that in terms of Section 17-A, no police officer is permitted to conduct any inquiry or investigation into any offence done by a public ser-

vant where the offence

allegedly is relatable to any

recommendation made or

ecision taken by the public



servant in discharge of his public functions without previous approval. Unless, therefore, there is previous approval, there could be neither any inquiry nor investigation. You are, therefore, requested that while keeping in mind the Lalita Kumari case in the instant matter, the provisions of the amended Prevention of Corruption Act,2018 and the Yashwant Sinha case also need to be given primacy and it should be clarified to all authorities concerned that sanction under Section 17 of PC Act is mandatory before inquiry or investigation," the chief secretary's office informed the DGP office in its January 20 Communication.

The communication by the chief secretary's office clarifies that constitutional courts in various pronouncements, including the judgment dated January 11, 2019, of the Delhi high court, titled Devender Kumar versus CBI, have clearly enunciated the scope of Section 17-A of the PC Act holding that the

available to the public servants in relation to the decisions taken or recommendations made during the bonafide discharge of their official functions only and no prior approval is required in trap cases or when the alleged act of the public ser-

vant is ex-facies criminal. The Panchkula police had booked Khemka on April 26, 2022, on cheating and corruption charges on the complaint of Haryana Warehousing Corporation MD for the irregularities in some appointments made during Khemka's tenure as corporation MD. Khemka, in a representation to the chief secretary on April 28, 2022, stated that no prosecution sanction was obtained under Section 17-A of the PC Act while registering the FIR against him. He also stated that the incident alleged in the FIR was 12 years old and had been probed earlier a number of times by police. He also claimed that no cognizable offence was made against
