

"Denmark Warns US Of 'Devastating' NATO War", troops are under standing order

Copenhagen : Denmark would have to defend itself in the event of an American attack on Greenland, said Denmark Member of Parliament and Chairperson of the Defence Committee Rasmus Jarlov. He acknowledged that although the Danish army would not be able to stop the US, an attack is not acceptable. Tension soared over Greenland as US was co-considering paying cash to Greenland to encourage independence from Denmark, a move that was being detested. Mt Jarlov said, "We also want to make clear that it's not acceptable to attack us militarily, and it would lead to the absurd situation and disastrous situation of a war



escalate," he explained. Trump previously made an offer to buy the island in 2019, during his first presidential term, only to be told it was not for sale. After returning to office following his victory in the 2024 US Presidential Election, Trump revived his offer from his first term to purchase Greenland, which was again turned down. Jarlov said that Greenland is not for sale and that it is not a matter of price for the nation. "We can't sell 57,000 Danish citizens to become Americans. Our Greenland is theirs and we have made that extremely clear." Shoot us first, if Greenland is attacked as Europe grows anxious over potential US military action.

Jammu : The National Medical Commission's decision to withdraw permission for the Shri Mata Vaishno Devi Institute of Medical Excellence for non-compliance with minimum standards has evoked mixed reactions here, with the BJP and Sangharsh Samiti welcoming the move. The Samiti and PDP have termed it a setback for people of the region. Sangharsh Samiti, a recently formed conglomerate of right-wing organisations backed by the BJP, has been spearheading an agitation in Jammu since November last year, demanding cancellation of admissions to the College and seeking reservation of seats exclusively for students professing faith in Mata Vaishno Devi. The Samiti emerged soon after admissions for the inaugural MBBS batch of 50 students was completed through the NEET merit list. Of these, 42 students are Muslims—mostly from Kashmir—along with seven Hindu students from Jammu and one Sikh candidate, a composition that triggered demands for scrapping the admissions and reserving all seats for Hindu students. The National Medical Commission's

Assessment and Rating Board (MARB) on Tuesday withdrew the letter of permission granted to Institute in Jammu and Kashmir's Reasi for non-compliance with minimum standards. An order issued by the MARB on Tuesday said all students admitted to the college during the counselling for the academic year 2025-26 shall be accommodated in other medical institutions in Jammu and Kashmir as supernumerary seats by the competent authority of the Union Territory administration. "We welcome the decision of the National Medical Commission's Medical Assessment and Rating Board, Union Health Minister J P Nadda and Lt Governor Manoj Sinha for withdrawing the permission but at the same time securing the future of the students," J-K BJP president Sat Sharma told reporters here.




appeared for Varma, and solicitor Tushar Mehta who represented both the houses, a bench of Justice Dipankar Datta and SC



He informed that 81.30 percent voters of the existing voter list filled their forms and registered their names



for the new draft voter list. There were a total of 15 crores 44 lakh 30 thousand 92 voters in the existing voter list.

US brazen foreign policy

The extraction of Maduro, President of Venezuela, right out of his fortress, by a Delta Force unit authorised by Trump, may be one of the most brazen foreign policy moves in recent humanitarian record. But in foreign policy, there is no moral right or wrong, just self-interest and their might is always right. It always is and always has been.

This will be yet another Iraq or Afghanistan, say some. Others say, "Well, didn't Trump promise America will not be involved in foreign adventures any more? Was he not all about America first?" Still others are frothing and fuming at his blatant disregard for international world order (a world leader cannot just arrest another from his home), and for domestic precedent (in operations like this the opposition is taken into confidence and Trump didn't do that).

Maduro is accused of being a drug lord and a brutal dictator who has terrorised his citizens, reduced them to penury, while appropriating oil revenues for himself and his henchmen. Previous administrations would have used this as the hook and framed the Saturday operation as America asserting its position as the world's moral force, bringing democracy and liberating countries.

Lindsey Graham, Trump critic turned acolyte, tried to toe that line, only to be interrupted by Trump declaring no, this is about oil. Why is he saying the quiet part out loud? Oil is America's worst kept secret, the driving


force for most of its military adventures, but one no US administration acknowledges. So why do it now? Because this is exactly what his base wants to hear. Trump's shick has always been that he does not want to h spend US dollars on regime-change for vague strategic objectives, which make sense only to foreign policy wonks. He is not interested in doctrines and encirclement. He wants to see the money. In his world, it only makes sense to go to war if there is a return on investment. Many people agree. To the 60-plus demographic in conservative states that's his base, he has messaged directly, with the honesty and straightforwardness that his fans associate with him, something like: 'Yes, it is the oil. I don't care for making the world a better place. I only care for you the Americans and our self-interest. And we are the strongest country in the world, and we won't apologise for it. We will get what we want, and who dares stand in our way?"

US spends a lot on its military. But for decades, its citizens haven't seen much in terms of overwhelming military victories. There was Vietnam. During the Iranian revolution, their embassy was held hostage. That was the time Trump was a young man, and the humiliation Americans suffered led to the defeat of Jimmy Carter plus the rise of Reagan. In Afghanistan, under Biden, Americans ran away in chaos, leaving

Trump stands self glorified realising a vision of unilateral US domination in the way that exists in the imagination of many Trump voters, waging a populist war on all fronts: illegals being flown out in chains, countries that have taken END advantage of US (it doesn't matter if this is true or not) being punished by tariffs (it doesn't matter that it is Americans paying those tariffs), and world leaders who mock Trump picked up from their houses and thrown into prison.

'Development and Regulation Act' sought change by Chandigarh Admn

CHANDIGARH : The UT Administration has sent a proposal to the Ministry of Home Affairs (MHA) seeking an amendment to the Capital of Punjab (Development and Regulation) Act.

Owners of industrial plots and commercial properties may soon get long-awaited relief from steep penalties imposed for violations of building bylaws.

The amendment would empower the UT Administration to rationalise penalties in building violation cases at its own level. Once approved by Parliament, the amendment would apply to both pending and future cases in the city.

More than 5,000 notices related to building violations were pending in Chandigarh, primarily involving industrial sites and commercial properties. UT Chief Secretary H Rajesh Prasad said: "An amendment to the Act is necessary. Only after that penalties in these 5,000 cases, and future cases as well can be rationalised" said the officials.

During a review of building violation cases, the Chief Secretary had noted that in



several instances, penalties had reached alarming levels. "In some cases, the penalty amount has become almost equal to the value of the property itself. A permanent solution is required so that such penalties can be rationalised," he said.

The officials explained that the Estate Office issues notices for additional construction or construction beyond approved building plans, including for minor deviations. Such notices have been served extensively in industrial areas and commercial buildings across the city.

Under the existing provisions, penalties start accumulating from the date a notice is issued and are calculated at Rs 10 or more per square foot per day.

Within months, this often results in penalties running into several crores of rupees, making them virtually impossible for businesses to pay.

Strict MC drive launched against property tax defaulters



MOHALI : Sealing notices had been issued under Section 138-C of the Punjab Municipal Corporation Act, 1976, to repeat defaulting properties, and in appropriate cases a final period of three days has been granted for payment of the entire outstanding property tax said Commissioner Parminder Pal Singh.

A strict enforcement drive against repeat property tax defaulters, particularly major commercial and industrial properties that have failed to deposit the property tax despite repeated notices and adequate opportunities.

Parminder Pal further cautioned in the event of failure to clear the dues within this final period, the municipal corporation will proceed to seal the premises without any further intimation, and the owner/occupier shall be personally responsible for any loss or damage to goods, stock or machinery lying inside the sealed property.

Jasjit Singh, Joint Commissioner added that after sealing, the municipal corporation was empowered under law to dispose of such properties through public auction to recover outstanding



property tax, along with penalty up to 20 per cent of the tax amount and interest at the rate of 18 per cent with effect from April 1, 2014, till the date of recovery as admissible under the Punjab Municipal Corporation Act, 1976.

The present action particularly covers prominent industrial and commercial units located in various phases and sectors of Mohali, details of which have been compiled in the defaulter list prepared by the MC. All property tax payers who are still defaulters have been warned to immediately deposit their arrears along with applicable penalty and interest at the office of the MC within the stipulated time.

Any delay or failure to comply will invite coercive measures, including sealing of property, auction for recovery of dues and other legal proceedings as per the Punjab Municipal Corporation Act, 1976.

Further, the plaintiff was also entitled to damages and compensation of Rs 1 lakh to be paid by the defendants for causing reputational, economical, mental and social loss to her, the court ordered.

Action sought by PPCB against Chd MC, Contractor for illegal dumping of garbage

CHANDIGARH : The UT civic body had awarded a contract to a consortium of M/S Aakanksha Enterprises, Dwarka in New Delhi and M/S Rekart Innovations Private Limited, Gurugram (trailing member); for a sum of Rs 67.96 crore for biomining of the legacy waste and reclaiming the land in Dadumajra in 2022.

After five garbage-laden trucks on their way from Chandigarh to Palheri were impounded in a late night operation by the Punjab Pollution Control Board (PPCB) and the Punjab police, a controversy has erupted over the inept handling of legacy waste by the Chandigarh Municipal Corporation.

If the legacy waste was to be disposed of in the vicinity in the dark of night, why so much taxpayers' money was being spent on the bioremediation project pointout environmentalist and residents.

The Mullanpur police registered a case against the five trucks registered under Punjab number have been impounded which were unidentified persons.

On Saturday, PPCB officials recommended an FIR



management contractor, truck owners, drivers, landowner, where the garbage was being dumped, and the Chandigarh Municipal Corporation, under the Environment Protection Act and Section 271 and 272 of the BNS. The case was registered on a statement of PPCB Junior Engineer Amanpreet Singh. The PPCB officials stated that it was not clear since when the clandestine activity of garbage dumping had been going on.

The 5 trucks registered under Punjab number have been impounded which were used to transport the garbage from Chandigarh to Palheri village near Mullanpur.

According to the FIR, the

truck drivers and conductors fled the spot, leaving behind their vehicles, after sensing trouble.

Questions are being raised about the Chandigarh Municipal Corporation's inept handling of legacy waste after the issue came to the fore. The MC, which runs a late night drive to catch litterers, could not spot five garbage-laden trucks as these drove from UT to Mullanpur to dump the waste.

Similarly, the UT police has also drawn the flak from environmentalists. The police force, which have installed hundreds of hi-tech cameras on roads to catch traffic violators and issue lakhs of challans every year, could not spot these trucks with tampered, displaced and soiled number plates. "We will not allow outside garbage to be dumped in our area. It is a potential health hazard," said Dr Sunny Ahluwalia the Chairman Punjab Water Supply and Sewerage Board, who reached the spot on Saturday night.

General housing scheme in Sec 53 to steam off by March

CANDIGARH : After nearly a decade, the Chandigarh Housing Board (CHB) has planned to launch the general housing scheme in Sector 53 by March this year. Scrapped several times despite two demand surveys, the CHB will now auction the site for the group housing scheme.

During an interaction with mediapersons, UT Chief Secretary H Rajesh Prasad said the site would be auctioned in a fair and transparent manner and any private developer could participate in the auction.

Spread over nearly 21 acres



in Sector 53, nearly 11 acres have been earmarked for a general housing scheme for employees of the UT Administration.

A demand survey completed in March last year received 7,468 applications for only 732 flats — nearly 20

applicants per unit — indicating a strong demand for CHB housing. Applicants deposited Rs 10,000 for HIG and MIG categories and Rs 5,000 for EWS.

The housing scheme in Sector 53 has been derailed several times for nearly a decade. First proposed in 2018, the scheme received just 178 applications for 492 flats, primarily due to high prices — Rs 1.8 crore for a three-bedroom, Rs 1.5 crore for a two-bedroom and Rs 95 lakh for a one-bedroom unit — forcing the CHB to withdraw the scheme.

The association said while the farm house policy of the state government has been stayed by the NGT, illegal colonisation was being done without impunity.

Devinder Sandhu from the WWICS said the housing society coming out with farm lots had eco-tourism approval from the competent authority.

"Regarding the notices issued by GMADA to property owners who have developed eco-tourism sites for their personal use, the affected persons have filed a contempt petition in the Punjab and Haryana High Court. The matter is being heard by the court," he added.

The GMADA has written to the police for registration of FIR against the World Wide Immigration Consultancy Services, for carving an illegal colony Fair wood Farms and Imperial Golf Greens, Nada (Majri). The District Town Planner has sought registration of the FIR under Punjab Apartment and Property Regulation Act, 1995.

Restore Indian culture to Ariha Shah, discussed Modi with Chancellor Friedrich Merz

NEW DELHI : India had been involved in sustained engagement with the German authorities and believed the Ariha matter should now be approached primarily from a humanitarian perspective, said Misri.

Prime Minister Narendra Modi raised the case of Ariha Shah, an Indian child who has been in German foster care since 2021, during his discussions with German Chancellor Friedrich Merz, Foreign Secretary Vikram Misri said on Monday.

"We have been in discussions with the German government, their embassy in Delhi, and agencies in Berlin for quite some time. This case was, at one point, a legal matter, but we believe it should ultimately be approached keeping in mind the humanitarian



issues involved," Misri said.

He said the government was fully aware of the family's distress and was making every effort to assist them. India was also seeking to ensure that Ariha was raised as far as possible in an Indian cultural environment. Misri said the PM had specifically raised the issue with Merz and that India would continue to follow up with the German government, assuring continued support to the family. Ariha was taken into foster care by German

child protection services in September 2021 and has remained under their custody since. Civil society group Save Ariha Team has said all police cases against the child's parents were closed in February 2022, but Ariha's custody had not been restored. The group has further alleged that there are currently no active legal proceedings related to Ariha's custody, leaving her future uncertain. It has raised concerns over what it describes as the denial of the child's Indian cultural, religious and linguistic identity.

Preserving religious rituals Sissu panchayat bans tourist activities in valley from Jan 20 to Feb 28

KULLU : Sissu village located in the Chandra valley and often bustling with tourists, especially during winter due to easy access through the Atal Tunnel, has witnessed a steady influx of visitors in recent weeks. Despite harsh cold conditions, hundreds of tourists have been reaching Lahaul daily, drawn by snow-covered landscapes and adventure activities. Tourism activities in the scenic Sissu valley of Himachal Pradesh's tribal district of Lahaul-Spiti will remain suspended for 40 days, from January 20 to February 28, in order to preserve the sanctity of traditional religious rituals and age-old customs. The decision has been taken collectively by the Sissu gram panchayat, along with prominent religious and community bodies, reflecting the region's deep-rooted respect for its cultural and spiritual heritage. However, local institutions

felt that the growing tourist presence could disrupt the solemn religious observances scheduled during this period. To ensure uninterrupted worship of local deities and the proper conduct of traditional rituals, a consensus was reached to impose a complete ban on tourism-related activities across the Sissu panchayat area, which was a routine after the tourist influx increased in the area. The decision was unanimously endorsed by the Raja Ghepan Committee, Devi Bhoti Committee, Labrang Gompa Committee, along with Mahila and Yuvak

mandals of the panchayat. During these 40 days, all villages under the Sissu panchayat, including areas around the helipad, will remain closed to tourism. Panchayat president Rajeev said, "The ban covers the entire stretch heading from Pagal Nullah to Ropsang. No tourism-linked operations will be allowed. All forms of adventure tourism will remain strictly prohibited. Activities such as all-terrain vehicle (ATV) riding, hot air ballooning, zip-lining, skiing, bungee jumping and tube sliding have been completely barred during this period." The religious restrictions are primarily linked to important local festivals such as Haldia and Poonha, which require peace, discipline and spiritual focus. According to the panchayat leadership, the presence of tourists and recreational activities during this time could interfere with the observance of divine traditions, often referred to locally as "dev restrictions".

Probe into coal pilferage scam by ED, Mamata Banerjee challenged against 'interference' in SC

NEW DELHI : The Enforcement Directorate alleged that Mamata entered the raid sites and took away "key" evidence, including physical documents and electronic devices from the premises of I-PAC and obstructed and interfered with the investigation into the case.

Accusing

West Bengal Chief Minister Mamata Banerjee and her officials of obstructing a raid at the I-PAC office and premises of its director Pratik Jain in Kolkata during the probe into the coal pilferage scam, the Enforcement Directorate has moved the Supreme Court seeking a CBI probe into the January 8 incident. Her presence at the search site and the alleged removal of documents had an intimidating effect on officers and seriously compromised the probe agency's ability to discharge its statutory functions independently, it alleged. The ED's petition is likely to be mentioned for an urgent hearing on Monday.

Alleging

obstruction and non-cooperation by the state administration, the agency sought directions for an independent inquiry by the CBI, in the Calcutta High Court on



contending that a neutral central agency was necessary in view of the 'interference' by the state executive.

The West Bengal Government has already filed a caveat to preempt any ex parte order against it.

In its caveat filed in the top court, the TMC government requested that no decision should be taken without giving it an opportunity to be heard.

A caveat, filed before a constitutional court, is meant to ensure that no adverse order is passed without hearing the party concerned.

The ED had on January 8 conducted raids on the premises of I-PAC and at the residence of its director Pratik Jain in Kolkata as part of a money-laundering probe into an alleged multi-crore coal pilferage case.

Banerjee and others allegedly caused obstructions during the raid, the ED alleged.

Earlier, both the ED and the West Bengal Government had filed petitions against each other in the Calcutta High Court on

Budget on Feb 1 as scheduled, MP's not to avail holidays, says Speaker

NEW DELHI : The Union Budget for 2026-27 will be presented by Finance Minister Nirmala Sitharaman on February 1, as per established practice, dismissing speculation that the date could be changed as it falls on a Sunday, clarified Om Birla the Lok Sabha Speaker on Monday.

"MPs are public servants, they are meant to serve the people and therefore there is no Sunday or a holiday for them," Birla said at a press conference when asked whether the Budget would be presented on February 1.

He said the Budget Session of Parliament would commence on January 28 and continue till April 2. The Speaker declined to comment on the issue of impeachment proceedings against Justice Yashwant Varma, stating that as the matter was sub judice, no remarks could be made outside the court.



High lighting technological changes in parliamentary functioning, Birla said that greater emphasis

was being placed on AI-based services in Parliament-related work. He added that by 2027, all speeches and debates would be made available in 22 Indian languages on a real-time basis.

Responding to concerns over whether increased reliance on artificial intelligence could lead to reduced human intervention and job losses, Birla said that no permanent appointments had been made in Parliament over the past six years since he assumed office. Instead, he said, existing contractual human resources were being utilised for work, helping save public funds.

7,000 km high-speed rail corridors would be built by 2047: Vaishnav

NEW DELHI : High-speed routes, designed for maximum speeds of up to 350 km per hour and an operating speed of 320 km per hour, will mark a transformative leap in India's rail infrastructure, said the Union railway Minister Ashwini Vaishnav while inaugurating the 16th International Railway Equipment Exhibition (IREE), 2025, at Bharat Mandapam in New Delhi.

Unveiling an ambitious roadmap for the Railways, on Wednesday announced that the government plans to build 7,000 km of dedicated passenger corridors by 2047 under the Viksit Bharat vision.

Vaishnav said the proposed corridors would be powered by indigenously developed signalling systems and modern operations control centres, ensuring both speed and safety.

He also outlined the



government's futuristic vision for Vande Bharat 4.0, Amrit Bharat 4.0, and next-generation railway manufacturing standards. Highlighting the success of the Vande Bharat series, he said the third-generation train already meets global parameters, with acceleration from 0 to 100 kmph in just 52 seconds, faster than many trains in Japan and Europe, while maintaining low noise and vibration levels.

"Vande Bharat 4.0 will be a new benchmark in performance and passenger experience," said Vaishnav, adding that the upcoming

model will focus on superior seats, enhanced toilets, and refined workmanship.

Discussing the Amrit Bharat series, the minister said the 2.0 version is already operational and the 3.0 model, based on push-pull technology, is being developed for long-distance routes. The 4.0 version, he added, will bring in new-generation trainsets and locomotives, expected to be ready for testing within 36 months.

Vaishnav credited Prime Minister Narendra Modi's leadership for what he termed "a decade of modernisation," noting that more than 35,000 km of new rail lines have been laid and 46,000 km of electrification completed in the past 11 years. "Our budget allocation for the Railways has consistently risen, reflecting the government's commitment to a modern, self-reliant network," he said.

"When we want this, it is of course because we have the impression that part of this discussion is based on a misreading of what is what," Rasmussen told reporters, adding, "We believe it makes sense to try to arrange a meeting with our American counterparts in order to clear up some of the misunderstandings that may exist." Earlier, European leaders warned Trump in a joint statement that the terri-

trial integrity of Greenland and Denmark should be respected. Danish Prime Minister Mette Frederiksen on Monday had also warned the Republican leader and said that any US attack on Greenland would mean the end of the NATO alliance and "the security that has been established since the end of the Second World War." Trump has argued that the US needs to control the world's largest island to ensure its own security in the face of rising threats from China and Russia in the Arctic. Secretary of State Marco Rubio told a select group of lawmakers that it was the administration's intention to eventually purchase Greenland – a self-governing territory of Denmark and part of NATO – rather than use military force.

Iran blacks out internet claims "terrorist agents of US and Israel set fires"

Teheran : Iranian State media has accused "terrorist agents" of the U.S. and Israel of setting fires and sparking violence during recent demonstrations. The brief report buried in State TV's 8 a.m. broadcast represented the first official word about the demonstrations. A 'nationwide internet blackout' was reported in Iran on Thursday (January 8, 2026) night amid a fresh wave of escalation in Teheran following a call for mass demonstration by the country's exiled Crown Prince Reza Pahlavi. This comes after twelve days of protests in the country over its ailing economy.

Soleimani statue pulled down, thousands on street, protests intensified

Tehran : Thousands have hit the streets, dozens have died, buildings and statues have been set afire in Iran where tensions surrounding protests against the leadership and dwindling economy saw an overnight escalation to an all-time high on Thursday, prompting authorities to resort to a nationwide internet shutdown.

The protests reportedly intensified after exiled prince Reza Pahlavi's battle cry. The protests in Iran that



started on December 28 have expanded to multiple cities and even capital Tehran. Protesters on Thursday walked through the streets and chanted slogans against Iran's clerical leadership which has been facing a public outrage over the dwindling economy.

Demonstrators were seen repeating slogans against the clerical leadership, including "Pahlavi will return" and "Seyyed Ali will be toppled", in reference to Khamenei. Internet was reportedly shut down across Iran and at least 42 people have been killed since the protests began last month, according to reports. Meanwhile, US President Donald Trump threatened Iran on Thursday and said repeated US would take strong action if Iran kills protesters.

The community water purification plants need to be augmented. The control over expansion of fluorosis need to be endemic, sources revealed. The accessibility to safe drinking water has been eloping with the discharge of untreated chemicals, effluents into the ground water, and depletion not halting for a cause. The multiplying cases of cancer are not being contained duo to the surge in bacterial growth.

Pathogens like bacteria and viruses are being experienced as a very common hazard with the rural public life. Afflicted several health issues might be arthritis, infertility, hypertension, neurotoxicity and increased risk of skeletal cancer, reveals an official.

Additionally prolonged exposure can damage organs like liver, kidneys, lungs and testis. Water contamination has been posing immediate and chronic health threats, needs serious contemplation, medication and panacea.
