WHEREAS, The Mission of First Step Recovery Homes, Inc. is to provide a supervised, temporary, safe drug and alcohol-free structured housing and support services for persons who are recovering from the disease of addiction and trying to stay out of the criminal justice system and

WHEREAS, First Step was founded because they understand it takes more than a rehabilitation center or recovery (drop-in) center to begin recovering from a drug or alcohol addiction. The emphasis is placed on creating a sustainable "recovery community" for each person, where they have the tools, resources, and support to maintain independence, stay clean and sober, fulfill their life's purpose, and reconnect with their loved ones and

WHEREAS, First Step Recovery Home, Inc. has been at the forefront of assisting participants with wrap-around services, including family support, to facilitate healthy households contributing to wholesome communities.
