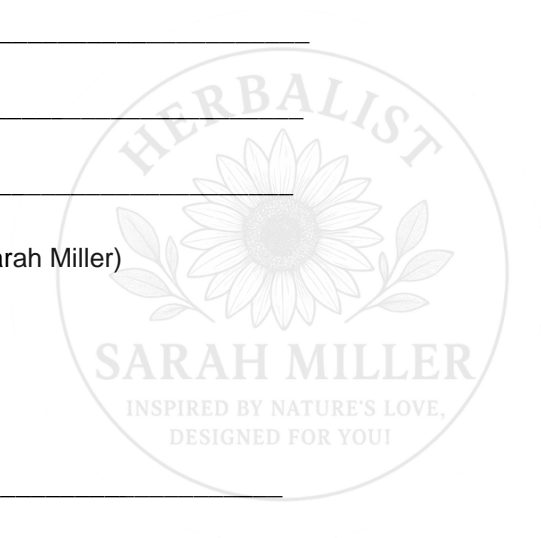

## 4. Confidentiality

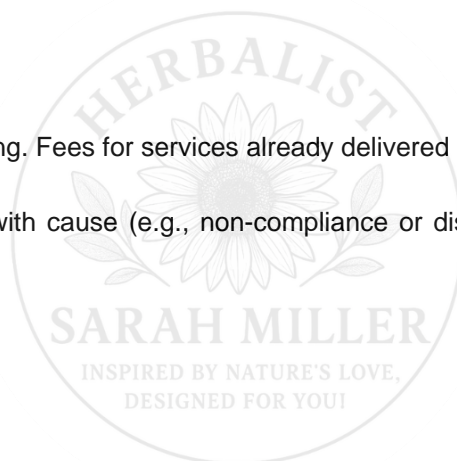

### 10. Consultations & Follow-Ups

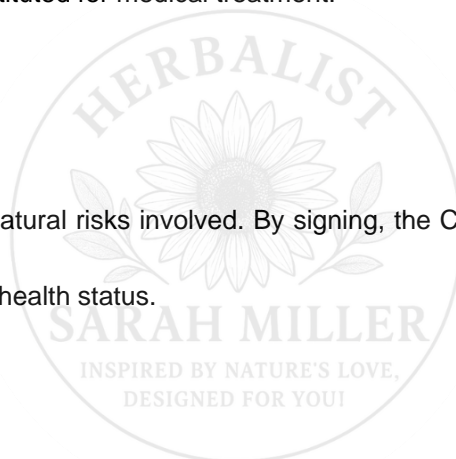
- The initial consultation involves health history, wellness goals, and lifestyle evaluation.
