- Government Affairs- Karla Kelly
 - o 2024 EMS for Children Act passed
 - o 2025 reintroduced HealthCare Provider Act
 - Not passed by legislation- refunding bills, SOAR, mission Zero, SUPPORT- all previously funded and expired in 2024
 - New proposed in 2024 by ENA- improving mental health, prevent bleeding act, support WPV act, Support the safety from violence and healthcare employees act (SAVE)
 - Colorado Nurses Association- HB 24-1066- prevent WPV in Healthcare setting failed.
 Two more introduced this year for WPV and Assault in second degree. HB 25-1227 and SB 25-166
 - O Day on the Hill 4/29-30- 4 COENA members attending
 - Requested meeting with 6 legislators
 - COENA GA committee- local DOTH May 15th in Denver

- Firearm Injury Prevention- gun locks, collaborating with schools and FIPI-LEAD courses
 - We have distributed over 4200-gun lock to EDs across CO
- Cold Water Drowning Signs- collaborating with different lake officials and ENA Foundation to get signs around lakes about cold water drowning awareness
- Nursing Mental Health and Wellness- partner with fundraising committee to sell attire "I am enough"- have sold 46 items and raised \$531.80

 - Monitor instructor scores- May meeting
 - Annual instructors round up- June
 - Update committee documents and policies
 - Grievance policy, instructor monitoring letter, application for mentoring new directors and state faculty, TP-ICER form
 - Trauma and pediatric specific goals from separate subcommittees
 - Getting approval by SEMTAC/CDPHE for TNAC

7. New Business

- Bylaws submitted and need approval from members, reviewed by legal. All attendees except for one are members- quorum met
 - Eric reviewed proposed bylaws- highlighted areas were changes
 - 4 votes
 - Consent agenda
 - 1-36- Name and grammar changes moved in which section it the document but no changes to content
 - No opposing- approved by members
 - 37-45-clarified voting and non-voting members. No changes to document removed names to match national.
 - 38 is a new article but just a functional change.
 - 39 added a deadline as a recommendation from national.
 - 40 section CB angle
 - 41. Notice of meetings and what that requires.
 - 42. Specific vacancies and how they are handled. No changes to process.
 - 43 is a new section.
 - 44 grammatical changes
 - 45 clarifications of bylaws.
 - Approved by Amy. Second by Jacki.
 - No opposing
 - 46- made changes to bylaws. Change to annual meeting date- historically prior to GA for election of officers and bylaws. Would change the meeting to June instead of September. As a corporation you must legally have an annual meeting.
 - No opposing- approved by members
 - 47- currently to make changes to bylaws at state level it has to be approved by national and by Colorado nonprofit attorney to say it's legally bounding in state of Colorado. This change would replace it to be any attorney that can council and not a non-profit to expand the number of people that can help complete this for COENA. Approved at national through governance to give easy and affordable access. It took 3 months to find a non-profit this year and it was much more expensive.
