## **Emergency Gun Violence Summit, Oct. 10, 2024, Baird Center, Milwaukee, WI**

### **About the Summit:**

The Second Annual Emergency Gun Violence Summit will be held in Milwaukee, Wisconsin on October 10, 2024. The summit brings together community members, local and national experts, faith-based leaders, elected officials and more to discuss solutions to gun violence prevention in both urban and rural communities. The summit is organized by Forward Latino and the 80% Coalition.

Topics for this year's workshops and information sessions will include:

- The Facts: Local & national statistics and trends related to gun violence
- The impact of gun violence on individuals, families, and communities
- Community intervention strategies for preventing gun violence
- The role of law enforcement and the justice system in preventing gun violence
- Faith-based approaches to addressing violence before it occurs
- Gun violence from a healthcare perspective
- Gun violence and mental health
- Generation Lockdown: Gun violence in our schools and the trauma it creates and more.

In addition, this year's summit will feature a student workshop tract developed specifically for high school students.

#### **About the 80% Coalition:**

The 80% Coalition is a non-partisan organization comprised of advocacy, business, education, faith-based, professional and service organizations committed to the passage of commonsense gun violence prevention legislation.

The 80% Coalition legislative priorities include:

- Closing background check loopholes that allow violent felons to purchase firearms online, at gun shows or in person from private sellers.
- Allowing Extreme Risk Protection Orders (ERPOs), otherwise known as "red flag laws." ERPOs allow a family member or law enforcement officer to petition a court to remove a firearm from an individual they believe to be imminent threat to themselves or others, and grants the the court authority to temporarily remove the firearm, only after due process, and if the threat is confirmed by the court.
