



OAK COVID-19 Prevention Policy (Reviewed monthly by OAK Medical Team)

Oncology And Kids policy outlining our hyper prevention approach to reduce the spread of infection and allow for more rapid identification of COVID-19 cases.

These policies were developed with the OAK Medical Team, OAK Advisory Council, OAK Board of Directors, by referencing the current [CDC Guidelines for Summer and Youth Camps](#), the current [Occupational Safety and Health Administration guidelines for Control and Prevention](#), and the guidelines currently in place from of the [California Department of Education](#).

VACCINATIONS:

OAK requires proof of *all Staff and Volunteers ages 16 and older* to be fully vaccinated (2 Moderna or 2 Pfizer shots, including 1 booster if eligible) for in-person participation of all OAK programs and events, including but not limited to Camp Reach for the Sky (CR4TS).

Although it is highly recommended, OAK currently *DOES NOT* require the *camper population of 17 years old and under* to receive the full vaccination.

VACCINATION EXEMPTIONS:

Vaccination exemptions for Staff and Volunteers to attend any OAK program in person must be documented and approved by the OAK Medical Team as well as the OAK Leadership Team a minimum of 20 days prior to the first day of the registered session. All proposed vaccination exemptions must be documented by the Staff and Volunteers' authorized physician.

PARTICIPANT SCREENING:

The immune status and risk factors for campers and their families will be taken into consideration when implementing the screening procedures. At a minimum, a camper, staff, or volunteer (hereafter, designated as "**Participant**") who has a temperature of 100.0° Fahrenheit or above, or other signs of illness, will not be allowed to attend in person OAK programs and events, including but not limited to CR4TS.

OAK Medical Team and CR4TS Leadership will record answers to the questions below. The screening will be documented and signed off by the designated OAK Medical Team.

1. Have you had a fever of 100.0° Fahrenheit or above in the last 10 days?
2. Have you recently experienced coughing or shortness of breath?
3. Have you recently experienced a loss of taste or smell?

4. Have you been exposed to anyone who has had a positive or pending COVID-19 test in the last 10 days?
5. Have you been out of the country in the last 10 days?
6. Final Step in the OAK Participant Screenings: Participants who have answered “**YES**” to any of the five screening questions above, will then be subject to a Rapid Covid-19 test prior to loading the bus (ROC+SIB) or entering the campground at DAY Camp.

DAY Camp Session:

Participants are screened prior to entering the CR4TS designated area each morning. OAK Medical Team and CR4TS Leadership will record answers to the questions above, along with a temperature for each Participant, prior to allowing Campers into the CR4TS designated areas.

** Participants will **ONLY** be subject to a Rapid Covid-19 test if they are showing symptoms throughout the week of camp.

Resident Oncology Camp and Sibling Camp Sessions:

Participants are fully screened on the first day of camp prior to bus check in. All 6 Covid Screening points listed above will be addressed with the Participant prior to leaving the vehicle they arrived to bus pick up in. ROC+SIB Campers will also be screened on Wednesday of camp.

** Participants will **ONLY** be subject to a Rapid Covid-19 test if they are showing symptoms throughout the week of camp.

Teen Weekend, Family Camp, and RYANSTRONG Camp Sessions:

Participants are fully screened on the first day of camp prior to bus check in. All 6 Covid Screening points listed above will be addressed with the Participant prior to leaving the vehicle they arrived in. The weekend duration camps will feature full screening for Participants on arrival and the morning of the second day.

** Participants will **ONLY** be subject to a Rapid Covid-19 test if they are showing symptoms throughout the week of camp.

VISITORS AND SHORT-TERM VOLUNTEERS:

Visitors and Short Term Volunteers will be permitted during CR4TS sessions. All visitors will be subject to screening prior to entering CR4TS.

FACE MASKS:

Once a Participant has tested negative, mask wearing will become optional for all full time Participants.

SOCIAL DISTANCING:

Bunks and sleeping arrangements will adhere to a minimum distance of 6 feet (head to toe policy remaining). Participants will no longer be required to socially distance themselves from each other throughout the duration of CR4TS.

CLEANING AND DISINFECTING:

Disinfection squad will wear disposable gloves and approved personal protection equipment (PPE) while performing all sanitization procedures, including handling of trash. All Participants will be expected to wash their hands thoroughly and often, including immediately after removing gloves and/or after performing all sanitization procedures.

- Only latex free gloves are allowed at CR4TS.
- Additional PPE may be required based on disinfection products being used. The Risk of splashing, or in response to potential biohazards.
- Removal of gloves should be done carefully to avoid contamination of the wearer and the surrounding areas.
- Reusable clothing or cleaning materials should be laundered after each use.

OAK will provide EPA-registered household disinfectants proven effective. Disinfection squad will only use the disinfection products as instructed on the label or provided during their training by the authorized OAK Leadership Team.

WASHING HANDS AND DISINFECTING:

Hand sanitizing stations and additional signage will be placed throughout all OAK programs and activity areas. All buildings will be sanitized prior to the arrival of Participants. Participants who are counselors will also be trained to be on the lookout for areas that need housekeeping over the course of the session.

Areas prone to high use or touch, such as bathrooms, doors, light switches, faucets, counters, tables, will be disinfected multiple times daily and after each scheduled use. The OAK Leadership and Medical team will be the primary “disinfection squad” responsible for constant maintenance of the areas around camp. *Whenever possible we encourage Participants to return to their assigned cabins to use the restroom, thus minimizing their exposure to viruses that could be transferred through public restroom use. Participants will notify the disinfection squad if there is a bathroom or other location that needs immediate sanitizing attention.

GENERAL EXPECTATIONS AND REQUIREMENTS:

Staff-

- Masks are no longer mandatory once a negative test has been verified
- Social distancing is no longer part of the OAK Covid prevention policy throughout the daytime hours of operation. Socially distancing will continue to be enforced during bunk times as all Participants will sleep at least 6 feet apart, head to toe.
- OAK Volunteers will not be permitted to leave the campsite during the duration of the camp week. If a member of the Site staff (Camp Stevens, Camp Cedar Glen) displays any symptoms mentioned in the screening, we will ask that they take a rapid test before resuming work with CR4TS Participants.

Campers and Families-

- Mask wearing will no longer be required and is fully optional.
- Family Camp Participants are encouraged to sleep only within their designated family spaces.

- Participants are responsible for adhering to all points of the COVID-19 Prevention Policy.

Programs and Activities-

- Masks will no longer be required for full time Participants and instead is fully optional.
- All Participants must hand wash before and after use in all program and activity areas.
- Disinfection squad will sanitize all used equipment prior to each use.
- Program staff will be the only authorized Participant to gather or replace materials needed for a program or activity.
- Counselors and all volunteers will be encouraged to frequent cleaning and disinfecting of all common supplies and equipment used for that session prior to each use.
- Common supplies or equipment will be placed in a designated area after each program session for cleaning.
- Counselors and volunteers will disinfect all tables and areas of use before and after each session.

COVID-19 Prevention Policy was designed to lower the chances of this virus impacting Camp Reach for the Sky and OAK programs and events. With our immunocompromised population, we hope that all Participants can recognize the need to be vigilant.
