RESIDENT ONCOLOGY CAMP PROVIDES A SAFE AND NURTURING ENVIRONMENT FOR CHILDREN BETWEEN THE AGES OF 8 AND 17, BATTLING CANCER TO EXPERIENCE THE JOYS OF CHILDHOOD. WE OFFERED A WEEK-LONG RESIDENTIAL CAMP WHERE YOUNG PATIENTS COULD PARTICIPATE IN VARIOUS ACTIVITIES TAILORED TO THEIR MEDICAL NEEDS AND ABILITIES.
