RESIDENT ONCOLOGY CAMP PROVIDES A SAFE AND NURTURING ENVIRONMENT FOR CHILDREN BETWEEN THE AGES OF 8 AND 17, BATTLING CANCER TO EXPERIENCE THE JOYS OF CHILDHOOD.
