Michael Gale reported for the Fire Department. In January there were 19 EMS calls, 1 Hazmat and 8 others for a total of 28 calls. He and the Fire Marshal attended a Groton Fire Officer Meeting on January 25. On January 19, Plymovent performed the annual maintenance on the apparatus exhaust system. On January 20, Densmore came on a service call and performed the annual maintenance. On January 20, the sprinkler was tested.

Charlie Chaffee reported for the Fire Marshal's office. The monthly inspections were performed. He has been taking EMS training on-line. There is an issue with the heat detector in the boiler room. He will get a fire alarm company to come and repair. He reported new code books are required. He will order. Chief Gale was appointed Deputy Fire Marshal.

Russ Fowler reported for the Water Company. The chlorine numbers at 205 Elm Street have been rising. They will flush every two weeks. Frank and Russ have been creating a list of the 3" lines. There is a meeting scheduled for the lead and copper evaluation. They got a call about MRH water leak. They checked it out and it was groundwater. There was a break in the 3" pipe on Potter Court. There were 3 CBYD calls. Russ requested he, Frank, and Ted Rathjen go to an AWWA day of classes at \$140 per person. It was agreed they should go.
