April 2023: From the Pastor's Heart

Whose Fault Is It?

Congratulations! You have successfully made it through Lent, keeping your promises to God! I know from experience that keeping Lenten vows is not always easy but I also know from experience what a great feeling it is to find yourself having been faithful to God. Being faithful to God is what its all about. If we can be faithful in keeping our Lenten vows, we know deep down in our hearts that we can be faithful to God in all aspects of our lives. That is, if we really want to and commit ourselves to doing it, provided, yes provided, one extremely important thing, PRAYER. Admit it with me. We prayed for God's help, and He answered our prayers. Admit it with me, the only reason we were able to keep our Lenten vows was that God helped us in our weakest moments. The lesson I see, I hope you see it too, is this: We commit ourselves to prayer, we can be more faithful to God in all aspects of lives, all of the time not just Lent. Amen!

As we celebrate the Resurrection of our Lord and Savior Jesus Christ and reflect on his Crucifixion and Passion, the personality of Pontius Pilate the Roman Governor of Judea draws me into some serious self-reflection. Let me set the stage.

Remember Judea, including the city of Jerusalem, was under the control of the Roman Empire. While the Chief Priest and the Sanhedrin Council were the local civic leaders of the Jewish people, they themselves had to answer to the Roman Governor, who was appointed by the Emperor of the Roman Empire. As you might imagine, there were times when the Roman Governor and the Chief Priest and the Sanhedrin council were at odds with each other. The Chief Priest and the Sanhedrin had the power of influence over the Jewish people. They could gather crowds and inspire demonstrations, protests, riots, and rebellions which were not acceptable to the Roman Emperor, therefore jeopardizing the Governor's position. On the other hand, the Governor had control over the local branch of the Roman Army and could use legalized-violence to force his/her will upon the Jewish people. While the Chief Priest and the Sanhedrin Council desperately wanted to kill Jesus, they did not have the power to do so. They needed the Roman Governor, Pontius Pilate to issue the order to execute Jesus. This is why they bring Jesus to Pilate and falsely accuse him of plotting insurrection and rebellion against Rome as an earthly king. Pilate is forced into a very uncomfortable situation. He receives a spiritual a warning not to harm Jesus from his wife. He recognizes that the Chief Priest and the Sanhedrin council do not have a valid reason for executing Jesus. But he does not want them complaining to the Emperor or starting a rebellion. What would you do if you were in Pilate's situation?

Life or death is in your hands. Your decision will determine whether a person lives or dies. What would you do? Pilate recognizes that his decision about whether Jesus should be released or crucified will affect his personal future. He knows in his heart of hearts that Jesus is innocent of all wrong but he also knows the Chief Priest and the Sanhedrin council want Jesus dead and if he does not give them what they want they will go work to have him removed from his office. Pilate does not want to lose his comfortable position of power and wealth.

Here's how Pilot dealt with his dilemma. Matthew 27:24 (NRSV) "So when Pilate saw that he could do nothing, but rather that a riot was beginning, he took some water and washed his hands before the crowd, saying, "I am innocent of this man's blood; see to it yourselves." Pilate washes his hands before the people and declares he is innocent of Jesus' Blood even though he gives the Chief Priest and the Sanhedrin Council permission to crucify Jesus.

Tell me, do you think this act of washing his hands makes Pilate innocent of the blood of Jesus Christ? Pilate communicates his awareness of this injustice by washing his hands, but does this symbolic act make Pilate any less guilty? Remember Pilate never drove a nail into Jesus' hands or feet. Pilate never hit Jesus with a whip. Pilate is not the one who pressed a crown of thorns into Jesus' head. Pilate was not present on Golgotha's hill when Jesus was crucified and died. Is he innocent or is he guilty?

How are we to understand responsibility, then and now? Is it the acts we do or do not do with our hands and bodies? Does responsibility include using or not using our influence and/ or power to help something happen or to stop something from happening? Can we, in our own ways, simply wash our hands and declare our innocence for the events and actions of some people that result in the death, diminishment, and suffering of other people? When are people and events too far away for us have any influence or provide help? When are people or events close enough for us to accept any responsibility?

Clearly, the answers are personal, as it was for Pilate. However, we must remember that we will have to answer to God for the consequences of our personal choices. Legend has it that Pilate committed suicide. I imagine him constantly washing invisible blood from his hands.

May your reflections on this season lead you to peace.

Being Lax

The most lasting legacy of the Covid epidemic may not be the new ways people can show up, important as those are. The most lasting legacy may be new ways of thinking about when and whether to show up. For congregations, the era of attracting people by low expectations may have come to a belated end.

Covid broke the habit of attendance for a lot of people. Some will come back, but many have found other ways to spend their time. Congregational leaders are wondering, "When will they come back? How can we get people to return"? Worship attendance reached a high of nearly 50% during the 1950s, with affiliation estimates ranging up to 70%. Many people then felt pressured to find a congregation, join it, and attend. Cultural controversies were often cast in religious terms Catholic vs. Protestant, liberal vs. Evangelical, Christian vs. non-Christian.

Meanwhile, congregations began to advertise themselves as strict or lax. Strict congregations emphasized distinctive doctrines and behavior rules. Lax ones opened their arms wide, demanding little and requiring only general principles or notions. For a while, the lack of rules and expectations was a powerful driver of lax congregations' growth.

But in our time laxness has begun to lose its favor. Non-affiliation is an accepted option, and so people are no longer relieved to learn that they can have the respectability of congregation membership without the inconvenience of examining their lifestyles or beliefs. Why join a congregation when you can believe and act as you wish at home?

Both poles of the strict-lax spectrum appear in every congregation. In part, this happens because "openness" is not enough. A faith community needs to stand for something, and if it does, it will stand also against some other things. It may welcome everyone, but if its values are apparent, it will repel some and attract others. Those values may be religious doctrines or political positions or moral stances. If they amount to more than platitudes, they signal that while all are welcome, some do not belong.

Many congregations fear to choose a spiritual center because someone might feel left out. Ironically, such congregations exclude almost everyone. Some people know this and will advocate perhaps only from the margin for centering community more firmly.

"All are welcome here" which also sounds so easy means you have to learn to welcome people who are different from you and me. This teaching pointed into what, for me, has been a long learning process about difference. My assumptions about what "everybody" has in common has been challenged over and over by people who have taught me just a little about what it means to be female, Black, Indigenous, sexual orientation, disability, and faith.

The Covid pandemic has hastened the race toward laxness to its end. Some congregations will return to the old strict requirements and expectations. Others will invite people into a new covenant, strong communities of expectation based not on oppressive social pressure but on voluntary choice.



In addition to running medical clinics, we plan to build some playground equipment and teach the older students how to make a quilt. Team members hail from SC, NC and WV and include Lynn Rhyne from St. Paul's.
- We need donations of: sanitary pads, Bible story coloring books, 12 count boxes of crayons, toothbrushes, toothpaste, knit caps and reading glasses sixed for adults and others for kids. You can leave your donations in a bag for Lynn Rhyne at the church.
- Step 1 of the next phase involves adding 2 bathrooms (construction costs) and repurposing rooms.
- Step 2 will be to complete the security fence along the one side of the property.
- Step 3 will be putting a new pump in the well so it can be used for watering the garden to grow vegetables to feed the school and their families.
- I appreciate you all and so do our children. Dad would have been delighted to see this property taking shape.



St. Paul's Lutheran Church CEMETERY POLICY STATEMENTS Revised November 9, 2022

Statement of Purpose:

- The purpose of St. Paul's Lutheran Church cemetery is to provide a burial place of perpetual care for its members.
- The cemetery is a congregational cemetery and under no circumstances shall St. Paul's Cemetery be considered a public cemetery. Nor shall any plots be considered as being for sale or sold. All plots remain the property of St. Paul's Lutheran Church and are under the care and supervision of the Cemetery Committee and the Congregation Council.

I. ELIGIBILITY

Members of St. Paul's:

- 1. Each *active member of St. Paul's shall be guaranteed a grave plot at no cost. Plots shall be selected in the area designated by the Cemetery Committee at the time of death.
- *Active member as defined by St. Paul's Lutheran Church Constitution Chapter 8.Membership C8.02 (c)... Voting members are confirmed members. Such confirmed members, during the current or preceding calendar year, shall have communed in this congregation and shall have made a contribution of record to this congregation. Members of this congregation who have satisfied these basic standards shall have the privilege of voice and vote at every regular and special meeting of the congregation as well as the other rights and privileges ascribed to voting members by the provisions of this constitution and its bylaws.

Former Members and Extended Families of St. Paul's:

- 1. **Former/Inactive members** and extended family members with a pre-assigned family burial plot a contribution of \$500.00 is expected at the time of death.
- 2. The Cemetery Committee and the Congregation Council shall not be expected to approve requests for grave plots for a non-member other than those noted above.
- 3. Plots are available at no cost to former pastors of St. Paul's and their spouses. Plots are also available to sons or daughters of St. Paul's and their spouses who are in or have been in the full-time ministry of the church.

II. CEMETERY POLICY

- 1. All requests for plots and/or questions relating to the cemetery shall be directed to the Cemetery Committee in writing.
- 2. No grave shall be opened without first contacting the church office and the church office will contact a representative of the cemetery committee.
- 3. All contributions for grave sites shall be sent to the church and placed into the Cemetery Fund Line Item.

III. OPENING OF THE GRAVE AND SETTING MARKERS

- 1. An acceptable grave liner is required in each grave and cremation site.
- 2. Proper precaution shall be taken in opening graves especially in cases where drilling and blasting may be necessary. Any resulting damage to existing monuments or church property shall be the responsibility of those opening the grave and the funeral director in charge.
- 3. Removal of all excess dirt (and rock) to a designated area on church property shall be the responsibility of the funeral director.
- 4. Fill dirt shall be properly tamped and sod replaced on grave sites.
- 5. If it is necessary to remove a stone already in place in order to open a grave, the old stone shall be properly replaced.
- 6. No grave markers (monuments) shall be set without prior arrangements with the **CEMETERY COMMITTEE**. All headstones shall be set on a base no less than 4 inches thick. All footstones should be ground level.
- 7. Monument markers shall not exceed the width of the grave plots and shall be located at the head of the grave.
- 8. Only flat surface markers are permitted in the new sections of the cemetery.
- 9. Graves/Cremation Sites should be permanently marked as soon as practical after burial.

GENERAL ITEMS:

- 1. Borders of any kind shall NOT be installed around any plot or grave site. There shall be no curbing, sand, gravel, or concrete placed around any grave.
- 2. No shrubbery or growing plants other than grass shall be planted on any plot.
- 3. Grave sites (plots) in the new section of St. Paul's cemetery will be laid off in east-west direction. Head markers at the west end of the plot.
- 4. All broken and used flower vases (except those designed into or to fit the grave marker), all faded, dried, or generally unsightly flowers (live or artificial) shall be removed by the family of the deceased; otherwise, the Cemetery Committee shall have the right to authorize their removal.
- 5. All vehicles shall drive only in designated driveways.
- ⇒ If conditions arise not listed in the Cemetery Policy, the Cemetery Committee will address these issues accordingly.
