LAO REPORT

YCM has identified a number of proposed legislative actions that may be of interest to boaters. Those are:

<u>HB0719</u> - Natural Resources - State Boat Act – Alterations – This is the bill with most impact on boaters. You may recall a bill last year that would have significantly raised boat registration fees with much higher rates on larger vessels. YCM provided testimony in opposition to that bill and it didn't pass. We opposed a fee structure based on boat length. In our testimony last year, we clearly stated that the registration fee hasn't increased in decades and the Department of Natural Resources (DNR) should be able to increase the fees so long as the increase was used only for DNR purposes and for waterway improvements. It looks like our message was heard. This year DNR is just asking for an increase to a single rate of \$70 every two years regardless of the size of the boat. Documented vessels will also pay \$70 to get stickers. Because we feel that DNR does need an increase, the YCM Board has voted to provide testimony in favor of HB 0719. A hearing is scheduled for February 19 at 1 pm on HB 0719.

<u>SB0168</u> - Environmental Justice in Confined Aquatic Disposal Act – An expanded large container channel and terminal is being developed at Sparrows Point. To accomplish this, the Port must find places to dump the dredge material that will be removed to create this terminal. One of the options the Port is considering is to dig a huge trench east of the Key Bridge site and on the south side of the Patapsco. They would then place some of the Sparrows Point dredge spoils in that trench. This activity is called Confined Aquatic Disposal (CAD). Clearly, the residents and boaters near this part of the Patapsco have been rigorously opposed to this CAD proposal as they already live with an overabundance of industrial neighbors in their community. YCM Board member Carl Treff has been very active in opposing CAD and recently testified in support of this bill that would ban the use of CAD in communities already overburdened with industry. You may recall the article Mr. Treff posted in a recent Bay Breeze. There was overwhelming testimony in favor of this bill.

<u>SB0103</u> - Boating Accidents – Reporting Requirement – Property Damage and <u>SB 0123</u> -Boating Accidents – Duty to Remain at the Scene, Render Assistance, and Provide Information – Penalties – The titles of these bills are self-explanatory. Nothing seems controversial about these proposals.

<u>SB0562</u> - State Designations – State Cocktail – Original Maryland Orange Crush – This is my favorite. The bill says the orange crush cocktail originated in 1995 at the Harborside Bar and Grill in Ocean City, Maryland and this bill would make it the state cocktail. Many boaters will agree.

As the Maryland legislative session continues, we'll keep you posted on these bills.

Yacht Clubs of Maryland Bay Breeze Protocol Matters



Yacht Club Uniforms

Many of the yacht club protocols and traditions that have carried on for generations started in the 19th century when amateur sailors became increasingly common. The traditions we see at our clubs today began when people who had the means could go onto the water for recreational purposes and, increasingly, wanted the challenge and responsibility of captaining their own boats. A nickname at the time for young adventurous people was "Corinthians", which greatly appealed to the "gentleman sailors" of the era who had the temerity to captain their own boats.

Clubs dedicated to yachting formed. These clubs included as part of their purposes and bylaws, dedication by all members to the highest standards of vessel navigation and operation. Those focused on membership by owner captains and often had "Corinthian" in the name of the club, a name often seen among yacht clubs today. Consequently, traditions and rules were created to symbolize dedication to being mariners in every sense, paid professional or not.

A major tradition that has carried on from the early days of yacht clubs is the wearing of uniforms. As I have noted in other columns, the traditional yacht club uniforms are the same mariner uniforms still used throughout the world in navies and all other forms of nautical enterprise. The only substantive differences among most of the world's navy, mariner, and yachting uniforms are insignia, trim, and braiding.

By tradition, all members of a yacht club may wear a traditional uniform and/or one prescribed in the club bylaws or rules. Insignia, braid, trim, and pins on the uniform change with the member status and history in the yachting community. A basic member outfit normally would be a plain nautical uniform with only a member name tag. Most yacht club members in modern times obtain uniforms when they serve in an office or serve as Board Members. Their uniforms symbolize dedication to yachting ideals, pride in your club, and commitment of service to your club. Officials are easily identified by the insignia and badges worn.

Most clubs have rules governing uniform wear as decided appropriate for their club, so what you see with one club may not apply to another. All clubs honor and respect the unforms of other clubs and yachting associations, so it is normal to see different uniforms at a multi-club event.

Yacht club uniforms are worn either in an official capacity or in a private capacity. In a private capacity, the decision to wear a uniform (or not) rests with the person, male or female, entitled to wear it as a member or officer of a club or as a person holding a title earned by service to a club or presented by a club. The most common example of private capacity is Past Commodore, which is not a club office, but is a personal title earned by successful completion of service to a club. Once earned, this title is kept for life, is recognized by all yacht clubs and yachting organizations, and entitles the holder to wear a uniform with the appropriate insignia.

Official capacity includes serving in office and representing a specific club or organization for a ceremonial or business purpose. It does not include merely attending an event or meeting. When wearing a uniform in an official capacity, a person follows the uniform rules of the club for which they are acting.


