### Legislative Affairs Officer's Report

The Maryland General Assembly is under way, and it is "wait and see" what decisions they will make that will impact Maryland's hard-working citizens.

The Maryland Department of Natural Resources (DNR) will plant about 147 million oysters spat, or juvenile oysters, on forty-one acres in Anne Arundel County waters with mitigation funds from the 2022 grounding of M/V Ever Forward on an upper Chesapeake Bay oyster bar.

On March 13, 2022, the 1,095-foot Ever Forward container ship ran aground inside Natural Oyster Bar 4-2. The bow of the ship, which draws forty feet of water, became stuck at a depth of eighteen feet. The Ever Forward was refloated on April 17, 2022, after a month of intensive dredging and multiple extraction attempts.

Last year, the state required the ship's owner, Evergreen Marine Corporation, to pay DNR \$676,200 to fund oyster bar seeding mitigate the event's impacts. DNR has now selected the first area that it will target with this funding.

The grounding impacted about fourteen acres of Chesapeake Bay bottom, including 11.5 acres within the boundary of a natural oyster bar, according to the Maryland Board of Public Works. A <u>U.S. Coast Guard report</u> later determined that negligence on the Ever Forward contributed to the grounding.

In other news, for you oyster lovers, the Maryland fall oyster survey finds juvenile oysters, or spat, are thriving throughout the Bay—including in several areas where they have rarely been seen in 40 years.

Both the number of spat and the widespread distribution of them throughout Bay waters are particularly encouraging, according to the Maryland Department of Natural Resources (DNR). The survey results were announced at DNR's Jan. 9 <u>Oyster Advisory Commission</u> meeting.

The <u>Fall Oyster Survey</u> determines the year's the spatfall intensity index, which measures oysters' reproductive success and their potential for population growth. This year's index was 86.8 spat per bushel, four times the 39-year median index of 23.6. This year's index is the fifth highest in all 39 years.

It is good news for the Bay environment, since oysters provide food for animals, oysters are natural water filters, and their reefs provide habitat for marine life. It is also good news for watermen and the entire Bay seafood industry.





Last month, the U.S. Department of Commerce notified Maryland Gov. Wes Moore that it has declined Maryland's request for a federal commercial fisheries disaster declaration that was sought to help address the economic and ecological damage caused by the spread of invasive catfish and snakeheads in the Chesapeake Bay watershed.

Maryland made the unique request in March as a way to highlight and mitigate the harm that invasive Chesapeake blue catfish, flathead catfish, and snakehead have on economically important Bay species such as blue crabs and menhaden, which the invasives eat. Under federal law, fishery disaster requests can be granted after a state experiences a large, sudden, and unexpected decrease in fish stock that causes a significant loss in a commercial fishery. Commerce ruled that blue catfish have not had sufficient impact on commercial fishery revenues to qualify for fisheries disaster aid.

In the letter notifying Maryland of its decision, U.S. Commerce Secretary Gina Raimondo wrote that NOAA Fisheries recognizes the challenges invasive species have created in the Bay ecosystem and offered to discuss potential opportunities in the future with Maryland.

"We're disappointed in the decision, but also understand the ruling due to the limits of federal law surrounding fisheries disasters," said Maryland Department of Natural Resources Secretary Josh Kurtz. "We will continue to work with our federal partners to determine what form of federal assistance can help us mitigate the continued and pervasive spread of blue catfish and other invasive species impacting commercial fisheries in the Bay. However, this was just one of several efforts underway to tackle this issue. Maryland is taking proactive steps on its own to limit the spread of blue catfish and other invasive species."

In November, the Department of Natural Resources (DNR) hired a dedicated program manager to coordinate strategies across agencies and industries to reduce populations of invasive fish in Maryland.

Maryland has no fishing limits on invasive fish, which means anglers can catch and keep any number of them, at any size, during any time of year.

At the same time, Maryland's Department of Agriculture (MDA) is ramping up marketing efforts to promote wild-caught Chesapeake blue catfish to chefs, consumers, restaurants, grocery stores and distributors to encourage more people to buy, eat, and sell wild-caught Chesapeake blue catfish. The marketing and promotional campaign activities currently focus on media appearances, social media posts, and roadside billboards highlighting the culinary versatility of blue catfish and how eating more of the fish is an important way we can all help watermen, local businesses, and the health of the Bay. MDA also collaborates closely with chefs to attend various events throughout the state to provide demonstrations and samplings of wild-caught Chesapeake blue catfish.





Blue catfish were first introduced in Virginia in the 1970s as a target for recreational fishing. The catfish are native to the Mississippi, Missouri, Ohio, and Rio Grande River basins. Against expectations, the catfish expanded out of freshwater and into the higher salinity waters of the Bay, and from there <u>began to spread into other rivers</u> and tributaries in Maryland and Virginia. Blue catfish populations grow rapidly, and studies have found the invasive catfish making up <u>75% of the total biomass of fish</u> in a Virginia river

Blue catfish are voracious eaters and have been <u>documented as preying on blue crabs</u>, <u>menhaden</u>, <u>white perch and other species</u>. They out-compete the native species for habitat space and food and pose a threat to key commercial fisheries including blue crab, striped bass, white perch, yellow perch, and American eel.

Flathead catfish and snakehead are also known to prey on and out-compete native species. With few natural predators, these fish can spread quickly through Maryland waters.

Protocol Matters by Joe Hellner

Something that comes up a lot this time of year is what to do about late cancellations when it is too late to adjust the count with the caterer. Consistent with what most clubs do in these circumstances, for late cancellations and no shows that are not caused by extenuating circumstances (emergency, auto accident, etc.), the person who committed to attending the event must pay the host for expenses incurred because of late cancellation or failure to show.

Host clubs must immediately attempt to get expenses owed by contacting the no shows directly. All of us who put on events know that this is a serious obligation because a host club can take a financial beating if people make reservations and do not show. The host club may choose to waive the expenses, particularly when there are extenuating circumstances, but the decision is always up to them and not the no shows.

If you do not show up for an event for which you made a reservation, think of your own club and how it would be affected when folks with reservations do not show.

If a visiting club member fails to pay a host club or business, their home club must act because failure of a member to pay debts reflects badly on the home club and its members, embarrasses them to other clubs and to boating friends, and hurts the home club's goodwill relationship with a business or club. For those reasons, Commodores and Boards need to ensure all debts that could reflect badly on the club or its members, be settled even if the club ends up paying. It is then up to the club what to do about the member(s) who did not pay.
