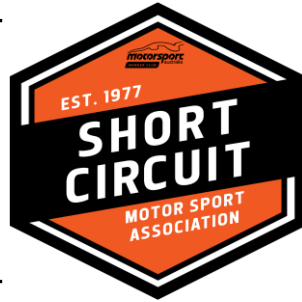

Dear Competitors and Members

It is with great regret that the committee must inform you that the upcoming Round 2 SCMSA event on Saturday 17th and Sunday 18th May 2025 cannot proceed.

During Round 1, an incident occurred with a falling branch that resulted in damage to a vehicle. The association self-reported this to WorkSafe Qld, rectifications and procedural improvements were made in accordance with WorkSafe Qld direction, and full written clearance was given. Despite this, the complainant has exercised their right to ask for further investigation from WorkSafe Qld.

As a result, further investigation by WorkSafe Qld and Southern Downs Regional Council was conducted on Tuesday 6th May 2025. This further escalation resulted in an inspection of the whole Carnell Raceway facility as well as closer scrutiny of the proposed lease.

Yesterday 8th May 2025, we formally received several improvement notices that require further action. The scope of these actions, further discussions required with the regulatory bodies, and timeframe to undertake them means that the site must be closed at this time.

We are unable to propose a new a date at this stage until the situation is resolved and the site is cleared by WorkSafe Qld.

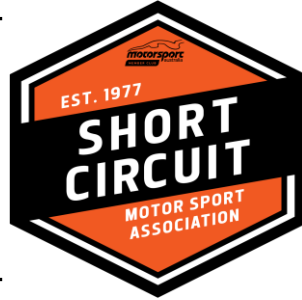
