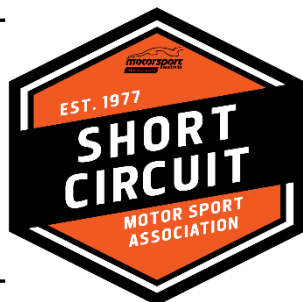

- Nominations must be submitted to secretary@scmsa.com.au by 11:59 PM on Saturday, 8 March 2025.
- A list of candidates will be published to the members 7 days prior to the AGM.

Nomination Process Summary (Aligned with Constitution):

1. **Eligibility:** Nominees, proposers, and seconders must be financial members of the association before submitting nominations and hold a Motorsport Australia Competition Licence.
2. **Nomination Submission:** Nominations must be lodged in writing to secretary@scmsa.com.au at least 14 days before the AGM (by 8 March 2025).
3. **Proposer and Secunder:** Any two members of the association can nominate another member, and each nomination must be signed by both a proposer and a seconder.
4. **Publication of Nominations:** A list of all nominees will be published on the website and emailed at least 7 days before the AGM.
5. **Elections at AGM:** The election of the committee members will take place at the AGM. Balloting may occur if needed, with each member entitled to vote for as many candidates as there are vacancies.
6. **Casual Vacancies:** If any positions are not filled during the AGM, the committee can appoint members to fill those positions until the next AGM.
