SCMSA TOURING CAR COMPETITION NUMBER and/or LOG BOOK APPLICATION

To be completed Short Circuit Touring Car Competitors only

All Short Circuit Touring Car competition numbers are declared vacant on the 1st December each year.

During December and January current number holders who wish to retain their existing numbers must re-apply for their number. Any number not applied for by the 1st of February will be declared vacant and will be allocated to the first person who applies for that number. To compete in Short Circuit Touring car events:-

1. Competitors and Entrants must be a current member of the **Short Circuit Motorsport Association** or a **SCMSA affiliated Club**. (If you wish to become a member of the SCMSA complete and return a SCMSA Membership Application Form) Those who become members of the SCMSA can pay the \$20.00 SC Fee as part of their application. Those who are members of an affiliated Club only will need to pay the \$20.00 fee.
2. Competitors are required to apply for a competition number (**using this form**) prior to competing and pay the \$20.00 Short Circuit fee.
3. The competition vehicle **must either have a Motor Sport Australia Log Book or a SCMSA Log Book**. A SCMSA Log Book is issued on application for the car you wish to run. **Note:-** A Motorsport Australia Log Book has precedence over a SCMSA Log Book. **This form to be completed by a competitor who require a SCMSA Log Book for their competition vehicle.**
4. New competition vehicles are also required to have an eligibility check prior to racing
