FURTHER REGULATIONS

To be read in conjunction with the Supplementary Regulations for the event.

1 AUTHORITY:

The event will be held under the FIA International Sporting Code including Appendices and the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd (CAMS), the Speed Event Standing Regulations, the Short Circuit Standing Regulations, the Short Circuit Vehicle Regulations, Short Circuit General Regulations, the Supplementary Regulations these Further Regulations and any further regulations or instructions which may be issued in respect to CAMS Permit Number **419/2807/02**.

The Speed Event Standing Regulations refers only to the super sprints. The Short Circuit Standing Regulations, Vehicle Regulations and General Regulations refer only to the short circuit.

7 JUDGES OF FACT:

(e) The Clerk of Course shall be deemed to Judges of Fact in respect to drifting.

8 START:

The event will commence at **10.00 a.m.** and will conclude at approximately 5.00 p.m. on Saturday 27th July 2019, and will continue from **10.00 a.m.** until approx. 3.00 p.m. on Sunday 28th July 2019.

12 SCRUTINY:

Scrutiny will be held at Carnell Raceway, Stanthorpe from **2 p.m. to 5 p.m.** on Friday 26th July 2019 and from **8.00 a.m. to 9.30 a.m.** on Saturday 27th July 2019, however, vehicles may be scrutineered outside of these times at the discretion of the Clerk of Course and Chief Scrutineer. If required special arrangements can be made with the chief scrutineer for Sunday scrutiny.

Competitors will be required to have their timing transponders with them at scrutineering to check their number and to ensure they are mounted correctly and are in working order.

No CAMS licences will be issued on the day unless special arrangements have been made with the Secretary of the Meeting.

13 DRIVERS BRIEFING:

The compulsory attendance of all drivers is required at the driver's briefing to be held at the canteen area on Saturday 27th July 2019 at 9.30 a.m. and Sunday 28th July 2019 at 9.30 a.m. All drivers are required to sign the attendance sheets. A penalty will be imposed on competitors failing to attend the driver's briefing, and omitting to signing the attendance sheets.

14 INSURANCE:

Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the Event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

2 Third Party Insurance: All competing vehicles carrying civil registration in Queensland require a Third Party extension certificate or letter (CTP) stating the full title of the event, location and date.

19 TIMING:

For those who need to hire a timing transponder the hire rate is \$20.00 per unit, **plus** a refundable security deposit of **\$140.00 cash (\$160 in Total)** which is to be lodged on issue of the transponder. **Transponders will be available for sale. See note re Purchase of Transponders**

PLACEMENT OF TRANSPONDERS

Competitors must supply their own cable (zip) ties suitable to attach the transponder to the vehicle. Transponders must be placed on the vehicle so it has a direct line of sight to the ground. Each driver must have a separate transponder and only **one** transponder is to be on or in the competing vehicle at any time.

28 PENALTIES

Drifting is not allowed. Any competitor drifting during competition may be excluded from the event. Any driver, considered by the Clerk of the Course in consultation with the stewards, driving in an unsportsmanlike manner will be excluded from the event.

END OF FURTHER REGULATIONS

COMPETITORS NOTES:

- (1) **Catering** – Catering will be provided on both days including Breakfast on **both** Saturday and Sunday mornings.
- (2) **Use of Showers** – The Stanthorpe Club has asked for a Gold Coin donation from those who use the showers to help defray the cost of providing them.
- (3) **Track Sweeping** – The Buccinis have again generously provided for a Street Sweeper to sweep the Track.
- (4) **Purchase of Transponders** - A decision was confirmed at this year's SCMSA AGM that transponders be offered for sale to all members. In doing so this will reduce the amount of rental transponders retained by the Association. This decision was made due to the significant amount of work required by volunteers to maintain the rental process.

At this round at Carnell Raceway you will have the opportunity to purchase a transponder, however we will still be providing the opportunity for rental.

If you wish to purchase a transponder with a two year warranty the cost is \$165.00.
