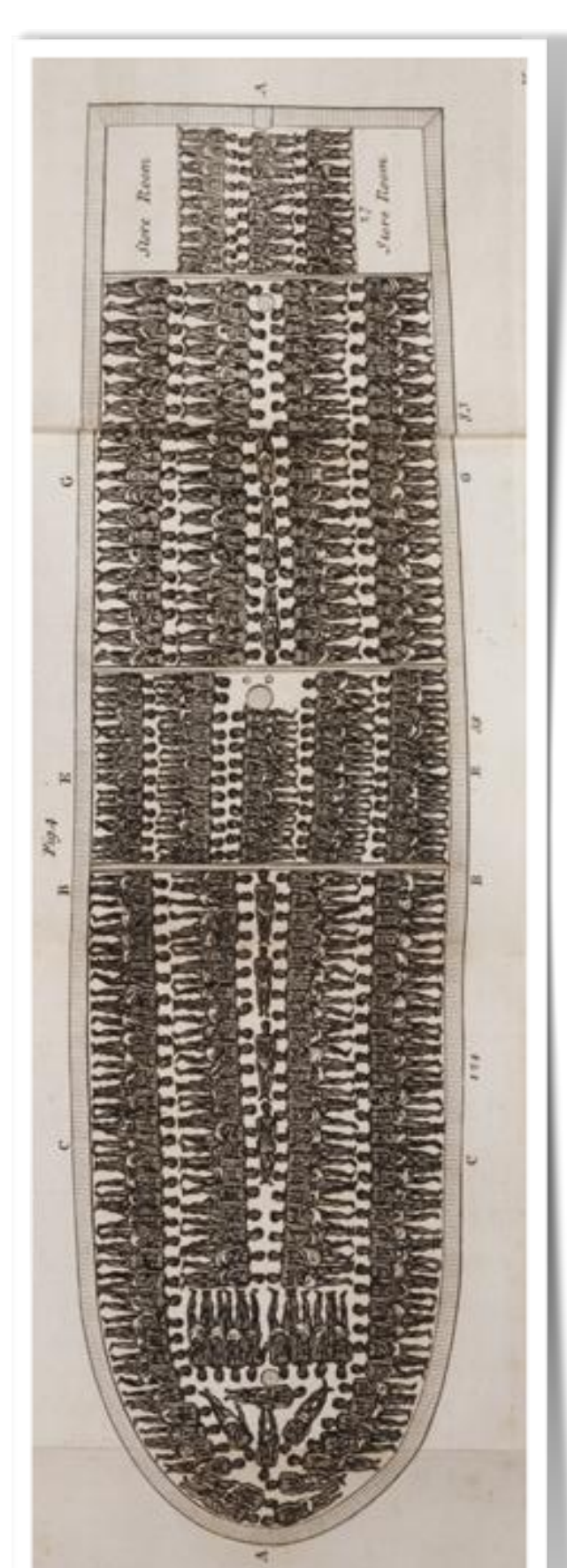

ZONG MASSACRE
Insurance Claim for over 132 African Slaves
Thrown Overboard; No Charges; Great Britain
Justice John Lee statement, "What is this claim
that human people have been thrown
overboard? This is a case of chattels or goods.
Blacks are goods and property; it is madness to
accuse these well-serving honourable men of
murder... The case is the same as if wood had
been thrown overboard."

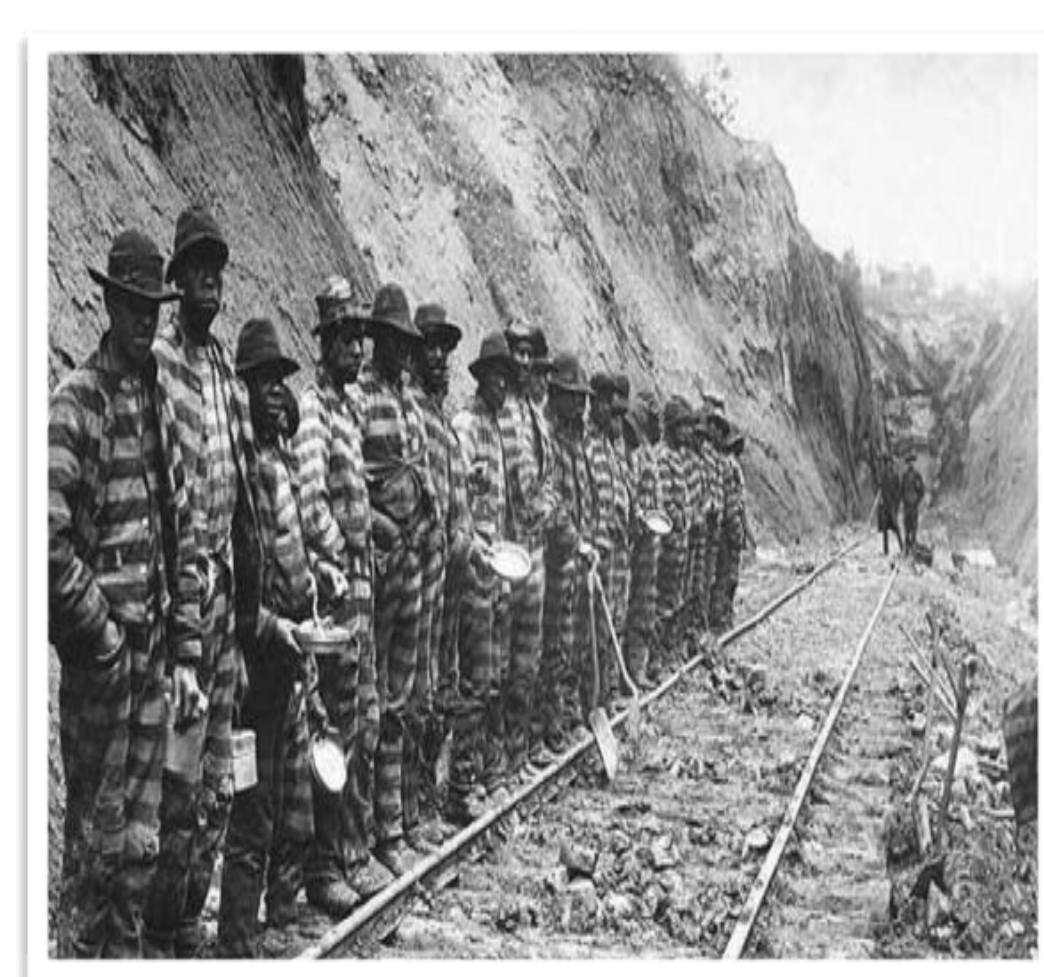

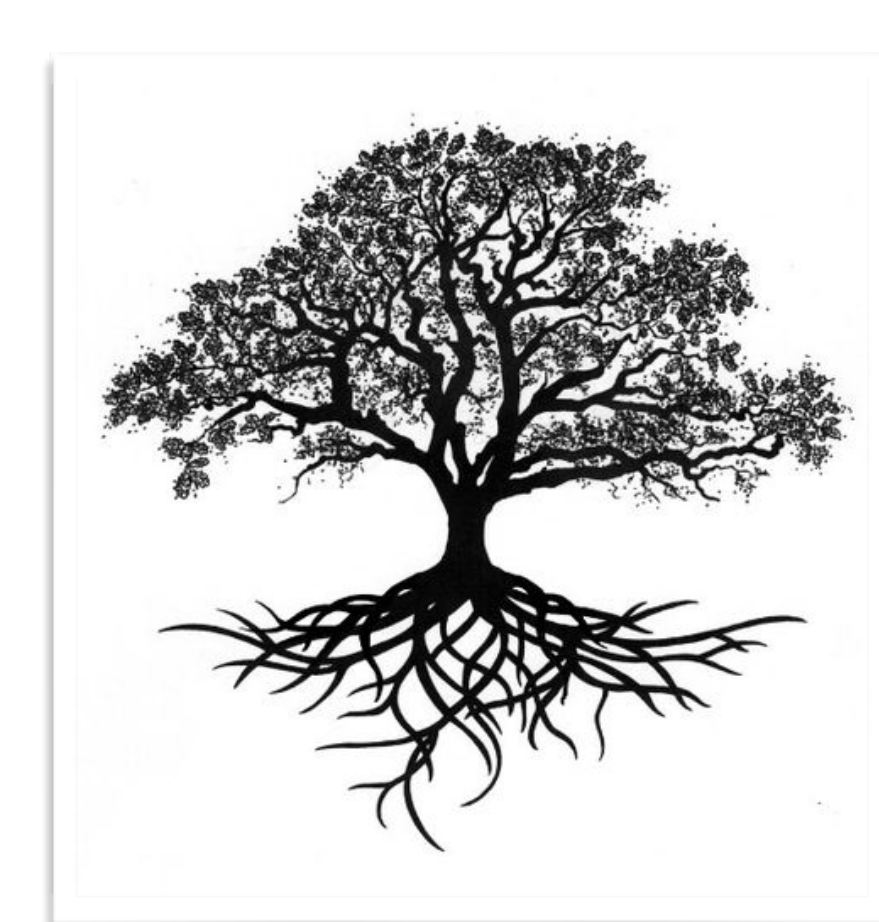

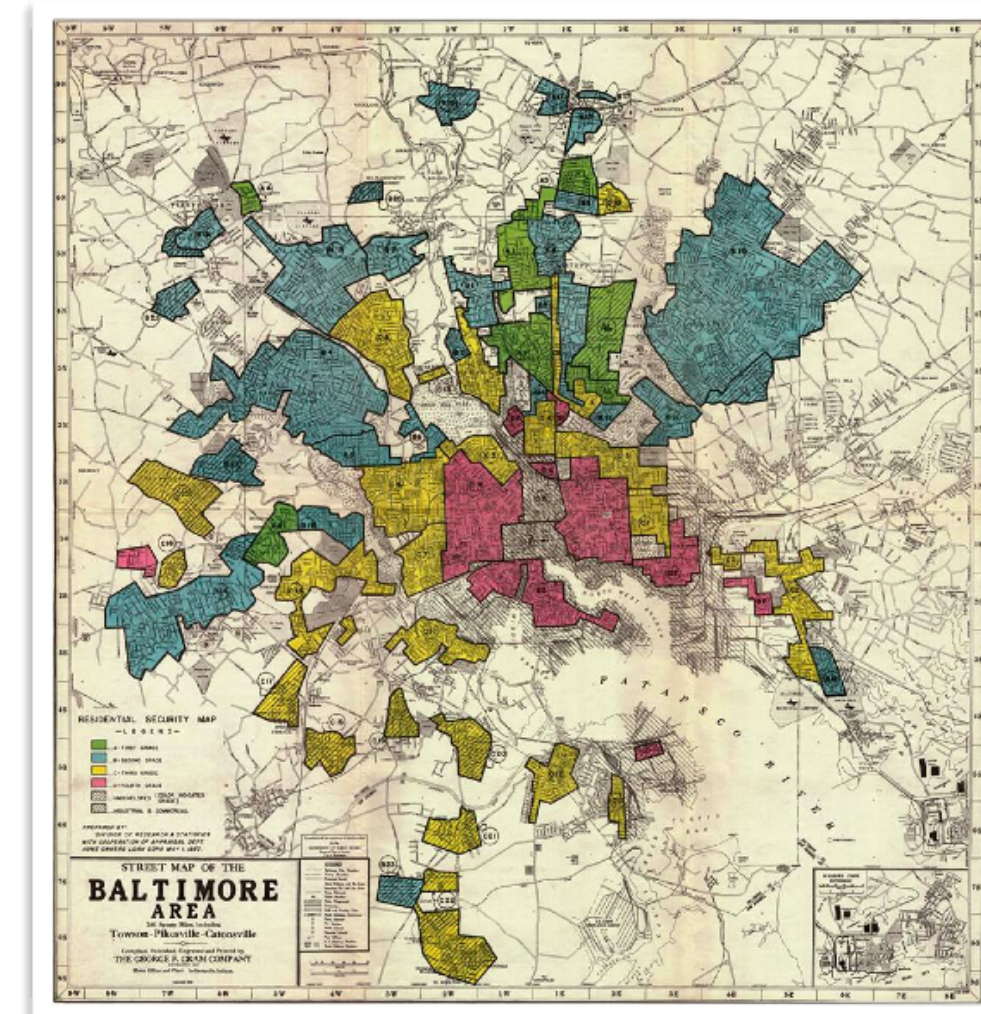
