2 What personal data we collect

3 How we obtain your data

- **Direct interactions** you give us data when you create an account, purchase a product, subscribe to a newsletter or contact us.
- **Automated technologies** we collect Technical and Usage data via cookies, server logs and similar technologies.
- **Third-party sources** analytics providers (e.g. Google), advertising networks, payment processors, publicly available registers.

Fraud prevention & security monitoring	Legitimate interests (protect business and customers) (Art 6 (1)(f)); legal obligations (Art 6 (1)(c))

Where we rely on legitimate interests, we have balanced those interests against your rights and expectations.

5 Cookies & similar technologies

We use cookies and similar technologies to recognise you, remember your preferences and measure Site performance. For full details please see our separate **Cookie Policy**.

You can control cookies through your browser settings and, where required by law, we will request your consent before placing non-essential cookies.

6 Sharing your personal data

We share your personal data only when necessary and in accordance with the law:

- **Service providers** acting as processors (e.g. hosting companies, payment gateways, email service providers, analytics providers) who provide IT and system administration services.
- **Professional advisers** including lawyers, bankers, auditors and insurers who provide consultancy, banking, legal, insurance and accounting services.
- Regulators and authorities who require reporting of processing activities in certain circumstances (e.g. HMRC, courts, the Information Commissioner's Office).

• **Business transfers** – if we merge, sell or reorganise our business, personal data may be transferred to a successor.

All processors are bound by contractual obligations to keep data confidential and to process it only according to our instructions.

7 International transfers

Some of our external partners are based outside the UK so their processing may involve a transfer of data internationally. Whenever we transfer your personal data out of the UK we ensure a similar degree of protection is afforded to it by using:

- Adequacy regulations (countries deemed to provide an adequate level of protection); or
- Standard Contractual Clauses approved for use in the UK, together with supplementary measures where necessary.

8 Data security

We have put in place appropriate technical and organisational measures to prevent your personal data from being accidentally lost, used, accessed, altered or disclosed in an unauthorised way, including:

- encryption in transit and at rest;
- role-based access controls;
- · regular security testing and monitoring;
- staff data-protection training.

We limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know.

9 Data retention

We keep personal data only for as long as necessary to fulfil the purposes we collected it for, including satisfying any legal, accounting or reporting requirements. Generally:

- Customer accounts retained for 6 years after last activity;
- Transaction records retained for 6 years for tax compliance;
- Marketing consents retained until you opt out or withdraw consent.

When retention ends, we delete or anonymise the data. We may retain anonymised statistical data indefinitely.

10 Your legal rights

Under UK GDPR you have rights to:

- 1. Access request a copy of the personal data we hold about you;
- 2. **Rectification** ask us to correct incomplete or inaccurate data;
- 3. **Erasure** request deletion of your data where there is no good reason for us continuing to process it;
- 4. Restriction ask us to suspend processing of your data;
- 5. **Portability** receive your data in a structured, commonly used, machine-readable format and have it transferred to another controller;
- 6. **Object** object to processing based on legitimate interests or direct marketing;
- 7. Withdraw consent where we rely on consent you may withdraw it at any time.

You also have the right to complain to the **Information Commissioner's Office** (ICO) at *ico.org.uk* or 0303 123 1113. We would appreciate the chance to address your concerns first, so please contact us.

11 Automated decision-making

We do **not** use your personal data for automated decision-making that produces legal or similarly significant effects.
