

Letter from the President

Dedication is around the corner! Really! The township has informed us that the bond monies have been released and, once necessary drainage repairs are made, the remaining monies will come to the community. The plan is to use the monies to correct landscaping issues throughout the community.

Collection of the special assessment imposed on homeowners to replace funds used to pay for snow removal is in full swing. 49% of the total has been recovered. This special assessment is subject to the same fee schedule and process as the monthly dues, i.e., additional fees and possible legal action. It is hoped that 100% recovery will be realized by July 31.

To update you on the delinquent account situation, several delinquent accounts have been paid in full and others are under payment plans. The accounts that did not seek payment plans or ignored the notices have been processed in Montgomery County Court and are now out of our control. It is unfair to expect the homeowners who pay regularly to carry the entire community. This was the last thing we wanted to do but we were out of options.

School will be out soon and homeowners are asked to drive carefully through the community, especially where there are parked cars. Toys and bikes must be stored when not in use.

Street parking is not permitted in the courts. Homeowners must park in their garages/driveways, slot spots or in the general parking spots on Bean or Napoleon Drives in the carved out spaces. Parking on the sidewalks and driveway aprons is also not permitted. Violators will be towed. Households having 3 or more vehicles should be considerate of their neighbors and use the general parking spots.

Vehicles parked in slot spots without current registration or inspection are considered abandoned and will be towed.
