## **COURSE AND BIRDS**

All tests are single course without a bird field, chuckar or game bird will be released in all stakes except puppy. First bird on course will be shot on retrieving stakes (AGD / OGD). Blank all other birds. No blanks may be fired in open puppy. Blaze orange must be worn in all live shooting stakes.

Horseback handling will not be permitted in any stake.

Horseback scouting will not be permitted.

## **PRIZES**

Standard AKC Rosettes to all placed dogs.

Buckle to first place dog for any stake over 8 dogs that start.
