

What you need the day of the road test:

- NYS Learner's Permit
- MV-278 Pre-Licensing Course Completion Certificate

or

- MV-285 Driver Education Completion Certificate
 - The MV-285 supersedes the MV-278. You don't need both
- MV-262 Certification of Supervised Driving (if under 18 y/o)
 - The bottom part of the form does not have be filled out
 - It can be added, but only the parent's signature is required

Other things to remember:

- **DO NOT** practice in or near the road test site area.
- The student **CANNOT** be behind the wheel when you pull up to the road test site.
- When you get to the road test site, you will get in line behind the other cars that are waiting. If you are the only one at the site, pull up to the green sign that says, "DMV Road Test Starts Here"
- You will not be given the results of the test at the site.
- When the road test is over, the examiner will give you a business card with a link to a website to check your results.
- Results are posted at the end of their shift and available at or around 6:00 PM
