Great news! You can save more in 2025! The IRS limit for retirement plan contributions is \$23,500. If you are age 50 or older by December 31st, you can contribute an additional \$7,500 in catch-up contributions.

There's even better news for those in the 60-63 age bracket. You can contribute a higher catch-up contribution amount of \$11,250.
