## APPLE FEST ADVENTURE - CONTEST RULES

NO PURCHASE IS NECESSARY. VOID WHERE PROHIBITED. EXCLUDES RESIDENTS OF QUEBEC.

The St. George Apple Fest "Adventure" contest (the "Contest") is sponsored and administered by St. George Applefest, 36 Main Street South, St. George, Ontario N0E 1N0 (the "Contest Sponsor").

The Contest consists of one component as described in more detail in these Rules:

Contest draw ("Contest Draw")

Contest Period. The Contest starts at 10:00 a.m. Eastern Standard Time ("EST") on September 18, 2021 and ends at 6:00 p.m. on September 18, 2021 EST (the "Contest Period").

All eligible entries for the Contest Draw portion of the Contest must be received by 6:00 p.m. EST on September 18, 2021 EST (the "Contest Entry Deadline").

Eligibility. The Contest is open to Canadian residents. Eligibility is non-transferable. Residents of Quebec are excluded from the Contest including for certainty the Contest Draw.

Employees, representatives or agents of The Contest Sponsor and any other person in any way involved in the development or administration of this Contest, including employees, representatives or agents and persons domiciled with such persons (such as a members of their immediate families, including spouses, parents, siblings and children, regardless of where they reside), are not eligible to enter the Contest.

- All prizes will be drawn at the South Dumfries Community Centre (St. George Arena) and awarded on September 18, 2021 starting at 6:30pm.
- You do not have to present to win a prize.
- All draw's will be drawn made live on Facebook Live and posted on the St. George Apple Fest and St. George Business Association Facebook page.
- The full names of winner's, which is listed, on the St. George Apple Fest Adventures card will be posted on the St. George Apple Fest Facebook page and the St. George Business Association Facebook page.
- Each participant can win more them once.
- All prize baskets or any item(s) in the baskets that was created by the St. George Apple Fest Committee and can not be exchanged or refunded for cash or other items.
- St. George Apple Fest is not responsible for an unexpected issue and/or injures related to all or any the items in the prize baskets.
- All prizes' winners will be contacted to arrange pick up for their winning basket.
- See Rules and Regulations on the St. George Apple Fest website.

Contest Draw. Random draws from all eligible Contest Entries, excluding residents of Quebec, will be held at approximately 6:30 p.m. EST on September 18, 2021 ("Draw Date") at St. George ON by St. George Apple Fest board members and designated local politicians ("Contest Draw").

The Contest Draw will be conducted by the Contest Sponsor, whose decisions in all matters shall be final. The Entrants whose eligible Contest Draw Entries are selected from the Contest Draw on the Draw Date ("Selected Entrant") will be eligible to receive the prizes listed.

Contest Draw Odds. Odds of winning a prize as part of the Contest Draw depend on the number of eligible Contest Draw Entries received during the Contest Period.

Substitutions: Gift Certificates and Prizes must be accepted as awarded, without substitution, transfer, exchange or assignment, unless otherwise approved in writing by the Contest Sponsor. The prizes are non-refundable, not convertible to cash, except in the Contest Sponsor's sole

discretion. The Contest Sponsor reserves the right, in its sole discretion, to make substitutions of equal or greater value of the Gift Certificates and Prizes, including without limitation, a cash award, if the Gift Certificates and Prizes cannot be awarded as described for any reason.

Award of Prizes. The Selected Entrant will be notified in person or by phone regarding the Prize, using the Entrant's contact information supplied in the Contest Entry.

For the Selected Entrants to be eligible to win, the Selected Entrant must:

respond to the telephone notification from the Contest Sponsor regarding the Prize ("Prize Notification") within seven (7) business days of it being sent; and

have complied with these Rules; and

correctly answer, without assistance of any kind, a time-limited, mathematical skill-testing question; and

complete, execute and return a Full Release of Liability, Consent to Publicity & Indemnity Form ("Form") and any other consent to publicity and waiver of liability forms required by the Contest Sponsor within four (4) business days, which will confirm, among other things, each of the following:

the Selected Entrant has complied with these Contest Rules;

the acceptance of the Prize as awarded; and

consent to the use of the Selected Entrants name(s) to announce the Prize Winners and in connection with the Contest, without further compensation, except where prohibited by law.

In the event of a dispute over the identity of the Selected Entrants, proof of identification must be provided by the Selected Entrants to the Contest Sponsor upon request.

In the event of non-compliance with these Rules, and/or if the Selected Entrant cannot be reached via the contact information provided on the Contest Entry, or the Prize is unclaimed or undeliverable, or the Form is not fully completed, returned and signed by the Selected Entrant, or the mathematical skill-testing question is answered incorrectly, the Prize will be forfeited and an alternate Entrant or Entrants may, in the Contest Sponsor's sole discretion, be selected.

The Selected Entrants will be declared the "Winners" by the Contest Sponsor upon the Contest Sponsor's confirmation that the Selected Entrant has complied with these Rules, and completed and returned a Form signed by the Selected Entrant, including the correct answer for the mathematical skill testing question. Upon being declared a Prize Winner by the Contest Sponsor, the Selected Entrants will receive their Prize.

Contest is void where prohibited by law and is subject to all applicable laws and regulations. To the extent permitted by law, any dispute arising from this Contest will be determined according to the laws of the Province of Ontario, without reference to its conflict of law principles, and each Entrant consents to the personal jurisdiction of the courts located in Brantford or Brant County, Ontario and agrees that such courts have exclusive jurisdiction over all such disputes.
