#### **GOVERNANCE:**

The Secretary called the meeting to order and advised Members that Eric Camereon, our Acting Chair would be chairing the meeting.

It has been a difficult period for the charity, losing three founding members, namely Robert Kerr (former Chair), Suzanne Mackay (Community Garden Project) and David Hodge (Vice Chair) in the third quarter of 2023, so there was a need to stabilise the Board, meaning five (5) trustees present. Trudy Perry remained as Secretary and Debbie Smith as Treasurer. Mike Bryant and Eric Cameron have stepped up as Trustees and Adrienne Nicholas joined the Board in December 2023.

The Board would like to formally acknowledge all the hard work the founding Trustees have contributed to this point. There were many legacy issues that took a long time to resolve, multiple title deed issues to resolve, a new charity had to be established, and much funding sought to work our way through the huge project of getting a new community building a community garden project up and running and all the events produced throughout the year. Everyone deserves recognition for work that is often unseen.

MEMBERSHIP: As of the last AGM the Melvich Community SCIO Membership stood at 38 members. We have recruited 9 additional members, of which 1 has relocated out of area, leaving the current membership as of today at 46 Members. The Board will continue to promote Membership through all the social media channels and in the Community Update booklet.

CONSTITUTION: Constitutional changes discussed during the year 2021-22 were (Updated):

- 1. Expand area to match Melvich Community Council area (To be Actioned)
- 2. Add clauses to allow us to enter funding arrangements with Scottish Land Fund based on their constitutional requirements. This element has been investigated extensively with the help of Voluntary Group Sutherland and it was agreed by the Board that the changes required to our Constitution outweighed the benefits of working with the Scottish Land Fund, at this time. This matter has therefore been removed from the funding route for a new community building however may be considered at a later stage.

# **CHAIR'S REPORT:**

The Chair thanked everyone for coming and offered introductions to the Board.

EC then read through the comprehensive accounts report filed with OSCR and covered the main points of interest detailed in the report.

- 1. Summary of the main activities in relation to the charity's objectives
- 2. Summary of the main achievements of the charity in the financial period

The Board would like to thank our community, our grant funders and all of our volunteers for helping us have another successful financial year of Melvich Community SCIO. The support given to date gives the charity's trustees confidence that the challenging objective of having a multi-generational multi-functional inclusive community hub building is achievable.

There then followed a discussion on the Melvich Community Hub project and Community Action Plan (CAP).

The project is currently in RIBA Stage 1 - Design and after presenting the community with a building containing everyone's wish list items, we are now at a point to go back to the community and say what do you <u>not</u> want in the building if the size is to be significantly reduced as some have suggested. However, the Community Action Plan currently with the Community Councils suggests perhaps Sinclair Court is a higher priority, which could potentially facilitate some of the activities the community hub would have looked to facilitate. A copy for the general public is being put together. The entire document is 100 pages plus 100 pages of Appendices, so we are trying to condense this to area relevant documents but have not yet met with the community councils to discuss the document for the first time so this will be forthcoming as soon as possible.

- 1. Current date for Communities Councils to meet is Sunday 10<sup>th</sup> March @ 1pm.
- 2. Suggest a special meeting so this can be discussed and see how the CAP impacts the Community Hub once everyone has seen a copy of it.

Clearly, five people is not enough to do all the work required to achieve these objectives and to build a new community facility. People get burnt out and overwhelmed. Therefore, all members must seriously consider whether they wish the charity to continue. Without a total of 11 people on the Board assisting in many ways (we can all do something) the Board has serious concerns about its ability to achieve these objectives. Currently, if one of us has to attend to crofting or personal business we are then not quorate and can't hold our monthly meetings to get things progressed.

We are looking for **6 additional people** to step up as Trustees to the Board and lots of volunteers to help as follows:

- Event's Organiser (organisation, promotion and helpers)
- Website Management and Social Media (perhaps a youngster)
- Delivering Community Updates (helpers)
- Community Garden Project Lead (and helpers)
- Portskerra Play Park Project (helpers for fundraising and design & implementation of the project) Lead: Natalie Bird
- MOOV the active group that gets people outside for walking for fitness and mental health (people to join in) Lead: Sarah Kerr
- Minutes Secretary (taken from recorded sessions mostly)
- Bakers for events

#### ADOPTION OF THE MINUTES OF THE LAST AGM:

The minutes of the last Annual General Meeting dated 29/11/2022 were distributed to all Members prior to the meeting and subsequently passed for adoption.

All 17 members present voted to adopt the Minutes. No proxy votes were lodged with the Chair prior to the meeting.

#### **CONSIDERATION OF THE ANNUAL ACCOUNTS:**

The annual accounts for the period 1/4/2022 to 31/3/2023 were provided to all Members in advance of the AGM and on the evening.

Melvich Community SCIO has been actively engaging with potential grant funders and has made various successful grant funding applications to help our community on our journey towards establishing our new community hub. The accounts for this financial year show the receipt of grant funding (in the restricted reserves) that have a specific purpose as part of this journey and will be paid out when the relevant stage of work has been completed.

- £10,000 over two-years from SSE Strathy North Community Benefit Fund allocated to core funding and events, which will help us to deliver our charitable objectives.
- £16,886.11 was received from SSE Strathy North Community Benefit Fund allocated to RIBA Stages 0-1 to enable us to complete the design and feasibility elements of the project.

£2,200 was received due to the closure of North West Council for Community Action (NWCCA) who distributed some funds based on their Articles of Association to Melvich Community SCIO who were identified as a comparable charitable organisation. These funds have been allocated to the Play Park Sub-Committee towards their fundraising activities as the timeline for completion of this project is considerably shorter than the main Community Hub project.

DS confirmed that our annual accounts have been certified and filed with OSCR on-time.

# **RESOLUTION 006:**

The Secretary encouraged people to apply to be on the Board. You are required to complete a Self-Nomination Form. There are a maximum of 11 seats available on the Board. Anyone who would like to join the Board should speak to a Board member for more information and guidance.

Julie Fitttock and Tim Reed then put themselves forward to be on the Board and completed Self-Nomination Forms at the meeting.
