Students will be turned away from events, uniforms, performances paid for by Pines Jaguar Band Inc. if they have not participated in the Fair Share Program.
- _____ Should Payments not be made on time your student may be removed from the membership and will not be allowed to participate in any future events funded by Pines Jaguar Band, Inc.
- _____ If you selected a non-fundraising options and you use funds generated by a fundraiser your selection will be changed to the fundraising option and all discounts will be removed.
