The Eddie retains the right to remove vendors for abusive or offensive behavior, racism, sexism or other offensive speech which may offend patrons or vendors.
- 5) By completing the Vendor Application Form and upon paying the fee, all Vendors participating in the Eddie Farm Market grants permission The Eddie Hotel and Farm Inc and others as may be designated for Marketing or informational purposes to use photographs and video taken at the event and vendor information in marketing medium including but, not limited to websites, newsletters, Television, print and radio media.
