

# Terms and Conditions for Artists Selling Artwork to The Geek Out

Welcome to The Geek Out! We appreciate your interest in selling your artwork for our merchandise. By submitting your artwork for sale, you agree to the following terms and conditions:

## 1. Purchase Agreement

1.1 The Geek Out will purchase selected artwork for a one-time payment of **\$30.00 USD** per design.

1.2 Payment will be made via [bank transfer] within **[14] days** of approval and acceptance of the artwork.

1.3 Once the payment has been made, The Geek Out will hold full ownership and rights to the artwork.

## 2. Ownership and Rights

2.1 Upon purchase, **The Geek Out obtains full ownership and distribution rights** to the artwork, including but not limited to reproduction, marketing, and sale on merchandise such as T-shirts and other apparel.

2.2 The artist **relinquishes all commercial rights** to the artwork once it has been purchased.

2.3 The Geek Out reserves the right to modify, resize, or alter the artwork to fit merchandise specifications.

## 3. Artist Credit

3.1 The Geek Out will credit the artist for their work on relevant platforms, including social media, our website, and promotional materials where applicable.

3.2 While artist credit will be provided, **no royalties or additional compensation** will be granted beyond the agreed-upon \$30.00 per artwork.

## 4. Submission Guidelines

4.1 Artists must submit original artwork that does not infringe on any third-party copyrights, trademarks, or intellectual property rights. No AI artwork

4.2 Submitted artwork should be high-resolution (minimum **400 DPI**), in **PNG, AI, PSD, or SVG format**, and designed for apparel printing. Progress photos for proof of original design are encouraged but not mandatory. Please see examples below:



4.3 By submitting artwork, the artist confirms that they have full rights to the design and that it has not been previously sold or licensed to another entity.

## 5. Rejection and Refunds

5.1 The Geek Out reserves the right to reject any artwork at its sole discretion, even if it meets the submission guidelines.

5.2 If an artwork is not approved, no payment will be made.

5.3 Once an artwork is purchased, no refunds or returns will be provided unless it is found that the artwork is not the property of the artist in question. In this case, legal action may result

## 6. Legal Compliance

6.1 The artist agrees to indemnify and hold harmless The Geek Out against any claims of copyright infringement or intellectual property disputes arising from the artwork.

6.2 These terms shall be governed by the laws of **The Bahamas**, and any disputes shall be resolved in court if no other agreement can be made.

## 7. Agreement Acceptance

7.1 By submitting artwork to The Geek Out, the artist acknowledges that they have read, understood, and agreed to these Terms and Conditions.

7.2 These terms may be updated periodically, and continued participation will constitute acceptance of the revised terms.
