- 4. A motion by Wilson, seconded by Pulley, to approve the corrected minutes from the 5/19/25 meeting. Bernard aye, Pulley aye, Sutton aye, Wilson aye. Motion carried unanimously.
- 5. Heard presentation by Headwaters RC&D regarding multiple topics and services they offer.
- 6. A motion by Wilson, seconded by Pulley to approve Resolution 2025-2, Approving Wages for Fiscal Year 2026. Bernard aye, Pulley aye, Sutton aye, Wilson aye. Motion carried unanimously. (Note: The incorrect fiscal year was listed on the agenda; it should have read "Fiscal Year 2026," not "2025.")

- 9. Discussed water meter install charge for property at 540 N. Main. A motion by Pulley, seconded by Bernard, to charge the same new installation charge since there will not be a cost difference to the town for the install. Bernard aye, Pulley aye, Sutton aye, Wilson aye. Motion carried unanimously. (The previous service at that location was removed over 20 years ago.)

10. Discussed draft of Cemetery Regulations. The council agreed to have the cemetery board revisit the draft, make some edits, and bring the amended draft to the next council meeting.

- 11. Young announced the yard-of-the-month winner for June: Sharon and John Novitski.
- 12. Discussed what to do with topsoil from the water project. A motion by Wilson, seconded by Sutton, to keep the topsoil for the town's use. Bernard aye, Pulley aye, Sutton aye, Wilson aye. Motion carried unanimously.
- 13. Discussed what to do with the donated water pump. Wilson will bring this up at the next fire department meeting.
- 14. Discussed the possibility of hiring a seasonal worker or mowing business. Wilson obtained costs for mowing and weedeating. A motion by Wilson, seconded by Sutton, to table this topic to next spring since the grass is slowing down. Bernard aye, Pulley aye, Sutton aye, Wilson aye. Motion carried unanimously. Several council members volunteered to assist with mowing if needed.
- 15. Discussed Senior Van. A motion by Wilson, seconded by Pulley, to table this topic to the August meeting based on getting the word out and asking the attendees at the senior meal. Bernard aye, Pulley aye, Sutton aye, Wilson aye. Motion carried unanimously.
- 16. Discussed Fiscal Year 2026 budget projects.
- 17. Discussed draft of possible contracts for properties outside of town limits receiving water service. Clerk will check with attorney on draft.
