# **EVENT INFORMATION**

# Location

The Street Fair is located outdoors on Barnesville's Front Street, and is held rain or shine! Please come prepared to protect your merchandise in case of inclement weather which includes tarps, weights and tie downs; note that nothing can be drilled into the pavement.

## **Hours**

Street Fair hours are 10:00 AM to 8:00 PM on Friday, August 25 and 9:00 AM to 6:00 PM on Saturday, August 26. We ask that you be set up prior to opening time and remain set up until the fair's close.

# Set-up and Tear Down

Check-in and set-up begin at 7:00 AM on Friday. Tear down will be from 6:00-7:00 PM Saturday. YOU MUST BE DOWN AND OFF THE STREET BY 7:00-NO EXCEPTIONS!!!

# **Security**

Booths must be attended during show hours. Overnight security will be provided Friday after 8:00 PM.

# **Exhibitor Requirements**

Each exhibitor is responsible for providing tables, chairs and canopy. Electrical power is not provided; Generators are NOT allowed unless quiet MN tax number required.

# **BOOTH OPTIONS**

11 x 11 booth \$100-2 days 11 x 22 booth \$150-2 days 11 x 33 booth \$200-2 days

Booths are 11 feet deep from the curb and 11, 22, or 33 feet wide. You may request a certain block (refer to the Street Fair map on the back of this letter.) Booth numbers will be assigned and given out at check-in on August 25. PLEASE NOTE: Blocks 3 and 4 will be the only spaces that allow trailers for merchandise display only. Trailers must fit lengthwise in the requested space. No personal vehicle/trailer in your space unless it's part of your booth, and for setup and tear-down only. Parking is available off street.

# SPECIAL LOCATION REQUESTS

We will try very hard to honor special location requests. But please note: YOUR REGISTRATION MUST BE POSTMARKED BY August 1st-NO EXCEPTIONS if you want to get that certain spot.

# **TAX FORMS**

Minnesota requires that **ALL** exhibitors complete and return the enclosed Operator Certificate of Compliance ST19 with their registration. If you do not have a tax number, please call the Minnesota Department of Revenue at 651-282-5225.

# **INSURANCE**

We recommend that you have a Certificate of Liability Insurance to protect yourself and your business, but it is not mandatory to participate in the Potato Days Street Fair.

Neither the City of Barnesville nor the Potato Days Festival will be responsible for accidental loss or damage of any kind.

# **GENERAL INFORMATION**

Acceptance in the Potato Days Street Fair is a **FIRST-COME**, **FIRST-SERVE PROCESS**. Once we have received your registration, a confirmation will be sent to you by email (please provide on the registration form for faster service) or postcard. Specific information regarding check-in and set-up on August 25 will be mailed to you on August 1. No maps or booth numbers will be given out prior to Friday, August 25.

# PLEASE NOTE: THE REGISTRATION FEE IS NON-REFUNDABLE-NO EXCEPTIONS!

The Potato Days Street Fair is NOT a juried event. Therefore, product exclusivity is guaranteed only to vendors representing nationally known companies.

# Street Fair Map 2023

## **PLEASE NOTE:**

Highway 9/Front Street north and west of the downtown area will be undergoing extensive reconstruction during the 2023 Potato Days Festival. While the area occupied by Potato Days and the Street Fair will not be under construction, there may be considerable dust and/or mud as well as construction equipment in close proximity. Therefore, the Potato Days Board of Directors has decided to locate the entire Street Fair south of the Food Court area to avoid potential damage to vendors' property.

We will try our best to relocate vendors who have always been in Block 1 to similar locations in Blocks 2 and 3. We encourage previous Block 1 vendors to register before August 1<sup>st</sup> if you have special location requests.

No personal vehicle/trailer in your space unless it's part of your booth, and for set-up and tear-down only. Parking is available off street and in the vendor parking area.

Trailers and vehicles used as part of your booth or display are permitted in Blocks 3 and 4 only.
