Flood Insurance—Deadline Approaching!

After attending a recent class with Terry Hendricks, Chief Hydrologist for Pima County Regional Flood Control District, I thought it would be helpful to remind our homeowners that on June 16, 2011 the flood insurance rates will increase. Anyone who wants flood insurance should get it prior to the 16th as the rates will increase **SUBSTANTIALLY!** Anyone in Pima County that wants flood insurance can get it, regardless of whether they are/are not in a floodplain. Some properties may no longer be in the floodplain and therefore no longer require insurance. A homeowner can submit an "elevation certificate" if they are in a floodplain but feel their house is elevated enough that it doesn't require flood insurance. Also, if anyone is considering selling their home, the current flood insurance rates will carry through to the new owners as long as there is no lapse in coverage—this could be a huge benefit to seller and buyer. 49ers Neighborhood Watch Program

Hello 49ers Neighbors,

I am sad to report an incident that happened on June 8th involving two of our neighborhood dogs and hope, through this alert, to avoid any further pet illness, injury, or loss.

Two homeowners walked most of the last 9 holes on the golf course early in the morning with their dogs. Within half an hour of returning home, two of the dogs went into convulsions and died within approximately 15 minutes of each other. Both dogs were in good health prior to the walk. Other dogs were with them and so far show no signs of ill health. One dog was on-leash, the other was off-leash. It is not known what the cause of the illness may have been. Apparently the dogs were walking primarily down the center of the course, but not all were on leashes.

On the following day, June 9th, I received another report of dog illness. This again occurred somewhere along the last 9 holes of the golf course. This incident involved the same owner as one of the dogs which died the day before. The dog appeared healthy before going for a walk, but soon after had seizures and was immediately transported to the vet and was last reported to be recovering.

In light of the above information, we have learned that up to four weeks ago, two separate similar incidents occurred. Both dogs suffered seizures but thankfully survived. Again, the cause is currently unknown.

After checking with both the golf course manager and course greens supervisor, 49ers has confirmed that nothing different has been used on or around the course today or anytime recently. According to Wendy Cross, Manager of 49ers Golf Course, no chemicals were recently sprayed nor was fertilizer used. She also confirmed that the same products have been used over the course of several years without incident. The fertilizer, when used, is an organic, farm-grade fertilizer.

It is possible that these events could've stemmed from errant use of pesticides and/or poisons to control other problems around one's property. Please be sure to follow manufacturer's instructions for proper use and disposal or, given these recent events, PLEASE consider non-toxic methods of control.

Several additional dangers exist in our area in the natural environment. These include Colorado River Toads, Sacred Datura (Jimsonweed) and Rattlesnakes, as recently discussed. As we enter monsoon season, these hazards may increase.

It is advisable to keep your dogs leashed at all times, maintain an awareness of what they are "getting into" and keep an eye out for possible dangers. Also remember to secure your pets if they are sensitive to the thunder which precedes the monsoon rains, and watch for toads which come out of hibernation at that time.

If I am made aware of any new developments or information, I will pass them on to you.

Thank you, and again my sincere condolences to the families who have suffered this loss.

Neighborhood Sewer Rehabilitation

Even the best made plans change as Pima County has found out recently while working on our sewer system. The four phase plan to repair sewer issues progressed normally at West Wagon Trail. Sewer modifications at South Soldier Trail also went smoothly along with preparation work on North Wagon Trail. The manhole replacements on Barbary Coast turned out to be significantly more difficult due to a high water table only 5 feet below the road surface as well as an active underground spring. Each time the K E & G crew dug down, the sides of the hole would collapse. The crew had to continually pump water out for over a week in order to reach the sewer pipes almost 10 feet below the surface. Mr. Noel Ortiz, the Pima County Supervising Civil Engineer, said it was similar to the situation during the 2010 sewer problem on South Wagon Trail. Once the issues on Barbary Coast are resolved, work will commence replacing 350 of sewer pipe on North Wagon Trail. Mr. Ortiz also stated that the bids for lining all the sewer pipes has progressed and work should begin in August on the East end of the neighborhood and progressing in an sequential manner to the West end of the neighborhood. The KE&G crew and Mr. Ortiz wished to pass on their sincerely appreciation for all the support and cooperation Forty Niners residents have given them during the construction despite the inconveniences and longer than expected work.



Reddington Pass Use Changes

The FRP working group continues to be very active with issues affecting Reddington Pass. The group is now incorporated and working on raising donations to support the group efforts to make our part of the Coronado National Forest a safe and desire area for recreation. Friends of Reddington Pass advocates for the responsible stewardship of the Reddington Pass area and the preservation of its ecological, recreational and cultural resources. FRP priorities are to:

- 1) Assure conservation and restoration of sensitive riparian areas along the Tanque Verde Creek, its watershed and wildlife corridors throughout the pass
- 2) Improve opportunities for non-motorized, quiet recreation activities such as hiking, biking, horseback riding, wildlife viewing, picnicking and camping
- 3) Improve safe conditions along Reddington Road and throughout the Pass for residents and visitors.

The proposed shooting range is just one of many issues to be resolved. Soil samples taken in the area showed a higher than normal lead content, some samples in excess of federal limits, all due in part to the years of unregulated shooting in the pass. Land use compatibility, human and drug trafficking activities, dumping of trash, and activities outside of authorized boundaries are some of the others issues that FRP is working to resolve with over a dozen agencies.

By reaching out to as many people as possible and including them in working groups and meetings, FRP is working really hard to ensure that as many stakeholders are represented in the process so that workable solutions can be reached acceptable to as many people as possible.

49er Riparian Ecosystem

We live in a Pima County Riparian Ecosystem which gives us many wonderful native trees -velvet Mesquite, Palo Verde, Arizona Ash and Cottonwoods. We have obligations because of both the riparian designation and section 22 of the Conditions and Restrictions for Forty-niners Country Club Estates often referred to as CC&Rs. In Section 22 of the 49ers CC&R's you will find the following:

"The native growth on said property, including cacti, mesquite and palo verde shall not be destroyed or removed from any of the lots in said subdivision by any of the lot owners except such native growth as may be necessary for the construction and maintenance of roads, driveways, residences, garages and other out-buildings and/or walled in service yards and patios, which native growth shall not be removed prior to commencement of construction, and unless written permission be first obtained from the Leiber & McCarthy Land & Investment Corporation, its successors and assigns."

Your 49ers HOA Architectural Review Committee is one of those Successors and Assigns. The 49er Country Club Estates CC&R's run with the land and are

"automatically extended for successive ten (10) years each, unless there is an affirmative vote or written consent to terminate the declaration, as amended, by seventy-five percent (75%) of the owners of record of the lots within the subdivision for such purpose as stated in the First Amendment to Declaration of Establishment of Conditions and Restrictions for Forty-niners Country Club Estate and recorded the 1st day of December 1998 by 75% of the owners of record of the lots within the Subdivision."

A complete copy of the CC&R's and 1st Amendment quoted in the above paragraph can be found on the HOA website www.49ersHOA.com. Abiding by the CC&R's is MANDATORY even if a homeowner chooses not to join our voluntary homeowners' association.

Additionally, Pima County Regional Flood Control District, Water Resource Division (WRD) requires a grading permit if more than 1/3 acre is being cleared. The WRD recognizes that homeowners should also have a 30 foot defensible space around our homes for fire protection especially during this time of drought.

Your HOA has been called regarding tree cutting and removal by several of the 49er homeowners. The definitive answers and questions if there are any such things, will be addressed by the Water Resources Division at 520-243-1800. Ask for Carla Danforth.

Our CC&Rs were written in the 1960's. At that time, much of today's "world" could not possibly have been anticipated and as such, we are left with very minimal framework with which to govern our neighborhood. Compared to today's new neighborhoods with CC&Rs in the 100-plus page count, our CC&Rs have merely 6 pages. For anyone that has recently moved here from a more modern neighborhood, there is often frustration about the lack of appearance items, like weeds, paint, RVs, etc., that the Board can enforce. This makes adhering to what few "rules" we do have in our CC&Rs very important. You are encouraged to familiarize yourself with our CC&Rs. If you lost your copy, you can find them on our neighborhood website, www.49ersHOA.com, under Legal Documents. Once on our website, you can also learn about the process we do have that must be followed before improvements can be made to the exterior of your property!
