

LIABILITY WAIVER FOR PEACHTREE CITY CART TOURS, LLC

In consideration of being permitted to participate in the golf cart tours organized and operated by Peachtree City Cart Tours, LLC, I, the undersigned participant, hereby acknowledge and agree to the following terms and conditions:

1. Assumption of Risks: I understand that participating in golf cart tours involves certain risks and hazards, including but not limited to, the risk of accidents, injuries, property damage, and other foreseeable and unforeseeable dangers associated with outdoor recreational activities and the use of a golf cart. I voluntarily assume all such risks and hazards.

2. Release and Waiver: I hereby release, waive, discharge, and covenant not to sue Peachtree City Cart Tours, LLC, its owners, employees, agents, independent contractors, and representatives (collectively referred to as "Releasees") from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, or death that may be sustained by me or to any property belonging to me during the course of participating in the golf cart tours, including but not limited to any claims for negligence, personal injury, wrongful death, or property damage.

3. Indemnification: I agree to indemnify and hold harmless the Releasees from any loss, liability, damage, or costs, including attorney's fees, arising out of or related to my participation in the golf cart tours, whether caused by the negligence of the Releasees or otherwise.

4. Medical Treatment: In the event of any injury or illness that I may suffer during the golf cart tours, I authorize the Releasees to obtain medical treatment for me, including but not limited to emergency medical care, and I agree to be responsible for all medical expenses incurred.

5. Compliance with Rules and Instructions: I agree to comply with all rules, regulations, instructions, and guidelines provided by Peachtree City Cart Tours, LLC during the golf cart tours. I understand that failure to follow these rules may result in my removal from the tour without a refund.

6. Photography and Publicity: I consent to the use of any photographs, videos, or other media taken during the golf cart tours for promotional purposes by Peachtree City Cart Tours, LLC, without any compensation or further approval.

7. Severability: If any provision of this waiver is found to be unenforceable or invalid, the remaining provisions shall remain in full force and effect.

I HAVE CAREFULLY READ THIS LIABILITY WAIVER AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE, WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, AND ASSIGNS MAY HAVE AGAINST THE RELEASEES. I VOLUNTARILY SIGN THIS WAIVER WITH FULL KNOWLEDGE OF ITS SIGNIFICANCE.

PEACHTREE CITY CART TOURS, LLC GOLF CART SAFETY RULES

- 1. All passengers must remain seated and wear a seat belt at all times while the golf cart is in motion.
- 2. According to O.C.G.A. 40-6-76 (Georgia Code) children under **eight years of age** must ride in an age-appropriate approved child restraint system and be in one of the forward-facing positions on the cart.
- 3. All passengers must keep their hands, legs, and feet inside the golf cart at all times while the golf cart is in motion.
- 4. No alcohol of any kind or drugs are allowed on the golf cart.
- 5. Passengers must not be intoxicated while taking a tour with Peachtree City Cart Tours.
- 6. Passengers are responsible for their belongings and must take them with them upon exiting the golf cart.
