



MURRAY-CALLOWAY COUNTY COMMUNITY FOUNDATION 2020 ANNUAL REPORT

The Murray-Calloway County Community Foundation (“MCCCF”) had an outstanding year during the COVID 19 stricken year. The major highlights are outline herein.

- MCCCF started 2020 with \$2,761,810.00 in total endowment funds for the non-profits of our community.
- MCCCF ended 2020 with \$3,370,115.00 in total endowment funds for the non-profits of our community.
- Our goal for 2020 set in December 2019 was to reach total endowment funds of \$3,000,000.
- The annual gain of \$608,305.00 is biggest growth year in the history of the MCCCF.
- MCCCF distributed \$63,686.00 to its non-profits with endowments in 2020 and still experienced the growth of over \$600,000.00.
- MCCCF experienced investment income of \$397,136.00 for the year.
- MCCCF received \$317,293.00 in gifts for the year.
- In addition, Women of Numbers, an affiliate of MCCCF, made gifts to non-profits in our community in the amount of \$12,500.00 in 2020. Thus, the combined total gifts to our non-profits in 2020 were in the amount of \$76,186.00.
- COVID 19 mandates prevented our Board of Directors from having face-to-face board meetings for most of 2020. However, we did have Zoom board meetings on as needed basis.

Goals For 2021

- Through the 2021 Endow Kentucky Tax Credit program, our goal is to increase gifts to our non-profit endowments by \$200,000.00.
- Through gifts from donors to existing endowments, our goal is to increase our fund balances by \$400,000.00.
- Through investment income, our goal is to increase our fund balances by \$200,000.00.
- Our goal for disbursements to the non-profits that we serve in 2021 is \$100,000.00.
- Our goal is to establish 5 new endowments in 2021.

NEW ENDOWMENT ESTABLISHMENT
