THE 2025 DRS. DICK & JAN WEAVER CHALLENGE *for* CHARITIES

AGREEMENT TO PARTICIPATE

The Drs. Dick & Jan Weaver Challenge for Charities is a significant investment honoring the late Drs. Dick and Jan Weaver, as well as their family. Their investment and long-term gift is accomplishing their goal of helping nonprofits and their missions grow in perpetuity. The Murray-Calloway County Community Foundation (MCCCF) is proud to be administer and steward of the Weaver Challenge for Charities and its goal to grow nonprofit endowments and their missions.

In order to participate in the 2025 Weaver Challenge for Charities, it is required that the Director, or equivalent, and Board Chair from each participating organization read, understand, and sign in agreement with the rules and procedures of this event. This document must be returned to the **Murray-Calloway County Community Foundation** (MCCCF) via email at mcccommfoun@gmail.com in order for the organization to be eligible for participation in the event. **Note the deadline of August 15, 2025.**

RULES AND PROCEDURES

Failure to follow any of the Rules and/or Procedures listed below may disqualify an organization from participating in the 2025 Drs. Dick & Jan Weaver Challenge for Charities, affect future participation in the event, and/or result in forfeiture of match dollars.

1. Every participating nonprofit must be a 501(c)(3) organization and submit an Agreement to Participate by close of business day on August 15, 2025, to mcccommfoun@gmail.com. The Weaver Challenge will take place from September 1, 2025, through November 30, 2025. Qualifying contributions may be accepted beginning September 1, 2025.
2. Every participating nonprofit organization **MUST** send at least one representative to the mandatory Kick-Off meeting to be held August 13, 2025 from Noon - 1:00pm, in the CFSB Sycamore Banking Event Center.
3. Nonprofits are encouraged to use the official MCCCCF logo. Contact the Foundation for access to the logo and for usage guidelines.
4. All funds raised in the Challenge may only be used for organizations that serve Calloway County.
5. Organizations are responsible for soliciting donations on their behalf. Participating organizations must raise a minimum of \$1,000 (one thousand dollars) to receive matching funds and be willing to participate in a debriefing survey following the event.
6. A unique aspect of the Challenge is that donors can make contributions on behalf of several organizations with only one check and thus receive a single tax receipt. Only official donor forms will be accepted. An official electronic version of the donor form can be found on our website at www.mcccf.org. Brochures will be distributed to all participating organizations. Donors may select one or several organizations to support and pay with one check or individually online.
7. Eligible contributions include:
 - Special events—all participating nonprofits may use the proceeds of any fundraising events toward the Challenge as long as the Challenge is properly publicized as the recipient of the proceeds. All nonprofits will have 77 days to raise funds (9/1/25–11/30/25). Proceeds from a special event should be submitted directly to the MCCCCF in one check from the nonprofit.
 - Checks—any submitted outside of special events must be made out to the MCCCCF and accompanied by an official donor form
 - Gifts of stock and/or real property—contact the MCCCCF directly
 - Corporate Matching Gift Programs—matching portions must be received by the contribution deadline (9/1/25–11/30/25). Online donations—visit www.mcccf.org (utilize official donor form)
8. Ineligible contributions include:
 - Membership dues
 - Tuition
 - Pledge payments—gifts given to MCCCCF on behalf of an organization cannot be made in fulfillment of a pledge agreement with an organization
 - Gifts made outside of the official giving period (9/1/25–11/30/25)
9. Organizations will receive 100% of the money donated on their behalf. Once all funds are reconciled, the MCCCCF will release those checks by December 23, 2025. All funds to be qualified for the Match must be in the MCCCCF by the close of business on November 30, 2025. In order to receive the matching funds, organizations **MUST** attend the Celebration Event on December 10, 2025, at the CFSB Sycamore Banking Event Center, with at least one Board member present.
10. If an organization currently has no endowment established with the MCCCCF, the matching funds raised will be used to establish one and the organization must agree to contribute additional funds for the next three years or until the \$10,000 minimum requirement for an endowment is secured.
