

## Weddings & Special Events - Private Party Tattoo Artists

Have you ever wanted a private tattoo artist for your special event or party? Check out our information and pricing guide below.

**General Information**: We require a minimum of 3 months' notice for an event. It's recommended that if you're looking to host several Artists that you give as much notice as possible to ensure Artists' schedules can accommodate.

We'll need to connect with the venue to ensure we have permission, please be prepared to get us a contact for your venue.

**Deposit:** Deposits must be paid in full no later than 30 days prior to your event date. Deposits are 50% of the total cost of the quoted event. A hold will be placed on the deposit until the venue is approved by LTC and MDH to ensure the venue meets the temporary event space requirements for licensing.

**Payments:** Deposits are due 30 days prior to the event. Deposits are half of the total quoted event price. The Final payment is due the day before the event.

**Licensing:** LTC works with the Minnesota Department of Health to obtain a temporary event permit. This ensures safety and compliance with MDH's Body Art Regulations. Event spaces and venues will need a final inspection by MDH to approve temporary workspaces. MDH temporary licensing fee can pe paid directly to LTC.

Why is this important?

Not going through MDH licensing can result in artists and shops losing their licenses and paying hefty fines. It also poses a public health risk to you and your guests by risking blood borne cross contamination which can result in disease transmission, infections, and scarification.

**Venue Requirements:** We will need a venue contact to work out punch list items for permit approval and to coordinate MDH final inspection. To obtain a temporary license, artists must be working near easy access to a designated handwashing sink. Sinks must be in close proximity to the workspace and artists must be able to access the sink without walking through doors or having to touch anything. Artists will also need access to outlets/power, additionally the work space must have floors and walls that are washable and non-porous – this means we cannot tattoo over carpeting.

LTC will require a floor plan with general dimensions from the event space to illustrate where the artists will be working and setting up.

MDH and LTC will need access to the space to do initial walk throughs and an inspection prior to the event start time. MDH typically inspects the space an hour prior to "tattoo start time" to ensure compliance.

**Pricing and Options:** Packages (prices include the MDH temporary licensing fee and supplies. Tips and gratuities are <u>not</u> included in the listed prices.)

## **Pre-drawn Custom Flash**

Based on your specifications, artists will draw up custom designs and submit to you for your approval prior to your event. Additional fees may apply for additional requests or last-minute changes. Design size can range from a few inches to 6 inches. Larger pieces will require a full consultation with your artist at their standard rate.
