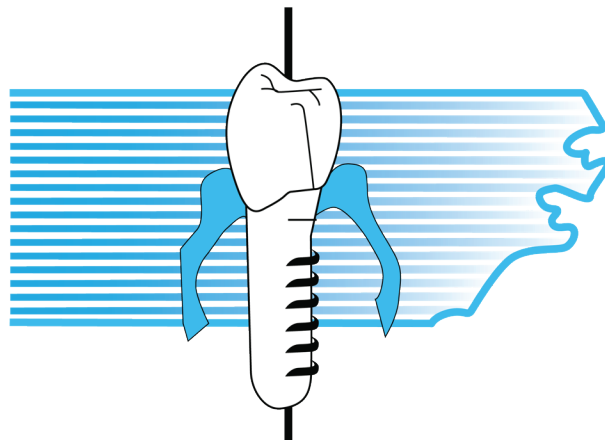

Contemporary Diagnosis and Treatment Planning

Most problems restorative dentists face can be traced back to an incomplete diagnosis. Treatment plans are thusly created based on a lack of information. The resulting complications and failures lead to frustration and a search for clinical predictability. Avoidance of clinical failures centers on a systematic diagnosis of the stomatognathic system—the joints, muscles, posterior occlusion, and the anterior occlusion. Predictability centers on application of this information into 2D and 3D treatment planning, and verification with refined provisional restorations. This course will focus on these commonly overlooked factors and participants will be able to immediately apply them in their clinical practice.

Upon completion of this session, attendees should be able to:

- Confidently diagnose the TMJ's and differential between intracapsular and occluso-muscular issues.
- Outline the 5 requirements of occlusal stability and understand how these make-or-break esthetic treatment.
- Discuss the factors of global, macro, and micro esthetics.
- Interpret the process of determination, verification and communication.

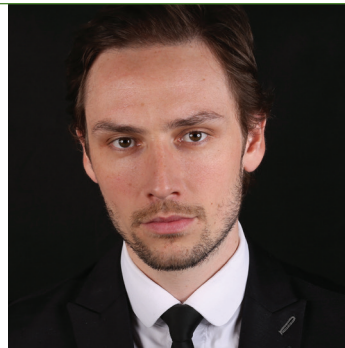

Treatment Planning for Multiple Missing Maxillary Anterior Teeth

When patients are missing multiple teeth in the anterior maxilla, we must be cognizant of the soft tissue loss as well. We have options to restore these missing teeth with natural tooth bridges, implants with bridges, or removable partial dentures. We can graft to develop lost tissue structure, but we can also resect to hide transition lines when indicated.

- Explain the options for missing multiple teeth in the esthetic zone.
- Achieve improvements from hard and soft tissue grafting.
- Understand that resection has a place at the treatment planning table as well.

The wealth of materials currently available and required in restorative dentistry, combined with the rapid introduction of new materials, can be overwhelming. Understanding the basic properties and characteristics of each material, and their proper application, allows us to achieve the optimum potential of each material. Thus, providing the patient with exceptional care. This course will focus on clinical tips and criteria for material selection to complete the pursuit of excellence in mastering restorative dentistry.

- Understand the evolution of adhesive systems, tooth-colored direct restorative materials, and which adhesion strategy can optimize bonding to the tooth structure. Moreover, understand the importance of light-curing and the polymerization process and its role in prolonging restorative care.
- Establish criteria for modern-day ceramics selection and application with emphasis on monolithic zirconia, its different generations, and how the concepts of biomimetics can be applied to selecting the appropriate ceramic restorative material.

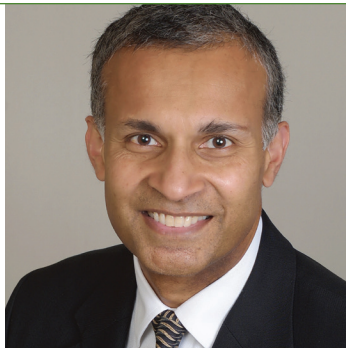

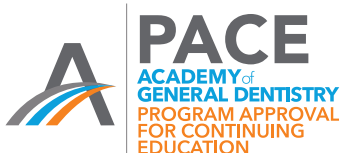
