Award winning project: Divestiture of Roche's largest manufacturing facility to Lonza

Objective

IT transition of Genentech's largest biologics manufacturing facility in Vacaville, California, ensuring a seamless divestiture to Lonza without any production disruptions. The project involved decoupling the IT infrastructure and all business-critical applications from Roche/Genentech's global infrastructure while maintaining compliance and operational integrity.

Project Impact

- The \$1.2 billion divestiture strengthened Lonza's U.S. biologics manufacturing footprint
- Maintained uninterrupted operations at one of the world's largest biologics production sites, with a 330,000-liter bioreactor capacity
- Successfully integrated 750 employees into Lonza's global team

- IT project management for all quality systems, covering 30 global applications and 150 local instruments
- Support the IT separation from Roche/Genentech networks while maintaining regulatory and operational compliance
