Pride and Prejudice

House physical plant loses pledges, creates concern

he recent alumni meeting during the Fall 1984 Theta Chi Homecoming in November created a strong sense of pride and concern in everyone present. The future state of the Alpha Chi chapter physical plant was a topic of concern. For more information read the article in this issue, "Task Force Committee Formed.'

Each of us has had our own unique experience in Theta Chi during our years of study at Syracuse University. However, when we came back to the chapter house over the years, there seemed to be a change in the brotherhood. The only thing that does not change is our tradition of fraternal practice at Theta Chi. Perhaps the change we sense is a function of a changing university student body and tighter academic standards and economics. Associated with the outcome of change comes a demand for the quality of growth. Nothing can be healthier for a fraternity than the desire to improve on past accomplishments.

Alumni Guidance Needed

We have come upon another fork in the road which requires guidance for the Alpha Chi Chapter from its alumni. One road leads to the improvement of the overall function of fraternal practice; the other road leads to stagnation and probable disintegration. In the middle of the crossroads is the current fraternal practice of the chapter house. Such a practice is of good quality with a good balance of upper and lower classmen. But the physical plant of the chapter house, coupled with a changing campus and two newly added fraternities (ATO & SAE), is hindering our competition for membership.


The age of the chapter house provides maintainenance problems, as well.
Although many improvements to the chapter house physical plant were made in the past, it is now obvious that we have not been able to change with the times fast enough. With previous house mortgages coming to a close, it is also more financially possible to prepare for future assurance of a Theta Chi fraternal practice on the Syracuse University campus.

Supporting the improvement of the Alpha Chi physical plant is a statement from Theta Chi Fraternity National President, Brother George Kilavos during a recent conversation with this author: "It is necessary for all chapters of the Theta Chi National Fraternity who hold ownership of their chapter house to coordinate an ongoing alumni chapter evaluation on the following aspects of the chapter house:
(1) The condition of the chapter

physical plant.
The competitiveness of the physical

plant with its environment.

(3) The desired capacity of the physical plant.

Five Year Plan

We have to analyze where the chapter will be in five years. To do this type of analysis, the Alumni Chapter needs to be sensitive to both the present and the future environmental surroundings of the chapter house.

Although we are concerned about improving Theta Chi fraternal practice at the Alpha Chi Chapter, a simple question must be asked; "Why improve the Alpha Chi Chapter?" This question may seem ridiculous but I feel that many of us have not taken the time to seriously ask ourselves this question.

The fraternity serves a tremendous purpose. Organizational, management, and financial skills along with the feeling of self-confidence and group acceptance are just a few of the benefits gained through the Alpha Chi Chapter. When I see a young man enter Theta Chi and leave a changed man, I feel a sense of pride and commitment. Indeed, as an alumnus I am an educator, being a responsible co-owner of the chapter house. However, as an educator, if I see potential students being distracted I need to attract them. Also, I should desire to improve the quality of my

Negatives Distract Pledges

Recently, I made it my business to ask the 1984 fall pledge class (now brothers) what was the most negative aspect they perceived about the Alpha Chi Chapter. Overwhelmingly, their response was the appearance of the physical plant structure. The first thing a potential pledge is attracted to, aside from the party, is the appearance of the fraternity house. The state of New York has raised the legal drinking age to 21. Hence, alcohol at parties will no longer be able to attract potential pledges into fraternities. To provide more insight to our appearance problem, former pledge class Vice President Erik Larsen, '88, who is a freshman finance major, said, "When a friend of mine [a sophomore] and I were looking to join a fraternity we often described factors influencing our decision to pledge a house. My friend went to Sigma Alpha Mu [Sammy] and I decided to pledge Theta Chi. However, my friend was torn between Theta Chi and Sammy. The reason he went to Sammy was because their facility was better than Theta Chi even though Sammy's house is five blocks from the main campus and in a bad section of the city. Dale Desaulniers, former pledge class president and a freshman premed major, stated, "I pledged Theta Chi because I liked the brothers. They were friendly and very hospitable. Also, they were very sincere about Theta Chi. Some other friends of mine also liked the brothers of Theta Chi but weren't impressed with the way the house looked from the street.'

It is the function of a formal membership drive (rush) to present a good impression to the student body. Since the appearance of our chapter house on the campus is not good, this leads to a negative opinion of Theta Chi. As an educator of fraternal practice and a brother of Theta Chi Fraternity, I see a need for swift action concerning the physical plant of the Alpha Chi Chapter with emphasis on its future surroundings and effective competitiveness

To conclude, I hope that the 650 brothers of the Alpha Chi Chapter Alumni Association agree with my concern for the future of our chapter of Theta Chi Fraternity. For not only are we improving a chapter of Theta Chi, but, we are also furthering our own self respect. See you at -Rick MacGulgan

Lastly. Theta Chi promotes many university activities, thereby causing greater enthusiasm in



Renovation or Relocation?

The newly-formed Task Force works on the fate of the House

reetings! During the 1984 Fall Homecoming of the Alpha Chi Chapter of Theta Chi Fraternity an important issue was raised. I say "important" because of its content and the considerable amount of discussion on the issue. The issue, brought to the floor during the alumni meeting, concerned itself with the present and the future state of the Alpha Chi Chapter physical plant. This issue was submitted to the alumni executive officers in documented form by the actives and presented to the alumni for discussion. Additional topics, such as the appearance of the chapter house to the student body and the evolving "physical" environment (i.e., academic buildings) around the chapter house, were also mentioned. Perhaps what was most significant was the source from which this issue emerged, namely the active brothers of the chapter house. But this should not be a surprise to the alumni, for the active brothers are certainly first hand observers of the Syracuse campus today.

The result of discussion on the issue led to the formation of a special Task Force Committee (TFC) by appointment from Alumni Corporation President Brother Mark Ward.

The specific objectives of the TFC are: • To assess all possibilities of renovation or relocation of the Alpha

Chi chapter house.

To assess and estimate the future environment around the Alpha Chi chapter house and the environmental impact on Theta Chi fraternal prac-


• To conclude an optimal assessment of the chapter house and arrange

necessary financial plans.

To present a proposition to the Alpha Chi Alumni Corporation concerning a viable plan for improving the physical plant of the Alpha Chi chap-

ter and its fraternal practice thereof.
The current status of the TFC is a favorable one. As of November 28, 1984, the three major TFC officers were given an organizational baseline to start work. This baseline consisted of:

- Overall & specific TFC objectives.
- Comprehensive objectives for each TFC officer.

- Organizational chart & directory of the TFC.
- Request to hold the first meeting of the TFC before Spring '85 Homecoming.
 • Miscellaneous information.

As a result, the TFC officers have given considerable thought to their TFC function. For instance, Brother Joel Mooney has established documentation on our present location, surrounding environment and other Greek houses on campus. Brother John Carey has been working closely with Brother Joel to help establish fundraising needs. Brother Frank Hunt is active in the legalities of our real estate along with other locations.

he first meeting of the TFC will most likely be held in mid-January. The purpose of such a meeting is to establish a preliminary direction concerning the physical plant of the chapter house. The outcome of this first meeting will be presented to the alumni corporation at the Spring 1985 Homecoming by the TFC chairman. This presentation will cover the following areas:

• Current & future physical environmental surroundings of the chapter house. (Note: This analysis will be comprehensive)

Available alternatives to relocation of the chapter house.

- Possible construction and/or renovation alternatives for the chapter house.
- Pertinent information with respect to university expansion sights for further construction.
- Results from a polled survey analysis of current SU students' perceptions of Greek letter organizations.

As the Chairman of the TFC, I find the fulfillment of the TFC objectives important. I say this because of the eventual long-range effects the TFC's effort will have on the chapter house and its future. The foreseeable buildup of the local physical environment plus legalities associated with wood framed structures, such as our chapter house, pose both a threat to our campus physical plant image and probable serious real estate problems. These are two of the most serious Alpha Chi chapter problems.

The reason for this concern about the future of the Alpha Chi physical plant

centers on three issues:

Task Force/Reports

(1) Campus image of the physical plant. Physical plant maintenance.

(3) Future university construction at College Place on "our side of the street.

The first issue, physical plant maintainence, is straightforward. Basically, the chapter house is old and becoming inefficient on a utility basis, despite small improvements. Many of us know about the slanting staircase, water in the basement, slow sewer system, electrical system and other problems along with the external physical deterioration of the house.


he second issue involves the first impression that the chapter house makes on today's Syracuse University student. Having talked to our recent pledge class (now brothers), I expansion on College Place, if they occur, would make our House look even more outdated and worsen our image on campus.

One of the most important tasks of the TFC is to investigate these intentions of the University. However, it is necessary that each alumnus think about the future environment we could face and whether we should concern ourselves with our chapter house physical plant adapting to newly

built academic buildings.

There are only "4" Greek letter crganizations left on College Place.

Namely these are Psi Upsilon, Phi Kappa Psi, Theta Chi and Alpha Chi Rho. In between each of these houses are university-owned wood framed structures soon to be vacant. Previously occupied offices in these buildings will be moving into newer structures on campus, particularly the new student center to be completed in the fall of 1985. The number

Fresh paint and a well kept lawn will do much, even though the house occupied is ugly. All of these things make for favorable impressions as a person approaches the fraternity house, and first impressions are important.

asked them what they first perceived as a hindrance to pledging Theta Chi's Alpha Chi Chapter. The response was overwhelming and without hesitation-"The chapter house!" They also know of other potential Theta Chi material who were turned off by first impressions of our physical plant and decided not to bother with pledging. An argument against this dilemma might be, "Why didn't the active brothers visit these potentials and talk up the chapter for its internal worth aside from what it looks like?" Well they did do that and have been exercising that followup practice for some time now. But instead of pledging Theta Chi they went to other fraternities (26 in all) or none at all. By improving the appearance of the chapter house we improve both our image to the outside campus community and also the facility for the actives. Remember, we are not only dealing with the students of the 1980's but also the future pledges of the 1990's and 2000.

The third issue addresses future university academic building construction at College Place on our side of the street. Recently, the city of Syracuse has restricted expansion of the University to certain building zones. One of the allowable building zones is the College Place district. The tentative plans for university

of wood framed buildings demolished by Syracuse University has been stunning. The university also has a strong need for parking lots.

o conclude, we (alumni & actives) need to plan for the future. If we do not plan now we will soon face a bigger problem: the overall in-effectiveness of the Alphi Chi Chapter to function on the Syracuse University campus. The Task Force Committee is crucial to planning for the future.

As we look back on our own fraternity days, we realize the learning experiences we gained. We are educators of young men who enter the chapter house and leave prepared for life's challenges. I feel that we owe it to ourselves (as property owners), to the current actives, and to the future of Theta Chi National to insure that the future state of the physical plant will not hinder the ongoing quality of the Alpha Chi Chapter of Theta Chi Fraternity.


