THE DOG(S) TO BE PURCHASED THROUGH THIS CONTRACT IS: _____

THE FULL PRICE OF THE DOG IS TO BE PAID WITHIN **30** DAYS OF SIGNING THIS CONTRACT.

THE MEDICAL GUARANTEE IS FOR ONE (1) YEAR COVERING ALL GENETIC DEFECTS SUCH AS
BUT NOT LIMITED TO HIP OR ELBOW DYSPLASIA, SPINAL DEFICIENCY, GENETIC BLOOD
DISORDER, GENETIC DENTAL ISSUES, ETC. IF A DOG IS RETURNED FOR A MEDICAL DEFECT A
WRITTEN EVALUATION FROM A LICENSED VETERINARIAN MUST BE SUPPLIED TO THE SELLER
PRIOR TO ANY ARRANGEMENTS FOR SHIPPING OR A REPLACEMENT DOG IS SUPPLIED.

THE BUYER HAS FOUR WEEKS TO DETERMINE WORK ABILITY OF THE DOG IS ACCEPTABLE.

THE SELLER WARRANTS THAT THE ABOVE-DESCRIBED DOG IS IN GOOD HEALTH AND FREE OF
COMMUNICABLE DISEASES AT THE TIME THE BUYER ASSUMES OWNERSHIP. BUYER AGREES
TO HAVE A LICENSED VETERINARIAN EXAMINE THE ABOVE-DESCRIBED DOG WITHIN ONE
WEEK OF RECEIVING THE DOG BY THE BUYER. THIS EXAMINATION WILL BE AT THE BUYERS
EXPENSE

IF AS A RESULT OF THE EXAMINATION, THE VETERINARIAN DETERMINES THE DOG IS NOT IN
GOOD HEALTH, THEN THE BUYER SHALL ELECT TO KEEP THE DOG OR RETURN THE DOG TO
THE SELLER. IF THE BUYER ELECTS TO RETURN THE DOG, THE BUYER SHALL SUPPLY A
WRITTEN STATEMENT BY THE EXAMINING VETERINARIAN STATING THE RESULTS OF HIS/HER
EXAMINATION AND THE EXACT PROBLEMS, ILLNESS, OR CONCERNS IN DETAIL. THE SELLER
RESERVES THE RIGHT TO HAVE THE DOG RE-EXAMINED BY A LICENSED VETERINARIAN OF
THEIR CHOICE IN ORDER TO CONFIRM THE DIAGNOSIS.

IF THE DOG IS RETURNED TO THE SELLER ACCORDING TO ALL OF THE ABOVE STATED TERMS
AND CONDITIONS, THE SELLER SHALL BE OBLIGATED TO REPLACE THE DOG(S) WITH ONE OF
SIMILAR AGE, SEX, BREED, AND WORK ABILITY WITHIN A REASONABLE TIME FRAME. IF THE
DOG IS REPLACED BY ANOTHER DOG TO FILL THIS CONTRACT, THE SELLER WILL NEED TO
FOLLOW ALL OF ABOVE CONDITIONS AND TERMS. DOG MUST BE INTACT FOR REPLACEMENT.
