





# TRADITIONAL MARKETING VS NETWORK MARKETING

## TRADITIONAL MARKETING

**20%+ of profit goes into marketing spend such as:**

- celebrities
- billboards
- ads on the tv
- social media ads
- influencers
- campaigns
- videos

## NETWORK MARKETING

**Profit goes back into the consultant (up to 35%)**

**Consultants get paid commissions from downline as products are being sold through the business as a 'thank you'.**

**Products are not marketed if it's not through the consultants = high commissions**

# HOW WE EARN

HOW DOES IT WORK AND HOW ARE YOU PAID?



## 01/ COMMISSION

Client commissions are earnings paid to you on personal product sales to Preferred Clients (35% off suggested retail price, or SRP) and Clients (15% off SRP)

## 02/ BONUS

Bonus at each level available every single month. VP Success Award is available to Vice Presidents based on their team's product sales and volume

## 03/ OVERRIDES

Overrides are commissions paid to you on the product sales volume of your team

## 04/ CAR BONUS & TRIPS

As your sales volume grows you can earn a VP success award and be able to earn brand trips once a year. As a NVP there is a trip to Maui every year in January


