

# THE SECURITY OF THE COMMONWEALTH CRIMINAL CODE ACT 1995 OFFENCES AGAINST LAWS OF THE COMMONWEALTH

**CHAPTER 5** 

Division 80 - Treason.

Subdivision B – Treason

80.1 Treason

- (2) A person commits an offence if the person:
  - (a) receives or assists another person who, to his or her knowledge, has committed an offence against this subdivision (other than this subsection) with the intention of allowing him or her to escape punishment or apprehension;

or

(b) knowing that another person intends to commit an offence against this subdivision (other than this subsection), does not inform a constable of it within a reasonable time or use other reasonable endeavours to prevent the commission of the offence.

Penalty: Imprisonment for life.

### **CRIMES ACT NSW 1900**

#### - **SECT 12**

Compassing etc deposition of the Sovereign--overawing Parliament etc

## 12 Compassing etc deposition of the Sovereign--overawing Parliament etc

Whosoever, within New South Wales or without, compasses, imagines, invents, devises, or intends to deprive or depose Our Most Gracious Lady the Queen, her heirs or successors, from the style, honour, or Royal name of the Imperial Crown of the United Kingdom, or of any other of Her Majesty's dominions and countries, or to levy war against Her Majesty, her heirs or successors, within any part of the United Kingdom, or any other of Her Majesty's dominions, in order, by force or constraint, to compel her or them to change her or their measures or counsels, or in order to put any force or constraint upon, or in order to intimidate or overawe, both Houses or either House of the Parliament of the United Kingdom, or the Parliament of New South Wales, or to move or stir any foreigner or stranger with force to invade the United Kingdom, or any other of Her Majesty's dominions, or countries under the obeisance of Her Majesty, her heirs or successors, and expresses, utters, or declares such compassings, imaginations, inventions, devices, or intentions, or any of them, by publishing any printing or writing, or by open and advised speaking, or by any overt act or deed, shall be liable to imprisonment for 25 years.

#### **CRIMES ACT 1900 - SECT 348**

Punishment of accessories after the fact to certain treason-related offences

## 348 Punishment of <u>accessories</u> after the fact to certain treason-related offences

Every <u>accessory</u> after the fact to an offence under <u>Section 12</u> shall be liable to imprisonment for two years.

## CRIMES ACT 1958 VICTORIA SECT 9A

#### **Treason**

- (1) A person who—
  - (c) levies war, or does any act preparatory to levying war, against the Commonwealth of Australia:
  - (d) assists by any means whatever, with intent to assist, an enemy at war with the Commonwealth of Australia, whether or not the existence of a state of war has been declared;
  - (e) instigates a foreigner to make an armed invasion of the Commonwealth or any Territory not forming part of the Commonwealth; or
  - (f) forms an intention to do any act referred to in a preceding paragraph of this subSection and manifests that intention by an overt act—

shall be guilty of an indictable offence, called treason, and liable to—

- (g) level 1 imprisonment (life); or
- (2) A person who—
  - (a) <u>receives</u> or assists another person who is to his knowledge guilty of treason in order to enable him to escape punishment; or
  - (b) knowing that a person intends to commit treason, does not give information thereof with all reasonable despatch to a constable or use other reasonable endeavours to prevent the commission of the offence—

shall be guilty of an indictable offence.

Penalty: Level 3 imprisonment (20 years maximum).

(3) On the trial of a person charged with treason on the ground that he formed an intention to do an act referred to in paragraph (a), (b), (c), (d) or (e) of subSection (1) of this Section and manifested that intention by an overt act, evidence of the overt act shall not be admitted unless the overt act was alleged in the indictment.
