## County Clerk - Adams County

---

County clerks are public servants governed by the Wisconsin State Statutes 59.23. There are 72 county clerks in the State of Wisconsin. The County clerk is the filing officer for the Board of Supervisors and Constitutional Officer, designated under Article VI of the Constitution of the State of Wisconsin, providing declaration of candidacy, campaign finance and ballot access forms such as nomination papers and campaign finance registration, as well as administering oaths of office.

The services provided by each of the 72-county clerk's office are varied. In Adams County, we provide the Board of Supervisors support and we record the board proceedings, providing the final to the Adams County historical society. We prepare the agendas, minutes and publish legal notices. Record resolutions adopted and all ordinance enacted by the board.

- I am the Chief election officer. Election duties include:
  - Ballot programming, preparation and distribution
  - Return of votes
  - Canvass election returns
  - Records retention
- Marriage licenses. Administer SVRO and report.
- Dogs; Perform the responsibility relating.
- Apportionment of taxes.
- Timber harvest notices.
- Property; to the extent authorized.
- Account Contracts and leases for Adams County.
- Prepare and distribute the Adams County Official directory.
- Any duties as required per Wisconsin State Statute.

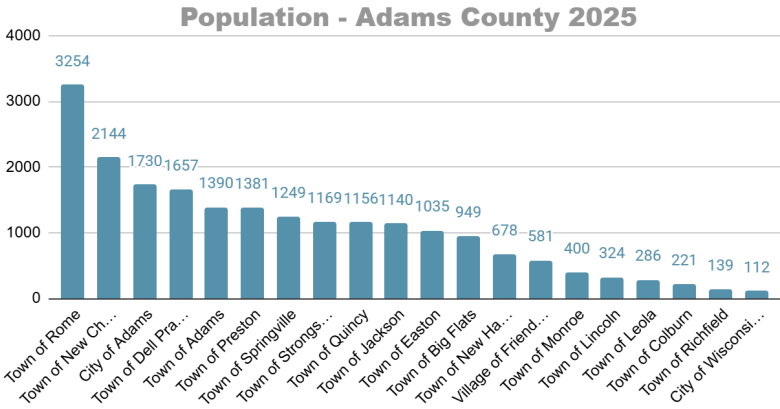

The County's voting age population is the summation of the voting age population for all communities within the county. This approximation is a courtesy estimate which helps you comply with Wisconsin Statute 5.66, which requires municipal clerks to approximate the number of electors prior to elections. The voting age population was calculated by applying the census proportion of persons over 18 to the preliminary January 1 estimate, and then multiplying the result by a state-wide factor to account for the general aging of the population.

### Who is Eligible to Vote in Wisconsin?

You must be 18 years of age to vote. All voters in Wisconsin must be at least 18 years of age on the day of the election to be eligible to vote. Persons who are otherwise eligible to vote may register to vote at 17 years of age if they will be 18 by the next election.

You must be a U.S. citizen in order to vote. Citizenship is documented through a U.S. birth certificate or a Certificate of Naturalization, but proof of citizenship is not required to vote. Green card or visa status does not qualify a person to vote in Wisconsin elections.

You must reside at your current address for at least 28 days prior to the election. (You may register to vote as long as you will meet the 28-day requirement by the day of the election.)

If you have moved to a new address within Wisconsin within 28 days of an election, you may be qualified to vote from your former address until you meet the 28-day requirement at your new address.

If you have moved to Wisconsin from another state less than 28 days before an election, you are only eligible to vote for President and Vice-President in Wisconsin until you achieve the 28 days.

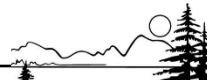
