

Valley Fliers January Board Meeting

Meeting Called to Order at: 6:30

Present: Morrow, Wildstone, DeWitt, Meyer, Smith, Vader, and 7 members.

Approval of December Meeting Minutes

Alan moved to accept as corrected. Geoff seconded. The motion passed unanimously.

Treasurer's Report

Alan provided both November and December financial reports. He reminded us that all monthly reports are preliminary and only the annual financials are not preliminary. November was ahead of last year and was a reasonably good month. On the balance sheet for November we showed pretty good recovery. We were also ahead in terms of cash flow. The upcoming work will eat into the finances. A share turned over each of the last two months.

In December we were back 65 members. For the year we had 10 shares turnover which is the norm. The \$13k maintenance is an estimate for 117's annual. This December showed more activity than the year prior. 117 had two annuals in 2025 because we did annuals on it in January and December. Alan suspects that 9MA's data subscription cost was put into another category. 63S depreciation will increase next year as we depreciate the new engine. Sean asked when the engine for 63S will arrive? Nick says it should be ready to ship the end of this month. He noted the avionics work will be done first and the engine probes will likely be tied up at the firewall until the new engine gets put in.

Maintenance Officer's Report

Nick ran through an update on each plane.

117 is mostly squawk free. The EGT probe had to be replaced. The carb heat had been lubed and seems ok.

727 The seat rail AD is done. The passenger side door handle broke and has been replaced with an upgraded replacement. Nick suggests the other door should probably be preemptively replaced. Nick called out Doug Stoltz as exceptionally helpful in dealing with the handle. Commenter from the floor asked if he is the only one who experiences GPS failures during radio communications? Another commenter asked if it was raining? First commenter said it was. Nick asked if the defroster was on at that time? Answer was yes. Nick says the vent for that is partially torn and might be related as it might be due to temperature issues. 727 will go into annual and overlap with 63S being out of service. The belly pan oil cause will be checked during annual. Nick asked if the nose wheel issue has recurred? Commenters said it had not.

63S It will be grounded at the beginning of February. It will get the prop overhauled, the copilot seat belt webbing will be replaced, and we will get the engine put in. The avionics will be done by Spencer's. We are going with dual G5s. We will also get full engine monitoring and dual usb chargers. The radios won't change. Most of the engine instruments will be pulled out of the panel, but the tach will stay. The vacuum system will be removed. The rate-of-turn indicator should be fixed. Kelsey wanted to discuss the selection of G5s. Since the decision was made based on the dollar value approved, she is less likely to approve expenses in the same way. She noted the boards discussion via text was not recorded. There was some discussion of what the board needs to record. Kelsey really prefers live discussion of board decisions. The strut had to be reinflated and will need to be rebuild. Nick replaced the seal around the openable window.

9MA Still in annual.

The google sheet for maintenance somehow broke and Nick was having challenges with keeping up with ADs. The sheet seems to be working now. Kelsey asked if Nick had suggestions for new software. Kelsey noted that Jonathan suggested a product but it looked a little expensive. Kelsey suggested new software might make Alan's job easier. Alan expressed some doubts it will be helpful, particularly if we don't update quickbooks, which will be expensive. Alan noted the real effort are due to discrepancies when people don't put in information they should. Alan says he likes the idea of eliminating the books we keep in each plane. Alan believes he may be able to update quickbooks desktop and enable some features. Kelsey noted quickbooks has a nonprofit rate for quickbooks online.

Safety Officer's Report

Geoff had nothing for the month. Andy noted we shouldn't leave a key in the plane. A plane was recently stolen from the airport. Geoff mentioned that the simulator update for the garmin 430 emulator can no longer be updated because the company that wrote it has gone out of business. Kelsey asked if the 430 emulator could just be replaced? Geoff suggested the emulator is likely part of the certificated part of the simulator.

Old Business

Simulator Geoff suggested we put together a committee to come up with options for simulator. Kelsey offered to talk to the simulator vendor. Nick asked if Geoff would be willing to head the committee. Several members agreed to help with the committee. Sean said he is in favor of having a reserve fund for the simulator, but not charging for it. Kelsey felt it was appropriate to charge for the simulator. Alan suggested the committee should look at whether or not it should be charged for. Alan won't have a good idea how the club's finances are until after most of the annual bills come in, say around April. Kelsey asked if we are going to run the club's accounts dry? Alan said we are going to be lower than he is comfortable. We are going to dip into our engine reserves. Alan noted we may need to adjust monthly dues. Alan would be comfortable tracking and charging its use in the same way that we do for our planes.
