

Valley Fliers June Board Meeting

Meeting Called to Order at: 6:30

Present: Morrow, Hewitt, Smith, Vader plus 6 members.

Approval of May Minutes

Geoff moved to accept as written. Chris seconded. The motion passed unanimously.

Maintenance Officer's Report

117 In May the flap bearings got replaced so the flaps now actuate smoothly. Members need to pay attention during preflight. Someone overflew a couple of ADs last month by six hours. Early notification to Chris would help us keep up with them. **9MA** Both strobes have died. Chris will upgrade both to new LED lights. **63S** Gabi thinks the turn coordinator is broken. Question from the floor: Could we put in G5s? Answer: Chris had been looking for them, but hasn't found a good set. Sean suggests the old avionics in 63S may be discouraging members from flying the plane. 63S is down for mags. **727** should have had its mags back last week, but Gabi needed to get some help with the reinstallation. Question from the floor: when ADs are overflown we have someone flying past an AD. Should we punish members (particularly CFIs) who overfly them? Answer: Chris says our time tracking software doesn't help us. He thinks we should move to a new system. Geoff suggested Rainier uses Needle Nine. Chris will research alternatives. Sean asked if it would require any changes to the aircraft. Chris says no. It would also replace ScheduleMaster for scheduling. Sean suggested rather than starting with punishment we should start discussing those issues with the people who overfly the ADs, then escalate to punishment if necessary. Sean suggests we start by calling out people. Chris notes the sheets in the books are not always up-to-date, but the spreadsheet on the club computer is always up-to-date. Comment from the floor: does anyone else hate 117's tow bar? A replacement has been ordered.

Question from the floor: what was wrong with the 182 avionics? Chris says there were two issues: some of the connectors in the rear were torn up, and the other was chafing on the avionics wiring.

Treasurer's Report

Alan was absent, but the financial reports for May were distributed. Alan is still waiting on the bill for 727's annual. The insurance will be paid for Q3 in June. Minimum flying hours looked low to Sean. Gross profit is up vs. last year. Alan's notes say the reserves are looking decent. Sean suggests questions be sent to Alan directly.

Safety Officer's Report

Geoff noted we had a bird strike on takeoff in 117. No damage to the aircraft as the bird went through the propeller. If or when that happens, please call airport operations so they can try to collect the bird's remains and species data. Airport operations inspected the remains from our bird strike. The FAA has a bird-strike reporting form to use if you have a bird strike when in flight. Chris notes the FAA uses bird flight path information as part of their planning processes. Geoff notes statistically bird strikes occur 500 AGL and below, but they can happen much higher particularly with raptors. Chris reminded members to look out for airshow TFRs. TFRs for fires are opening up too. It is also airport construction season, so he suggested members carefully check NOTAMs.

Sean noted we are seeing less member turnover.

We are now renewing with AvemCo.

Kelsey will preside next month as Sean will not be around. Chris will not be available next month either.
